- I. On behalf of President of India, the Registrar, Rajiv Gandhi University, Rono Hills, Doimukh Arunachal Pradesh invites as sealed Item Rate Tender in CPWD Form 8 in two bid system from all registered contractors in required classes as mentioned bellow in CPWD / Department of Telecommunication, M.E.S. / NHPC / NEEPCO / Railway / APPWD / NBCC etc for as detailed in the table below. Domiciled within territorial jurisdiction of Doimukh and the district as the case may be applicable as per Arunachal Pradesh district base entrepreneurs and professionals and incentives. (Development & Promotional) act 2020, published vide notification No. SPWD / W-66/2012 Dated 13-8-2015 & published in Arunachal Pradesh extra Gazette No. 224Vd- XXII Dated 11-9-2015 for the works:-

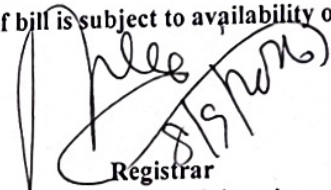

- The allowable bidding amount shall be less or within the estimated amount beyond which the bidding shall not be considered as eligible bidder and abnormally low bidder shall also summarily reject.
- Tender cost of documents be submitted in form of Demand Draft in favour of Executive Engineer. The cost of Tender Document is non-refundable. The Tender Paper may be collected from the office of the Executive Engineer, Rajiv Gandhi University, Rono Hills, Doimukh.
- The intending bidder must read the term and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Bid must be accompanied by earnest money of the amount specified for the work in the table above, in the form of Demand Draft of any Schedule Nationalized Bank issued in favour of Registrar, Rajiv Gandhi University, Rono Hills, Doimukh. Since the earnest money is part of performance guarantee and Security deposit. It shall be released after the completion of observation/maintenance period.
- The earnest money of above mentioned works in the form of DD must be deposited along with Technical Bid document
- The observation or maintenance period shall be of one year from the date of actual completion of works.
- Bids under two separate PARTS superscribed as 'PART-I TECHNICAL BID' and 'PART-II FINANCIAL BID' must be submitted on or before 1330 Hrs on 15.9.2026. The bids will be opened as according to date and time given in table above. in the chamber of Registrar in presence of intending Tenderer and shall be evaluated by screening committee whose decision shall be final. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
- Contractors who fulfil the following initial requirements shall only be eligible to apply.
 - Should have completed three similar (building) works each of value 40% of Tendered Value or

Two similar works each of Value 60% of Tendered Value or one similar work of value 80% of Tendered Value during last five years.

NB: *The Documents should be authenticated by completion Certificate and Performance Certificate*

- b) Should have an average annual financial turnover of 50% of Tendered Value in construction works during last five years up to 2021-25.
 - c) The bidders shall produce Solvency & Bank Certificate from recognize bank, NOC, Experience Certificate, Details of T & P with authentication, PAN Card. The intending contractor/Firms must have the GST registration certificates and its clearance certificate upto the previous month of GST deposit period.
 - d) The Machineries to be leased, Hired or purchased will not be considered for qualification. The Details without ownership certificate shall be rejected.
10. The competent authority on behalf of President of India reserves the right to accept or reject, any Bid, and to cancel the Bidding process and reject all bids, at time prior to the award of contract, thereby without incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds.
11. The competent authority wants to clarify that the payment of bill is subject to availability of fund.
