The 21<sup>st</sup> meeting of the Executive Council of Rajiv Gandhi University was held on 17<sup>th</sup> September 2018 at 11 a.m in Vice-Chancellor's chamber.

At the outset, the Vice-Chancellor welcomed all the members to the first meeting of the 4<sup>th</sup> Executive Council. The following agenda items were taken up for discussion and following decisions were taken:

## EC 21:01: To confirm the Minutes of the 20<sup>th</sup> Executive Council meeting held on 25<sup>th</sup> April, 2018.

The EC noted that the minutes of the 20<sup>th</sup> Executive Council meeting held on 25<sup>th</sup> April, 2018 were circulated amongst the members and no comments were received from any of the members so far.

The minutes of the 20<sup>th</sup> meeting of the Executive Council were circulated amongst the members and no comments were received. Hence, the Council confirmed the minutes.



EC 21:02: To consider the Action Taken Report (ATR) on the decision of the 20<sup>th</sup> Executive Council meeting held on 25<sup>th</sup> April., 2018.

The EC noted that in pursuance of the decisions taken in 20<sup>th</sup> Executive Council meeting, the University Authority has implemented and executed the decisions of the Council, wherever applicable.

The Council accepted the Action Taken Report on the decisions of the 20<sup>th</sup> Executive Council meeting held on 25<sup>th</sup> April 2018. A few clarifications were sought by some EC members, which were replied by the Chairman satisfactorily.

EC 21:03: To ratify the decisions taken by the University Authority on the following issues as under:

a. The EC noted that Prof. Bipan Hazarika, Professor, Dept. of Mathematics of this University has been granted EOL for another period of 1(one) year w.e.f. 4<sup>th</sup> August, 2018 (F/N) to enable him to continue as Associate Professor, Department of Mathematics, Gauhati University, Assam.

The Executive Council ratified the action taken by the University Authority.

b. The EC noted that Dr. Utpal Jyoti Das, Assistant Professor, Dept. of Mathematics of this University has been granted EOL for another period of 1 (one) year w.e.f 4<sup>th</sup> August, 2018 (F/N) to enable him to continue as Assistant Professor, Department of Mathematics, Gauhati University, Assam.

The Executive Council ratified the action taken by the University Authority.

c. The EC noted that Dr. Sunil Kumar Singh, Assistant Professor, Dept. of Mathematics of this University has been granted EOL for another period of 1 (one) year w.e.f 27<sup>th</sup> July, 2018 (F/N) to enable him to join as Associate Professor in the department of Mathematics at Mahatma Gandhi Central University, Bihar.

The Executive Council ratified the action taken by the University Authority. However, EC members expressed concern that granting EOL to three faculties from single department may hamper the regular classes of the Department. In such cases, guest faculty should be appointed during their EOL period.

d. The EC noted that Mr. Tade Sangdo, Dept. of History of this University has been granted 604 (six hundred four) days revised Study leave w.e.f. 01.09.2016 to 27.04.2018 for his Ph. D work under this University. However, the EC Members opined that a progress report may be submitted by the concerned teacher after returning from study leave.

The Executive Council ratified the action taken by the University Authority.



e. The EC noted that Prof. Ranjit Tamuli, Dept. of Management of this University has been granted lien for a period of 3 (three) years w.e.f 17.07.18 (A/N) to 16.07.2021(A/N) to enable him to join as Vice- Chancellor, Dibrugarh University, Dibrugarh, Assam.

The Executive Council ratified the action taken by the University Authority. The Council Members opined that Vice-Chancellor post is a term post for a period of five years and as such, the University may explore possibility to grant five years lien to him provided the rule permits.

f. The EC noted that the Technical resignation of Dr. Amit Tripathi, Assistant Professor, Dept. of Zoology has been accepted by this University to enable him to continue in the post of Assistant Professor, Dept. of Zoology at University of Lucknow, Uttar Pradesh.

The Executive Council ratified the action taken by the University Authority.

g. The EC noted that The Service of Prof. A. K. Das (Re-employed), Dept. of Botany has been extended for another period of 1 (one) year (2<sup>nd</sup> term) w.e.f. 03.07.2018 under re-employment scheme (after superannuation).

The Executive Council ratified the action taken by the University Authority.

h. The EC noted that Administrative approval is accorded on the decision of the UGC, New Delhi, vide N.No.67-3/2017(CU), dated 12<sup>th</sup> June, 2018 and Govt. of India, Ministry of Home Affairs (Foreigners Division), New Delhi, videF. No. 26011/52/2016 OCI, dated 11<sup>th</sup> December, 2018 that a person registered as an Overseas Citizen of India (OCI) cardholder under section 7A shall be eligible for appointment as teaching faculty in the Central Higher Education Institutions.

The Executive Council ratified the action taken by the University Authority.

i. The EC noted that Administrative approval is accorded on the public notice issued by UGC (MHRD), New Delhi, vide No.F.27-9(Orissa)2010(L)/PS, dated 4<sup>th</sup> July, 2018, "decided that Political Science & Public Administration subjects are inter-changeable for the purpose of appointment of Assistant Professor. It has been decided that both the subject are inter-dependent yet discerningly distinct in nature and hence, the candidates with Masters degree/NET either in Political Science or Public Administration may be considered for faculty position in Political Science as well as Public Administration depending upon the requirement of expertise in the concerned Higher Education Institution (HEI) which may be decided by the concerned HEI".

The Executive Council ratified the action taken by the University Authority.

j. The EC noted that Administrative approval is accorded to implement the new UGC Regulation notification issued by UGC, New Delhi on 18<sup>th</sup> July, 2018. Further, competent authority of the University has approved the same with effect from the date of notification issued by UGC i.e. 18<sup>th</sup> July, 2018. However, incentive for Ph. D/M. Phil, etc. as in 19.1 in new regulation is expected to continue as usual.

The Executive Council ratified the action taken by the University Authority. However, the regulation will be applicable to those teachers for promotion whose assessment period will fall after 18<sup>th</sup> July 2018.

EC 21:04: Appointment of Chancellor of Rajiv Gandhi university.

The EC noted that as per the letter of MHRD NO. F.35-3/2018 (CU-I dated 8.8.2018, the term of Air Marshal (Retd.) Pranab Kumar Barbora as the Chancellor of Rajiv Gandhi University has expired on 4<sup>th</sup> Aug 2018 (Annexure-D). Subsequently, the MHRD requested to provide a panel of not less than three persons, as per the provisions of RGU Act for appointment of Chancellor of Rajiv Gandhi University so that it can be placed to Hon'ble Visitor for consideration.

The Council deliberated on the issue. The EC expressed gratitude for the services rendered by Air Marshal (Retd.) Pranab Kumar Barbora to Rajiv Gandhi University as the Chancellor and authorized the Vice-Chancellor to write a letter to him. For the appointment of new Chancellor, the Council deliberated and arrived at consensus and approved the panel of five persons for onward submission to MHRD.

EC 21:05: To ratify Ph.D degree awarded to 15 research scholars on having qualified for the award of Ph.D in the respective discipline during the period 30/04/2018 to 12/09/2018.

#### EC:21:06: Any other item with permission of the chair.

Under the item, the following points were discussed and resolved:

#### a) XVI University Convocation

As usual, the XVI University Convocation is expected to be held on 30 November 2018 after receiving feedback from Examination and Academic Branch regarding their preparedness.

#### b) To approve Annual Report 2017-18.

The Annual Report for the academic year 2017-18 was placed to the EC and approved the same. It was also decided that soft copy of the same shall be circulated to all the EC Members.

#### c) Regarding pay anomalies of Ms. Reena Nabam, Staff Nurse working at RGU Health Centre

The EC perused the proposal and it was decided to dispose off the case administratively as per the directives of the MHRD, Department of Higher Education, Govt. of India.



#### d) Proposal to establish a Constituent College of Rajiv Gandhi University

Prof. N. Kar, Dean, Faculty of Environmental Sciences submitted a proposal for establishing of a Constituent College under the University.

The EC discussed the matter and in this regard it was decided to submit a detailed proposal along with financial implications, feasibility, etc and decided to constitute a committee for the purpose.

As there was no other item for discussion the meeting came to an end with Vote of Thanks from Registrar, Ex-Officio-Secretary of the 4<sup>th</sup> Executive Council.
