Pursuant to the decision taken in the 31<sup>st</sup> Meeting of the Academic Council held on 16<sup>th</sup> March, 2021 under item No. AC: 32:04, Temporary Affiliation is hereby granted to Arunachal State Nursing College, Naharlagun, Arunachal Pradesh for a period of one year covering academic Session 2020-2021.

This is issued with the approval of the Vice- Chancellor.


