### Terms and conditions


1. The interested firms/agency should submit application to the Registrar, Rajiv Gandhi University, Rono Hills, Doimukh, Arunachal Pradesh, PIN -791112. Envelope should bear the inscription of E.O.I for constructions and supply of acoustic materials.
2. The agency/firm should quote the rates of materials and construction charges with details specification.
3. The firms/agency shall quoted rate that should inclusive of all charges/Taxes (i.e packaging, forwarding, freight, installation and all other incidental charges. The rate should be valid for the current financial year.
4. The supplier has to provide a minimum of 1 year compressive free warranty for equipments.
5. Performance security 10 % of the total bill amount is to be kept by the University for a period of 1 year to cover the warranty obligations.
6. Only the registered firms under GST are eligible. The Income Tax and other Taxes as applicable shall be deducted from the bill as per instruction of the Government (Income Tax 2%). The photo copy of GST and PAN card is mandatory. No advance payment will be made.
7. The University reserves the right to accept or reject any or all without assigning any reasons.
