

BILL NO. 4

THE ARUNACHAL UNIVERSITY
(ALTERATION OF NAME) BILL, 2005
(As introduced in the Assembly on 24th March, 2005)

A
BILL

to alter the name of the Arunachal University.

Enacted by the Legislative Assembly of Arunachal Pradesh in the Fifty-Sixth Year of the Republic of India as follows:-

- (1) This Act may be called the Arunachal University (Alteration of Name) Act, 2005.
- (2) It shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.

In this Act, unless the context otherwise requires, -
"appointed day" means the date appointed under sub-section (2) of Section 1 for the coming into force of this Act;

As from the appointed day, "the Arunachal University" shall be known as "the Rajiv Gandhi University".

In the Arunachal University Act, 1984 (herein referred to as the Principal Act) the words "the Arunachal University" wherever they occur, the words "the Rajiv Gandhi University" shall be substituted.
