
However, they are ask to perform their duties from home, as may be assigned to them by the Head of the Department/Branch Officers accordingly.

CONTAINMENT ORDER

Consequent upon recommendation of the District Medical Officer, Itanagar Capital Complex vide letter No.DHS/ICC/COVID-19/PP-DOC/08-2020-21, dated 6th May, 2021 regarding declaration of the various sectors/ areas as Micro Containment Zones as clustering of COVID-19 positive cases have been detected in these areas.

Therefore, the following areas/sectors are hereby contained and the inmates put under home quarantine for a period of 14 (Fourteen) days with immediate effect -

The following SOPs shall be strictly complied with-

- 1) The DMO shall immediately collect samples of the primary and secondary contacts for COVID-19 tests after shifting all positive cases to the CCC.
- 2) No unauthorized persons shall be allowed to enter or exit from the above areas without prior approval from the undersigned or DMO/DSO, ICR.
- 3) The movement of people for supply of essential items and other emergency services shall be regulated and police/ security guard shall be deployed by the SP, ICR to regulate the movement.
- 4) The DMO, ICR shall deploy staff to oversee the immediate medical need of the inmates the above areas as may be required and also for thermal scanning etc.

- 5) The essential items required by the inmates shall be provided by coordinating with shopkeepers/ Home delivery firms by concerned Administrative Officers (EACs/COs) in coordination with the police and health workers.
- 6) The DMO/DSO shall carryout antigen/ RT-PCR/ Truenat testing of all the inmates as per SOP and instruct the period of quarantine etc and other follow up action to be taken.
- 7) The Sanitization of the colony shall be carried out by the IMC as shall be informed by the DMO/DSO.
- 8) No gathering will be allowed in the above areas.

This order shall remain in force with immediate effect till further order.

The violator shall be prosecuted under section 81 (b) of Disaster Management Act, 2005 and under section 188 of IPC.

The DMO, Capital Complex, Superintendent of Police, Capital Complex and Administrative Officers of Capital Complex are enjoined upon enforce this order.
