OFFICE ORDER

In pursuance to Govt. Order Nos. SEOC/DRR&DM/01/2011-12 dated 19th June, 2021 issued by the Arunachal Pradesh Disaster Management Authority, Civil Secretariat, Itanagar and De-Notification Order No. DC/PP/CVD 19/01/2020/PC dated 20th June, 2021 issued by the DC-cum-Chairman (DDMA), Papum Pare District, Yupia, the Rajiv Gandhi University shall implement the following measures / guidelines / instructions **with immediate effect:**

1. F Sector of RGU Campus including Bus Stand area and the area near by New Playground is now free from containment zone with immediate effect. The Barricade shall be lifted and the movement of people and vehicular movement are now free in that area. However, those who have been detected Covid-19 positive in the RAT on 12.06.2021, they must continue to remain 'Home Isolation' for one week.
2. University Offices, Departments, Institutes, etc. shall function till 05:00 p.m. on all working days with COVID-19 appropriate behaviour.
3. By considering the movement restriction as imposed by the Government of Arunachal Pradesh, the employees residing outside the campus shall attend the office till 04:30 p.m. on all working days.
4. All academic activities including examinations shall continue on online/blended mode as the offline academic activities are still suspended till further orders.
5. The University Buses shall ply with 50% of seating capacity with COVID-19 appropriate behaviour. The University Buses shall leave the campus at 4:30 p.m. considering the movement restrictions as imposed.
6. All shops including canteen/cafeteria in the university campus shall remain open on all days till 05:00 p.m. with strict observance of COVID-19 appropriate behaviour including wearing of face mask and maintaining of social distancing till further orders.
7. Movement of vehicle / individual(s) except exempted / essential services / medical cases across the main gate is restricted w.e.f. 06:00 P.M. to 5:00 A.M.



8. All Office goers (employees) and general public shall invariably adhere to the Covid-19 appropriate behaviour – wearing mask, maintaining social distance, and using sanitizer/washing hands regularly.
9. All eligible denizens are required to take vaccine as early as possible.


The above advisories / guidelines are subject to change/modify on receipt of the new Guidelines / SOPs from the Competent Authority.
