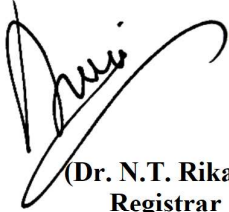

No.Estt./Teach-142/Advt./2016 (Vol-II), dated 20th July, 2019 and UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2018.
