HOW TO APPLY

1. Only online application through <https://pmayassam.in> will be accepted. Scanned documents to be uploaded with online application.
2. A candidate can select any 3 (three) districts as preferred place of posting at the time of filling up the application. No change in district will be allowed afterwards.
3. Upon selection the Candidate will be posted in any one the Urban Local Bodies of the preferred districts.
4. However, it may not be possible to post selected candidate in preferred district and in that case State Mission Directorate reserves the right to post the candidate anywhere else in Assam based on Vacancy position.
5. The link for Online Application will be active from **10:00 am of 18th September, 2021** and will remain active till **06:00 pm of 25th September, 2021**. No communication in respect of submission of Online Application will be entertained once the submission date is over. **Mode of Application is Online only.**
6. Candidates willing to apply for more than one post shall have to submit separate application for each post.
7. Valid email id and phone number should be given during filling up the application as all communications will be made through email mode only.
8. The crucial date of determining the age shall be closing date for receipt of application.
9. The short-listed candidates have to appear for a selection process for which no TA/DA shall be paid.
10. Persons employed in Govt. / Semi Govt. Organizations / Autonomous Bodies must submit NOC from their present employers.
11. The engagement will be on contractual basis for a period of One Year only. Based on performance and requirement of the PMAY-U, contract may further be extended.
12. Incomplete applications shall be rejected and only shortlisted candidates will be called for written test and/or interview. The list of shortlisted candidates shall be published in website.
13. Applications submitted other than the online mode will not be considered and shall be summarily rejected.
14. Degrees as referred above are those which have been awarded by a recognized University / Institution.
15. Candidates should bring the copy of application form and attached photograph and signature along with original documents/ certificates at the time of selection procedure for verification, failing which they shall not be allowed to appear. Candidates are also required to bring PAN Card or any valid ID and/or address proof at the time of selection test(s).
16. The Mission also reserves the right of rejecting any or all the applications without assigning any reasons thereof. Decision of the Mission will be final and binding in this regards.

Terms of Reference (ToR) for State Level Technical Cell (SLTC)

1. State Project Officer-Municipal Finance Expert

Qualification & Experience

- i. Post Graduate or Graduate in finance or CA from recognized university with 5-7 years of experience in municipal finance.
- ii. Experience in evaluating urban infrastructure investments, and helping city governments to use a range of options for financing projects.
- iii. Experience to advice and train staff in municipal finance, project finance and resource mobilization, public private partnerships etc.
- iv. Ability to work in a team and train staff to use the systems.
- v. Vast knowledge of Local Languages. (Assamese/Bengali/Bodo).

Roles and Responsibilities

- i. Conduct an affordability analysis and gather information to prepare a sample financial model for the project for ULBs.
- ii. Support ULBs to identify finance options available for financing urban infrastructure and leveraging funds from various sources.
- iii. Provide technical guidance to State to prepare policy guidance and notes on municipal finance.
- iv. Provide assistance to the City Project Managers /Specialists as and when required.
- v. Any other related tasks that may be entrusted upon by State/SLNA.

Terms of Reference (ToR) for City Level Technical Cell (CLTC)

ii. City Project Manager (Municipal Civil Engineer) / City Project Manager (MIS)/ City Project Manager (Municipal Finance Expert) / City Project Manager (Social Development Specialist)

Qualifications & Experience

- i. Post Graduate/ Graduate degree in Engineering (Civil) / Post Graduate/ Graduate degree in Computer Science, Computer Application, Information Technology/ Post Graduate/ Graduate degree in Commerce, Finance, BBA / Post Graduate/ Graduate degree in Social Sciences or Mass Communications.
- ii. At least 3 years of experience in Mission Mode Program or equivalent.
- iii. Experience in DBT mission will be added advantage.
- iv. Experience in evaluating urban infrastructure investments, and helping city governments to use a range of options for financing projects.
- v. Expertise in preparation of DPR, Financial Tenability & Viability Analysis of Projects.
- vi. Ability to assist ULBs to set standards and procedures for ensuring quality and monitoring compliances.
- vii. Excellent shorthand/computer typewriting speed both Assamese & English.
- viii. Prior experience in related field will be an added advantage.
- ix. Familiar with the rules and procedures of the Urban Local Government.
- x. Fluency in local language is essential.

- ii. Handholding support to the ULBs in identifying slum pockets and other lands for housing development.
- iii. As part of the slum mapping exercise, assist the ULB in identifying ownership of the land occupied by slums and mapping of the same.
- iv. Handholding support to the ULBs in tenability analysis and choosing options for untenable slums.
- v. Performing Geo-Tagging, Geo-Moderation at Field Level.
- vi. Assist the ULBs in selection of appropriate model for the in-situ slum redevelopment.
- vii. Support ULBs in the preparation of City Action Plan.
- viii. Provide handholding support to the cities in assessing the gaps of infrastructure development in the city.
- ix. Review the City Plan of Actions and DPRs for precision and detail and provide feedback as necessary.
- x. Support ULB to report with precision on progress of construction and utilization of funds under HFA.
- xi. Making Payment towards vendors using PFMS & Online module.
- xii. Beneficiary Management & tracking Individual Beneficiary Transaction Details using Central MIS System.
- xiii. Organizing Beneficiary Meet & resolve any critical issues.
- xiv. Regular visit of Beneficiary Houses and reporting to SLNA/Project Director.
- xv. Any other related tasks that may be entrusted upon by the head of ULB.
- xvi. Any other related tasks that may be entrusted upon by the head of CLTC/SLNA
