3. ELIGIBILITY:

- (a) A candidate must not be less than 18 years and above 32 years of age as on **05.11.2021**. However, the upper age limit is relax-able in accordance with the orders issued by the Govt. of Arunachal Pradesh from time to time in respect of Arunachal Pradesh Scheduled Tribe candidates.
 - **(b)** A candidate must possess Bachelor's Degree in Science or Engineering of any recognized University or Institution with at least one of the following subjects.

(iii) PHYSICAL TEST: Walking Test of a distance of 25 Kms and 14 Kms to be completed in 4 (four) hours by Male and Female candidates respectively.

Note: The Physical Test will be qualifying in nature.

The candidates who have already appeared in final examination of the qualifying degree and waiting for result shall also be eligible to apply. However, the candidates who have declared to have qualified in the written examination have to produce certificate and mark-sheet in original of passing degree at the time of Viva-voce/Interview.

4. METHOD OF SELECTION: The eligible candidates will be required to appear in the written examination in the following subjects:

A candidate is to select any 2(two) of the subject listed at **Sl. No. 3(b)** above but will not be allowed to offer the following combination of subjects.

- (i) Agriculture, Agricultural Engineering & Veterinary Science.
- (ii) Chemical Engineering and Chemistry.
- (iii) Computer Application/Computer Science and Computer Science & Engineering.
- (iv) Electrical Engineering and Statistics.

The candidates securing a minimum of 33% or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination papers shall be eligible for Viva-voce. On the other hand, it will further mean that selection for Viva-voce shall be based on the aggregate total marks secured in the written examination papers and subject to ratio of 1:3. The candidates securing less than 33% of marks in any of written examination paper shall not be eligible in the Viva-voce. However, the Selection Committee or Commission may lower the 'Cut off Marks' of 45% to certain extent, in case of non-availability of APST candidates securing the 'Cut off marks'.

- **MEDICAL FITNESS**: Those candidates who are declared to have qualified in the written examination will be called for Medical Test followed by Viva-voce/Interview.
- 5. In case there are a large number of applicants, the Commission may conduct *Initial Recruitment Test (OMR Based Objective Type) on General Knowledge and General Studies Paper carrying 100 marks* to limit the number of candidates for the Written Examination to 12 times of the total posts.
- **6. FEE:** Candidates are required to pay fee of Rs. 100/- for APST candidates and Rs.150/- only for others through online mode only.
- 7. HOW TO APPLY: Candidates are required to apply online only through Website www.appsc.gov.in Brief instruction for filling up of online application is available on the above mentioned website.

Syllabi of optional subjects can be downloaded from the above mentioned website.

8. <u>Documents to be uploaded</u>.

Candidates must upload scanned copies of the following documents along with the application.

- (i) Scanned signature of the candidate on white paper with black in pen (20 kb to 60 kb)
- (ii) Recent pass-port size photo (size 40 kb to 100 kb).

Note: Candidates should not use Mobile phone to apply online and should carefully read and understand browser information before applying online.

- **9.** <u>Prior to Viva-voce/Interview</u>. Candidates declared qualified in the written examination will have to submit **self-attested** Xerox copies of the following documents/information to the Commission one week prior to the date of Viva-voce/Interview.
 - (i) Recent passport size photographs.
 - (ii) Self-attested Xeroxed copies of Degree certificates and mark-sheet issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain degree.

- (iii) Self-attested Xeroxed copy of Matriculation certificate for proof of age issued by the Board only will be accepted.
- (iv) Self-attested Xeroxed copy of APST certificate for APST candidates and PRC/Adhaar Card/EPIC for other candidates.
- (v) Intimation letter to HoD or NOC from the applicable Authority (for the Departmental candidate only).

Those candidates who are appearing for Viva-voce/Interview will have to produce the above mentioned certificates and mark-sheet/documents in original at the time of Interview/Viva-voce, failing which he/she will not be allowed to appear in the Interview.

- 10. The decision of the Commission as to the eligibility or other-wise of candidate for admission to written examination or selection will be final and no correspondence or personal enquiry will be entertained.
- 11. The last date/time for submission of application is 05.11.2021 (till 1600 hrs)
- **12. EXAMINATION FEES**: Candidates are required to pay fee of Rs.100/- for APST and Rs. 150/- for others through online mode only.
- **13.** A candidate who is or has been declared by the Commission to be guilty of:
 - (a) Obtaining support for his/her candidature by any unfair means or,
 - (b) Impersonation or,
 - (c) Procuring impersonation by any person, or
 - (d) Submitted fabricated documents or documents which have been tampered with or
 - (e) Making false or incorrect statement or suppressing material fact or information or Resorting to any other irregular or improper means in connection with his/her candidature for the examination or
 - (f) Using unfair means during the examination or
 - (g) Writing irrelevant matter, including obscene language or pornographic matter in the scripts or
 - (h) Misbehaving in any other manner in the Examination Hall or harassing or doing bodily harm to the Supervisory Officers/Invigilators/Staff employed by the Commission for the conduct of examination or
 - (i) Violating any of the instructions issued to the candidate along with their Admission Certificate/Call Letter permitting them to take the examination, or Commission or as the case may be attempting the Commission of all or any of the acts specified in the foregoing clauses by a candidate may, in addition to rendering him/her to criminal prosecution be liable:
 - (a) To be disqualified by the Commission from the Examination for which he/she is a candidate or
 - (b) To be debarred permanently or for specified period.
 - (i) By the Commission from any examination or selection held by them.
 - (ii) By the State Government from any employment under them and
 - (c) If he/she is already in-service under the Government, disciplinary action under the relevant rules shall be instituted.
 - (d) Provided that no penalty under these rules shall be imposed except after:
