**NOTIFICATION**

In pursuant to the meeting with all Principals of affiliated colleges with the Vice-Chancellor, Statutory Officers, Director College Development Council and other officers of the University held on 24.11.2021 and by considering the Covid-19 appropriate behavior as per SoP/Protocols, keeping in view incompleting vaccination of all students and also considering the fact that in many colleges classes were conducted both online and offline (50 : 50), it is to notify that End Semester Examinations of all Undergraduate Courses in the affiliated colleges scheduled in December 2021 shall be conducted on Online/Blended mode. This shall be effective only for odd semester examination 2021.

In this regard, following points may be noted:

- (1) Examination fee that was already collected will remain the same and no fee shall be refunded to student as expenditure has been incurred for offline mode of exam.
- (2) Student shall submit their answer scripts of the particular examination on the same day of the examination in their respective colleges.
- (3) Only those students notified as eligible by the respective college and have filled-up exam form shall appear online examinations. The Non-eligible students appearing the examination by obtaining question papers from other sources shall be summarily rejected. Such students shall not claim for declaration of their results.
