## INTIMATION

Apropos to the situation of confusion arisen due to component of Environmental Studies in both Ability Enhancement Compulsory Course and Generic/subject specific course categories, this is to clarify that Ability Enhancement Compulsory Course (AECC-II) for three (3) conventional courses, that is; BA, B.Sc. and B. Com have been prepared separately and notified and circulated in July, 2021.


2. Accordingly, there is separate Environmental Studies syllabus for (i) all B.Sc. programmes and BA Mass Communication and (ii) B.Com programme.

3. Likewise, (iii) Humanities and Arts programmes viz., BA Anthropology, B.Ed., BFA, B.PEd., BA Economics, BA Education, BA English, BA/B.Sc. Geography, B.Sc. Geology, BA Hindi, BA History, B. Music, BA Political Science, BSW (Social Work) and BA Sociology, etc., will follow the Environmental Studies syllabus and course structure framed by BUGS (Geography) only.

4. For this, the email sent through the undersigned's email (david.pertin@rgu.ac.in) to all the Principals on 8<sup>th</sup> July, 2021 at 1.26 PM may be referred as ready reference.

5. More so, the AECC-II EVS syllabus framed by BUGS (Political Science) and BUGS (History) may be ignored.

6. Thereby, it is clarified that, AECC-II Environmental Studies syllabus framed for BA/B.Sc. Geography shall be uniformly applicable for all the Humanities and Arts programmes as mentioned at 3 above.
