### INTRODUCTION

With the purpose of promoting mutually beneficial relations between the two institutions through a common effort of understanding and cooperation, **GANDHI KING FOUNDATION** and the **RAJIV GANDHI UNIVERSITY** agree to broaden their collaboration by entering into the present Memorandum of Understanding (MoU).

### PURPOSE & OVERVIEW

- GKF has been working in the fields of Peace, Non-violence and Youth development for about a decade. The purpose of this MoU is to bring the possibility of collaboration with organizations and institutes of global eminence. GKF is coordinating with the Permanent Secretariat of the World Summit of Nobel Peace Laureates in implementing the Curriculum "Leading by Example" in Universities & educational institutes in India along with numerous other programs.
- GKF is closely associated with Gandhi King Global Initiative (GKGI), Stanford University, Pietermaritzburg Gandhi Memorial Committee (South Africa), University of Rhode Island etc to name a few with whom numerous global events were being organized.
- GKF will have the opportunity to work with the partnering University/ Institution to participate and implement various global programs - for example, World Summit of Nobel Peace Laureates, Gandhi King Conference, Gandhi Mandela Symposium etc
- GKF and the partnering University/ Institution shall establish and develop common leadership programs or support the existing events during the period of understanding.

### TERMS OF AGREEMENT:

This Agreement is effective upon October 15, 2020, executed by the duly authorized signatories of the parties to this Agreement and shall remain in full force and effect for 48 months and is auto-renewed after that. This Agreement may be terminated, without cause, by either party upon 90 days written notice via email.



### RESPONSIBILITIES:

- GKF shall share all the events and programs to the partnering University/ Institution across the year for participation, support and other mutually agreed actions.
- Partnering University/ Institution shall support the activities/ event organized by GKF (either solely or through other collaborations) in the best possible interest of both the parties in accordance to the existing policies of the partnering University/ Institution.
- Support could be nominating students, staff to participate in the events, promoting events/ activities on the website or possible media that the partnering University/ Institution engages in and not restricted to such a support alone.
- Promotion of GKF events in partnering University/ Institution in accordance to the policies established by partnering University/ Institution.
- Use of Logos: GKF and partnering University/ Institution shall use the logos on their respective websites in accordance to the existing policies to promote the events (online and offline)
- With the intention to systematically develop a mutually beneficial cooperation, the contracting parties annually stipulate the activities that shall be implemented in the following year. All suggestions and confirmations from both sides should be sent to the other party in writing via e-mail of the organizations or responsible persons
- Possibility of conducting certification courses, webinars in collaboration with the partnering University/ Institution
- Possibility of organizing youth summits, research programs, campus programs, in collaboration with the partnering University/ Institution.

### FINANCIAL COMMITMENT:


