**MEMORANDUM**

The Governor of Arunachal Pradesh is pleased to offer Provisional Appointment to Miss **HAPPY SONAM (Roll No. 113700** of Arunachal Pradesh Public Service Combined Competitive Examination Select List 2017). Daughter of Shri **SAWA SONAM of village Taffo, P.S.- Seppa, P.O. Bameng, District East Kameng State Arunachal Pradesh** to the post of Trade Development Officer (Group B) Gazetted under the Department of Trade & Commerce, Government of Arunachal Pradesh, in the **Pay Matrix Level- 7 (Rs 44900-142400)** per month plus other allowances as admissible to the State Govt. employees from time to time.

**1. The terms of offer of appointment are as follows:-**

- a) The appointee shall be on probation for a period of two years.
- b) The appointment may be terminated at any time by a month's notice given by either side during the probation period, viz. the appointee or the appointing authority without assigning any reason. The appointing authority, however reserves the right to terminate the service of the appointee forthwith or before the notice by making payment to him/her of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
- c) The appointment carries with it the liability to serve in any part of Arunachal Pradesh.
- d) Other conditions of service will be governed by the relevant rules and orders in force from time to time.

**2. The appointment will be further subject to:-**

- a) Production of Certificate of Fitness from the Medical Board, appointed/authorized by the Government of Arunachal Pradesh. Those who are already in Government of Arunachal Pradesh service and examined by the Standing Medical Board and applied through proper channel need not produce Medical Certificate.
- b) Submission of Declaration in the Form (Annexure-I) enclosed and in the event of the candidate having more than one wife living or being married to a person having more than one wife living, the appointment will be subject to his/her being exempted from the relevant Rules of CCS (Conduct) Rules, 1964 in this behalf.
- c) Taking an Oath of Allegiance & Faithfulness to the Constitution of India (or making of a solemn affirmation to that effect) in the prescribed Form on joining.
- d) Production of the Release Order/NOC from the previous employer (applicable in the case of persons who are already in Govt. service).

- e) Training as and when assigned to him/her by the Government must be attended without fail and shall be passed; otherwise, probation period may be extended to that extent.
3. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to willfully suppressed any material fact, he/she will be liable to be removed from service/discharged from probation and such other action as may be taken by the Govt. as deem fit.
4. If Miss **HAPPY SONAM** accepts the offer of appointment on the above terms, he/she should communicate his/her acceptance to the undersigned within 15 (Fifteen) days from the date of receipt of this Offer of Appointment letter or else the offer will be treated as cancelled/withdrawn.
5. No travelling allowance will be allowed for joining the place of posting.
6. The enclosed attestation forms (Annexure-II) in duplicate duly completed in all respect must be submitted along with the Medical Certificate etc. as specified in Para 3 above for appointment.
7. Four copies of self attested recent passport size photographs may also be submitted along with the acceptance letter in a separate envelope.
8. Production of the following certificate in original
- Educational & other Certificate.
  - Certificate in support of Age.
  - Character certificate from District or Sub-Divisional Magistrate or from two Gazetted Officers known to him/her for the last 3 (three) years prior to this appointment.
