- [2] The appointment shall be on probation for a period of 2 (two) years from the date of their joining and probation shall be regularized subject to satisfactory performance.
- [3] The appointment may be terminated at any time by a months notice given by either side viz, the appointee or the appointing authority, without assigning any reason. The appointing authority however reserves the right to terminate the service of the appointee forthwith or before the notice by making payment to him /her of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
- [4] The appointment carries with it the liability to serve in any part of Arunachal Pradesh as well as in the establishment of Government of Arunachal Pradesh located outside Arunachal Pradesh as desired by the Government.
- [5] If any declaration given or information furnished by the candidate proves to be false or if the candidates is found to have willfully suppressed any material information, he/she shall be liable for removal from service and such other action as Government deems necessary.
- [6] The appointment will be further subject to:
  - I Taking an Oath of allegiance and faithfulness to the constitution of India (or making of solemn affirmation to that effect in the prescribed form on joining.
  - ii. Production of Release Order/NOC from the previous employer (applicable in the case of persons who are already in Government Service)
  - iii Production of original Educational Qualification Certificate and Disability Certificate in respect of candidates selected under PWD quota, including all other testimonials for verification at the time of joining.

The appointee shall submit Medical fitness certificate from concerned DMO and NOC from the respective district administration at the time of joining.



- v. Any training as and when assigned to him/her by the Government must be attended without fail.
- vi The appointee shall report to the respective Deputy Commissioner of the field posting place at the District Hqtr. along with their original documents mentioned at sl ii to iv above for verification and for receiving briefing about the day to day functioning of the civil administration of the administrative unit.
- [8] The appointed officers are directed to report to the respective Deputy Commissioners and submit their joining report within **14 (Fourteen) days** from the date of issue of this order.

[9] The other terms and conditions of service shall be governed by the relevant rules and orders in force from time to time
