ORDER

The Governor of Arunachal Pradesh is pleased to accord administrative approval for Construction of Auditorium Building at Rajiv Gandhi University, Rono-Hill, Doimukh funded by DoNER under NLCPR scheme at an estimated cost of Rs 1021.73 Lakhs (Rupees Ten Crore Twenty One lakhs Seventy Three Thousand) only.

The Governor of Arunachal Pradesh is further pleased to accord expenditure sanction for Rs 333.98 lakhs (Rupees Three Crore Thirty Three Lakhs Ninety Eight Thousand) only being the payment of 2nd Installment of Grant-in-aid to Registrar, Rajiv Gandhi University for Construction of Auditorium at Rajiv Gandhi University, Doimukh, subject to the restriction of fund during current financial year 2015-16 and observances of all codal formalities and conditions stipulated under.

1. The expenditure by the executing agency during 2015-16 is restricted to Rs 333.98 lakhs (Rupees Three Hundred Thirty Three Lakhs Ninety Eight Thousand) only subject to the existence of budgetary provision during the current financial year under the concerned Head of Account.
2. The project should be completed as per original scope, specification and no revision of the estimate is entertained. There should no time and cost over run.
3. The funds should be utilized within specified time and strictly for the purpose for which it has been sanctioned. No diversion of the fund is allowed.
4. The concurrence is subject to non-duplication with any other scheme. Any deviation would be responsibilities of the Department.
5. The selection of works/schemes and its execution shall be as per guidelines of Government. And any deviation would be responsibility of the Department.
6. This concurrence is subject to the following of all codal formalities and ensuring guidelines of State Government/Gol which shall be squarely be the responsibility of the Department.

7. The Department shall deduct TDS of VAT on works contract @ of 12.5% leviable on taxable turnover of the works contract vide Ordinance No. TAX-64/2004/Pt. Dated 28<sup>th</sup> August 2009 or adopted by contractors, as per new schemes of 4% on total turnover issues vide Notification No. TAX-28/2002/Vol-II, dated 31<sup>st</sup> Aug' 2009 of Department of Tax & Excise.

All codal formalities, all the provisions and conditions prescribed in GFR, DFPR, CPWD Manual etc. all the Financial Rules and Regulations, the guidelines and directives issued by the Gol, Ministry of Finance, Gol Administrative Ministry of Gol, CVC and Govt. of Arunachal Pradesh in this regard from time to time should be followed in letter and spirit without fail.

The execution of the works/schemes/projects and procurement of items/materials, furnitures etc. should be done strictly as per the provision of GFR, GFPR etc and guidelines and conditions prescribed by the Gol, CVC and Govt. of Arunachal Pradesh in this regard from time to time. The process of tendering and competitive bidding should mandatorily be followed and complied with as envisaged in the GFR, DFPR, Financial Rules and Regulations and the conditions, guidelines, circulars and directives issued/prescribed by Govt. of India, CVC and Govt. of Arunachal Pradesh in this regard.
