NOTICE INVITING EXPRESSION OF INTEREST


Rajiv Gandhi University invites Expression of Interest (EOI) from interested reputed firms experienced in supply of Curtain, Blinds, Vinyl and its accessories. The interested Suppliers/Firms may quote their rates on the appropriate format as per Annexure-I.

General Terms & Conditions

1. The interested firms are required to submit their rates inclusive of GST, installation etc. along with the EOI.
2. The interested firms are required to submit a demand draft of Rs. 5,000/- (Rupees five thousand only) as Earnest Money in favour of Registrar, Rajiv Gandhi University, Rono Hills Doimukh.
3. The interested firm must be a registered Firm and must attach the documents.
4. The interested firms must have a valid GST Certificate, PAN to participate in the tender and must submit self attested copy of the same.
5. The willingness in all respect should reach the office of the University, at above mentioned address, in duly sealed envelope superscribed with 'Expression of Interest for supply of curtain, blinds, vinyl and its accessories'.
6. Incomplete & conditional willingness is liable to be rejected. Late and delayed willingness will not be considered.
7. It will be responsibility of the firm to pack the material by his own labourers and the cost towards transportation, packing, loading, unloading, installation at various sites/location etc. will also be borne by the firm.
8. The EMD amount, whose rates are not approved, will be returned within 30 days upon finalization. No interest will be paid on the amount of the EMD. However, the EMD of the firm, whose rates are accepted, will be returned on submission of performance undertaking after completion of the entire job that the materials has been received by them in full quantity, mentioning the weight of the material.
9. The University reserves the right to terminate the EOI without assigning any reason.
10. In case of any dispute, all legal matters shall be instituted within the jurisdiction of the place where the buyer ordinarily resides.
11. Additional terms and conditions will be incorporated in the supply order, if needed, to safe guard the interests of the University.
12. Any correspondence related to this EOI shall be uploaded in the website. Therefore, all bidders are requested to visit the website www.rgu.ac.in from time to time.
