# **ALUMNI ASSOCIATION OF RAJIV GANDHI UNIVERSITY (AARGU)**

### **PART-I: MEMORANDUM**

1. Name : The Name of the Association/Society shall be Alumni

Association RGU (hereinafter referred in short as AARGU).

2. Address : Rajiv Gandhi University Campus, Rono-Hills, Doimukh, District

Papum Pare, Arunachal Pradesh-791112

3. Jurisdiction : The jurisdiction of the Association shall be all over India, but any

dispute, case, suit shall be subject to the courts of Itanagar only.

4. Objectives : a) To foster stronger relation between RGU Alumni and the others connected with the University in all fields.

: b) To realize the enormous benefit that can come from the engagement and support of RGU Alumni with the University and seek their support in identifying strategic directions for RGU.

- : c) To provide opportunities for community service to act as good will Ambassadors for RGU within India and abroad.
- : d) To provide for academic and professional interaction and networking among RGU alumni and endeavour to create opportunities for RGU student community.
- : e) To prove assistance and facilities for all round development of the university.
- : f) To encourage the members to take active interest in the activities and progress of the alma-mater.
- : g) To initiate various welfare measures and activities so as to establish strong bond between the alumni and the University.
- : h) To leverage the power of alumni through networking and to maintain strong alumni database.

#### **PART-II: RULES AND REGULATIONS**

1. Membership : i) All Alumni of the Rajiv Gandhi University who have completed minimum 1 years of Course shall be eligible

for life membership of the Association. They shall have

voting rights

ii) The Vice Chancellor shall be the Ex-officio Patron of the

Association and in that capacity shall enjoy all the

privileges of a member.

2. Associate Member : All present and Ex-employees can register themselves as

Associate members and they shall have no Voting

Rights.

3. Cessation of Membership : A member of the Association shall cease to be such a

member if he/she resigns from his/her membership or

found to be unsound mind or is convicted by a court of

law for any offence on moral grounds or termination of the membership by the Executive Committee for

compelling reasons.

4. Fees : Every members shall pay a membership fees/annual or

life members as decided by the University as per the

RGU Act.

5. General Body : The entire members of the Association shall constitute

the general body and shall meet once in a year at a

designated place and time. The general body shall have

the power to consider and decide on all matters relating

to AARGU and provide broad policy frame-work

towards the functioning of the Association. The general

body shall also elect an Executive Committee to carry on

with the activities of the Association.

6. Executive Committee : i) The management of Association and its activities shall

be vested in an Executive Committee (hereinafter EC)

nominated by the General Body for a three year term. EC

shall meet as many times as it feels deem fit. The EC shall comprise of President (one), Vice President (two), General Secretary (one), Treasurer (one), Joint Secretary (five), Chief Advisor (Ex-officio).

ii) The Association may create as many posts as equivalent to Jt. Secretary to undertake works of State/National and Global Alumni networks.

7. Powers of Executive Committee:

- i) It shall decide all its matters mostly by consensus and if no consensus could be reached on any matter the same will be decided by a vote of 2/3<sup>rd</sup> of majority members present.
- ii) The EC shall have financial power to oversee its activities such as open a Bank Account. To receive and spent money and to maintain proper account to create an Alumni Fund to further the purpose as mentioned.
- iii) It shall initiate such other welfare activities to foster bond between alumni and the University.

8. Chief Advisor, AARGU

The Chief Advisor shall be an official of the RGU and the post will be Ex-officio. He/she will be official link between Alumni and the RGU community.

9. Logo/website

The University logo or any other logo shall be used and all activity, membership forms etc shall be placed in the website.

10. Amendments

The General Body has the power to carry out amendments to the AARGU Constitution from time to time with a view to realize effectively the purpose as stated in clause 2. Any proposed amendments shall be circulated to members as far as possible of the Association along with the notice for amendment meeting.
