3. The candidates, who are in-service, are directed to submit an irrevocable No-Objection Certificate (NOC), from their respective employer (not necessarily from the Head of the Institute where employed) stating categorically “to provide study leave as and when required”, as per the University Ordinance. Non-submission of NOC at the time of Viva- Voce will disqualify the candidature and will not be allowed to appear the Viva Voce.

  - a. **On the First Page** – Name of the proposed Research Work, Subject Domain, Name of the Candidate with e-mail id, Mobile Number and Address.
  - b. **Second Page onwards-** Concept Note of the Draft Proposal, Research Gap, Objectives, Scope and Significance, Hypotheses, Proposed Outcomes, Research Methodology (Research Model, Research Variables, Place and period of Study, Sources of Data, Universe, Sample size, Sample Distribution), Proposed Chapterisation etc.
