- 6.0 All pages forming the detail bid documents issued to you must be submitted with seal and signature of bidder towards acceptance of the bid Terms & Conditions.
- 7.0 The Bidders shall be required to submit their bid in two separate envelopes as per following. The First envelope shall contain EMD in favour of Registrar RGU and failing which the bid shall not be opened and shall be returned unopened to the bidders.
- 8.0 The second envelope shall contain the techno-commercial/price bid duly super scribed with the package Name/enquiry No. and Name & Address of bidder.
- 9.0 Both the envelopes shall be submitted together at the same time. Failing of 1st envelope containing EMD, the second envelope containing Price Bid shall not be opened and shall be returned unopened to the bidders.
- 10.0 You are requested to submit your offer along with bidding documents DULY SIGNED & STAMPED, so as to be received by us as under.


