



#### RB: 44: E: Any other items:

#### Under the Any Other Item for discussion, the following decisions were taken;

- 1. Every Ph.D. students who are drawing non-NET fellowship and other fellowships shall come to their respective Departments every day. For this, there will be two registers, of which one register will be with the Supervisor (which will carry the names of scholars under him/her) and another register will be with the HoD which will carry the names of all the scholars under his/her Department/Institute. The scholars shall sign the attendance register every day. Before releasing the fellowship, the same should be submitted to the VC's Office for perusal by the Vice-Chancellor apart from the absentee statements. This is done to ensure involvement of scholars on the basis of the guidelines of UGC on the conduct of Ph.D. students.
- 2. Every supervisor shall ensure allocating some responsibilities to his/her scholars.
- 3. Director (IQAC) shall develop a proforma for 6-monthly assessment of progress report. Scholars are required to attend the seminars/webinars, symposium, etc. There must be a column in the proforma wherein their previous seminar/webinar attendance will be shown based upon which certain marks will be given. Furthermore, in this regard, analogies shall be obtained from other Universities which are within 100 of NIRF ranking.
