Concept Note and TOR for Survey Coordinator

ICRIER's research on India-Myanmar cross border trade and connectivity indicates that there has been a significant increase in informal trade even though the Indian Government has taken measures in 2015 to normalize cross border trade between India and Myanmar. In fact the officially permitted barter trade has rapidly converted to informal trade. Formal trade which was at low levels prior to 2015 has become negligible after the Government introduced measures to normalize trade.

The study project proposes to examine how impediments in the formal trade can be addressed to increase trade and how informal trade can be channelized to formal trade through corrective, adaptive and new measures. Including the gender dimension in studying informal trade has the potential to be a key driver for women's socio-economic empowerment and enhanced productivity.

Specifically the study has the following objectives:

- Identifying major cross border trading points for informal trade and estimating the quantum of India's informal trade with Myanmar
- Understanding institutional arrangements supporting informal trade. This would include
 examining the transacting environment of informal trade in terms of sourcing of goods,
 nature of markets in informal trade, the types of mechanisms for the flow of information
 on trading opportunities as well as the governance of contractual relations in informal
 markets. It would also include understanding the risk mitigating mechanisms adopted by
 informal traders.
- Identifying inadequacies of the formal channel and examining the reasons for weak implementation of trade policies in the formal trading channels.
- Identifying the roles played by women in informal trade chain.
- · Identifying ways to facilitate greater involvement of women in formal trade.
- Suggesting measure to improve the formal channels and make them more conducive for cross border trade.

TOR for Survey Coordinator

- As the Survey Coordinator for the state of Arunachal Pradesh you are expected to:
 - Identify the locations of major informal markets across the Arunachal Pradesh-Myanmar border through which informal trade is taking place.
 - Provide an estimate of the quantum of commodity-wise informal trade with Myanmar.
 - Map the institutional functioning and arrangements supporting informal trade.

- Provide the modalities being used by informal traders to source goods that are exported and distribute goods that are imported.
- Identify inadequacies of the formal channel that encourage traders to trade informally.
- ICRIER will design questionnaire for estimation of informal trade. The questionnaire will
 be designed to capture the volume, aggregate, item-wise and route-wise value of informal
 trade, characteristics of business, trade features, and custom process and transaction
 procedures involved in the trade.
 - Survey Coordinator will provide his inputs/feedback on the questionnaire and checklist design process.
- Survey Coordinator will conduct/supervise field survey of all identified informal markets across the Arunachal Pradesh-Myanmar border through which informal trade is taking place.
- The survey will be conducted twice using the questionnaire prepared by ICRIER.
- The survey respondents will cover:
 - Minimum of 50 informal traders carrying out trade through and around formal channels
 - Minimum of 25 respondents in each identified informal market
- The Survey Coordinator will interview concerned authorities/ governments departments in the capital city as well as locally. The consultant will also interview knowledgeable persons having knowledge about informal trade.
- Survey Coordinator will also be responsible for data entry, using the common template provided by ICRIER.
- Based on survey/ stakeholder consultations and other material, Survey Coordinator will
 prepare and submit state report on the extent of informal trade between Arunachal
 Pradesh and Myanmar. Specifically report should include
 - Identification of location of major informal markets across the Arunachal Pradesh-Myanmar border through which informal trade is taking place.
 - A detailed analysis of estimate the quantum of commodity-wise informal trade with Myanmar conducted through the state of Arunachal Pradesh
 - A framework of institutional arrangements supporting informal trade
 - Detailed modalities being used by informal traders to source goods that are exported and distribute goods that are imported.
