**Subject:-** Release of 2<sup>nd</sup> installment of Central Assistance to **Rajiv Gandhi University, Rono Hills, Doimukh, Itanagar, Arunachal Pradesh** (a Central University) under CSS of **Construction of Hostels for OBC Boys & Girls** during 2017-18 -reg.

Sir,

I am directed to refer to **Rajiv Gandhi University, Itanagar's** letter No. RGU/DEV-236/2011(C)(Vol.I/12 dated 19/07/2017 on the above subject and to convey the sanction of the President of India for release of **Rs. 58,18,000/-** (Rupees fifty eight lakh eighteen thousand only) to **Rajiv Gandhi University, Itanagar, Arunachal Pradesh** (a Central University) for construction of **two Hostels** accommodating 100 inmates for **OBC Student** (One hostel each for OBC boys and Girls accommodating 50 inmates in each hostel) under the "**Centrally-Sponsored Scheme of Hostels for OBC Boys & Girls**" during the year 2017-18, as per **Annexure**, out of a total sanctioned Central Assistance of Rs. 1,29,30,000/-. Out of the sanctioned amount, Rs. 64,65,000/- has already been released to the University as first installment vide letter dated 28/03/2015. The balance amount of Central Assistance i.e. Rs. 6,47,000/- will be released to the University later on after completion of construction of the hostels. The balance of the cost over and above Central Assistance will be borne by the University, as intimated vide their letter No. RGU/DEV-236/2011(C) dated 17th December, 2014.

2. This sanction relates to then Plan Expenditure and is in accordance with the pattern of assistance prescribed by then Planning Commission.
