Sub: - Fund Proposal for the expenditure of distance education admission fee in respect of convict prisoner of District Jail Jully for CFY-2022-23.

With reference to letter received from the JSH vide No. HMB(B)PD-09/2019/Pt/606 Dated Itanagar, the 31st August'2022 (**see at P-1c**). Prison department had obtained willingness from the convict prisoner lodged in district jail Jully, who is interested to join in **Institute of Distance Education**. The institute of Distance Education Rajiv Gandhi University, Itanagar had also supplied the **course offering chart** and verbally informed that the admission season will end by 31st Oct'2022.
