ITEM 10: To procure 1 (one) No. Xerox/Photostat Machine for the Examination Branch

The Council accepted the recommendation of 16th Finance Committee Meeting held on 13.03.97 and approved procurement of 1 (one) Xerox/Photostat machine for the Examination Branch, subject to availability of fund, with the observation that the machine be kept near the Controller's Desk to avoid misuse.

ITEM 11 : To approve construction of 10 (Ten) units of temporary Type S.P.T. Building for Arunachal University, for Security Guards.

The Council considered and accepted the recommendation of the 16th Meeting of the Finance Committee and approved construction of a semi permanent Type Building in place of M.I.B.T. for an estimated amount of Rs. 6.15 lakh plus extra cost of Rs. 80000/= being the difference of cost between M.I.B.T. & S.P.T. subject to due scrutiny of the proposal and estimate by the Building/Construction Committee and subject to availability of fund.

ITEM 12: To approve creation of teaching and non-teaching posts for proposed Life Science post Graduate Departments of Zoology and Botany

The Council accepted the recommendation of the 16th Meeting of Finance Committee held on 13.03.97 and approved creation of teaching and non-teaching posts, as detailed below, from 1997-98 Academic Session to start Botany and Zoology Department, subject to fund support and concurrence of the State Government.

To approve recommendation of proposal for declaring permanency of teaching posts and teachers

The Council considered the recommendation, as at Annexure 'A', of the Committee constituted for examining the eligibility of teachers for finalizing the cases of their permanency/confirmation. After thorough discussion of the report, the Council resolved as follows :

- (i) All teaching posts duly created by the University and concurred by the State Government in the various teaching departments are regular posts against which the teachers appointed through due process of selection can be confirmed following successful completion of probation as provided for Ordinance 20.
- (ii) Confirmation of teachers against permanent teaching posts shall be subject to following conditions :
  - 1) The post has to be a clear post against which no other incumbent is holding lien/deputation/Extra Ordinary Leave, etc.
  - 2) The teacher to be confirmed has to submit a Self-Appraisal Report which is accepted as satisfactory by the University authority.
  - 3) A confidential report from the immediate superior, i.e., the Head of the Department ; and in the case of Head of the Department, by the concerned Dean, In case the teacher happens to be a Dean, the confidential report be given by the Vice-Chancellor.
  - 4) A declaration from the concerned teacher to the effect that no police/criminal case is pending against him.
  - 5) Submission of medical certificate from medical authority as specified by the University.

To consider recommendation of the Selection Committees for the appointment of Readers and Lecturers in the Departments of Tribal Studies and Commerce.

The Council considered and accepted the recommendation of the Selection Committee meetings held on 10.03.97 for appointment of Readers and Lecturers in the Departments of Tribal Studies and Commerce as follows :
