To consider creation of Core Faculty for Mass Communication and teaching of Mathematics.

The Council deliberated on the following proposal of creating core faculties to run the Department of Mass Communication and Mathematics. The yearly financial implication for both the posts would be Rs. 3,67,000/- (approx.).

Considering the necessity of having the posts, the E.C. approved for the creation of the above Core faculties.

To consider creation of 3 (Three) Nos. of Lecturer's post for the Deptt. of Anthropology.

The Council noted that the Deptt. of Tribal Studies runs two programmes - Viz. M.Phil and MA in Anthropology. Keeping in view of a separate department in Anthropology 3 (three) posts of Lecturers in the pay scale of Rs.8000-275-13500 are required. The yearly financial implication would be Rs. 5,50,000/- approx.

The Council deliberated on the matter and resolved that the Department of Tribal Studies should be strengthened. By filling up of the already created posts, the Department can manage for the time being.

**Q1 49:36: To consider creation of teaching positions in the proposed Department of Mathematics**

The Council noted that the Finance Committee in its 38<sup>th</sup> meeting noted the proposal of the university to start the Department of Mathematics to run two courses – namely, M.Sc in Mathematics and Computing and Diploma in Teaching of Mathematics – from the session 2005-06. Considering the urgency, the following posts were created and advertised them in Employment News, National & Regional dailies:
