Dear Sir,

This is with reference to your office letter No. RGU/VCS-UGC/17 dated 13.12.2017 and RGU/REG/UGC/17 dated 16.12.2017 regarding the requirement of additional teaching positions. The matter was considered by the Committee constituted for the purpose. The recommendations of the Committee were placed before the Commission in its 5th meeting held on 24th May, 2018. The Commission considered and approved the recommendations of the Committee. Accordingly, the approval of UGC is conveyed for creation of 17 (seventeen) teaching positions in respect of Rajiv Gandhi University, Itanagar as per details below:

The expenditure on teaching positions approved for above mentioned departments be incurred out of the funds provided under salary head (36).

The above approval is subject to the fulfillment of the following conditions:-

- (i) University may fill up the teaching positions at the earliest and explore the possibility to allocate the vacant teaching positions in the new areas where the requirement of teaching positions in a particular department is more needed.
- (ii) The University should strictly adhere the reservation policy for SC/ST/OBC/PwD as per Government of India/UGC guidelines while filling up the teaching positions.
- (iii) The UGC Regulations of 2010 relating to Minimum Qualification for appointment of Teachers and other Academic Staff in University and Colleges and measures for the maintenance of Standards in Higher Education and as amended from time to time should be strictly followed.
- (iv) It is desirable that the Universities, especially the larger ones should focus on consolidation rather than horizontal expansion, to maintain quality.

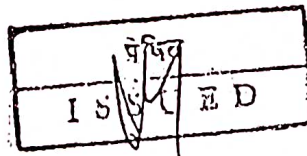
