**Dear Shri Injeti Srinivas,**

NITI Aayog is implementing the Atal Innovation Mission (AIM). As part of this mission, Atal Community Innovation Centres (ACICs) are being established across the country to support and encourage community driven innovation and transformation in the unserved and underserved regions of India. The selection of applicants for establishment of ACICs is carried out through a rigorous process and a grant-in-aid of Rs. 2.5 crore is provided to each selected applicant towards capital and operational expenditure.


As per the guidelines of the ACIC scheme, the selected applicants are required to form a Special Purpose Vehicle (SPV) under section-8 of the Companies Act, 2013. In order to maintain uniformity and give them a distinct identity with respect to the Atal Innovation Mission, the ACIC guidelines have prescribed that the name of the SPV formed must have the prefix "ACIC". For example, BML Munjal University, an applicant selected for establishment of ACIC will be required to register the SPV with the name "ACIC-BML XXXXX".

A total number of 24 applicants have been selected (copy enclosed). The registration of SPV is a prerequisite for disbursement of funds by AIM.

You would appreciate that these ACICs are being established with GOI support and it is important that they get identified by the name of the scheme under which they have been established. I would therefore request you to issue necessary instructions to the SPV registering authority(ies) to ensure that the SPV applications with the above-mentioned name directives from ACIC applicants may be accepted and registered.



Secretary, NEC in exercise of the financial powers delegated by the Government of India, Ministry of DoNER vide letter No. 4/1/2010-DoNER(NEC) dtd. 7<sup>th</sup> September, 2012 & OM No. 1/1/2014-DoNER(NEC) dated 26<sup>th</sup> November, 2014 has accorded **Administrative Approval** towards the proposal **“Documentation of endangered language, oral, Narratives and culture of Lesser known tribal communities of Arunachal Pradesh”** at an estimated cost of Rs. 89.95 (Rupees eighty nine lakh ninety five thousand ) only to be implemented by Registrar, **Rajiv Gandhi University, Doimukh, Arunachal Pradesh**. The funding is under Major Head “2552/31.

2. This Administrative Approval is issued subject to the following conditions:-
  - a) The assets/facilities created for the above studies sanctioned out of Government Grant will not be transferred/sold /alienated without the approval of NEC and Ministry of DoNER, Government of India
  - b) The **Rajiv Gandhi University, Doimukh, Arunachal Pradesh** shall ensure proper upkeep, maintenance and operation of the assets/facilities created out of the project.
  - c) The objective/methodologies as outlined in the above sanctioned proposal shall be strictly followed for implementation. There should not be any duplication of efforts/studies already made for the similar works.
3. The project is for study of **“Documentation of endangered language, oral, Narratives and culture of Lesser known tribal communities of Arunachal Pradesh”**
4. The detail particulars/scope of work/specification etc of the work/project **“Documentation of endangered language, oral, Narratives and culture of Lesser known tribal communities of Arunachal Pradesh”** as mentioned in the Project Proposal received from Director, Arunachal Institute of Tribal Studies & Coordinator, Centre of Endangered Languages, Rajiv Gandhi Central University. MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN DIRECTORATE OF RESEARCH  
DEPARTMENT OF CULTURAL AFFAIRS, GOVERNMENT OF ARUNACHAL PRADESH AND  
RAJIV GANDHI UNIVERSITY, DOIMUKH

Whereas, the Government of Arunachal Pradesh desires to promote Research & Documentation for development of Culture Policy of the state in pursuance thereof has decided to support this vision for developing the state's culture policy. And whereas the Directorate of Research, Govt. of Arunachal Pradesh, Itanagar and Rajiv Gandhi University shall be guided by the proposals and the concept paper as Annexure-I annexed to this MoU and shall form part of the MoU henceforth.

And whereas, for the said purpose the State Government has approved to place a fund to the tune of ₹1,00,00,000/- (Rupees one crore) only in favour of Directorate of Research, Govt. of Arunachal Pradesh, Itanagar and Rajiv Gandhi University to facilitate the research work in connection with the project - "Research & Documentation Programme in Partnership with RGU for Development of Culture Policy".

And Whereas, for this purpose the Government of Arunachal Pradesh vide letter No. PD (SPD)-04/2019-20/1258 Dated Itanagar, the 11<sup>th</sup> July' 2019 of Planning Department had placed an amount of ₹1,00,00,000 (Rupees one crore) only in Budget Estimate 2019-20 to the Department of Research, Government of Arunachal Pradesh for implementation of the same in partnership with Rajiv Gandhi University.



**And whereas,** the Directorate of Research, Department of Cultural Affairs obtained sanction of ₹1,00,00,000 (Rupees one crore) and drawal of ₹55,24,000/- (Rupees fifty five lakhs twenty four thousand) in AC Bill out of ₹1,00,00,000 (Rupees one crore) vide sanction order No. RES(CUL) BUD-ANN-240/18 Dated 24<sup>th</sup> Dec' 2019 in current financial year 2019-20.


**Now therefore, this Memorandum of Understanding** is made on 16<sup>th</sup> October' 2020 between Directorate of Research Department of Cultural Affairs represented by the Director of Research which unless the context otherwise require shall include his successor, representatives and assignee Department of Cultural Affairs (First Party) and Rajiv Gandhi University by Registrar on behalf of Arunachal Institute of Tribal Studies (AITS), RGU (Second Party) for implementation of budget announcement project "**Research & Documentation Programme in Partnership with RGU for Development of Culture Policy**" in the manner as laid hereunder:

1. The AITS, RGU and Directorate of Research will submit the estimate jointly prepared to the Secretary (Cultural Affairs) and will incur expenditure as per approved estimate only to implement **Research & Documentation Programme in Partnership with RGU for Development of Culture Policy** and will act in a transparent manner to implement the project/ scheme within the stipulated time period of two years.
2. The completion of project is mandatory. Therefore the payment will be released on two installments. The amount of 1<sup>st</sup> installment will be ₹45,24,000/- (Rupees forty five lakhs twenty four thousand) only out of ₹55,24,000/- (Rupees fifty five lakhs twenty four thousand) only which is drawn in AC Bill in favour of Director of Research and accordingly will be placed to RGU. The remaining amount of ₹10,00,000/- (Rupees ten lakhs) only from ₹55,24,000/- (Rupees fifty five lakhs twenty four thousand) only will be incurred by the department for transportation of the core team. Depending upon the performance and progress of the project the next installment will be released in part installments. The last part installment of second installment will not be released until the work is completed. Only after the completion of project and acceptance of the cultural policy by the State Government the last part installment will be released. In case of failure of completing the project within stipulated time period 10 percent of present cost will be deducted.
3. The project **Research & Documentation Programme in Partnership with RGU for Development of Culture Policy** will be completed within stipulated time period of 2 (two) years from the date of execution of the deed.
4. The Rajiv Gandhi University will realize an overhead charge of 10% from this project.
5. The AITS, RGU will be allowed to spend money with the approval of Nodal Department exclusively for the purpose of implementation of **Research & Documentation Programme in Partnership with RGU for Development of Culture Policy** in the line of approved scheme by the Government.

6. The Directorate of Research, the Nodal Department, Government of Arunachal Pradesh shall have exclusive right of monitoring the activities and may call for the records of the account statement related to it for verification as and when felt expedient by giving a prior notice of reasonable time and the **RGU** shall furnish the account statement regularly to the Directorate of Research, Government of Arunachal Pradesh, Itanagar and maintain proper upkeep on the accounts as required the Financial Rules there under.
7. The **AITS, RGU** will have meeting with Nodal Department represented by Secretary (Cultural Affairs), Director and Nodal Officer in the interest of implementation of **Research & Documentation Programme in Partnership with RGU for Development of Culture Policy** from time to time.
8. No deviation of the fund earmarked for the scheme is permissible. The **AITS, RGU** will abide by the Modalities set in the proposal or estimate approved by the Nodal Department and refers the draft Culture Policy provided by the Nodal Department.
9. The copyright of the outputs of this project both manuscripts/ book and audio-visual documents will rest with both organization i.e., the Directorate of Research, Government of Arunachal Pradesh and Arunachal Institute of Tribal Studies (**AITS**), Rajiv Gandhi University.
10. Any dispute(s) in implementation of this MoU or implementing the scheme shall be settled within the Jurisdiction of Itanagar (Arunachal Pradesh) and the matter shall be referred to the Chief Secretary to the Government of Arunachal Pradesh who shall appoint any Commissioner/ Secretary for resolution/arbitration. The procedure of such arbitration(s) shall be as per provision of Arbitration and Conciliation Act, 1996 and the orders of arbitrator shall be final and binding on the Department of Cultural Affairs, Government of Arunachal Pradesh and the **AITS, RGU**.
11. The Nodal Department shall be periodically informed about any activities and publicity made by the **AITS, RGU** in relation to the project **Research & Documentation Programme in Partnership with RGU for Development of Culture Policy**, its outcome and the sponsorship of this research project by the Research Department, Government of Arunachal Pradesh should be acknowledged.
12. The **AITS, RGU** shall have to submit the progress report quarterly to the Nodal Department for further conveyance of the status of the project to the Government.
13. Any assets procured or purchased for implementation of the project must be returned to the Nodal Department on completion of the project.
14. The **AITS, RGU** has to maintain dual stock registers for reflection of procurement of stationery/ store items.



15. All the required Codal formalities are to be followed as per laid down norms as stipulated in the sanction order. No. RES(CUL) BUD-ANN-240/18 Dated 24<sup>th</sup> Dec' 2019.
16. All the required Codal formalities are to be observed for appointment of Research Associate, Research Assistants etc.
17. The evidential documents should be made available to the Nodal Department.
18. Expenditure statement/ bills along with original vouchers have to be submitted by the AITS, RGU to the Nodal Department.




