The Advisory Committee Meeting for NET / Remedial Coaching and Entry into service of SC/ST/OBC and Minority Community Students was held with the following coordinators of the committees and members:

1. Prof. Oken Leko, Coordinator, NET/Remedial Coaching.
2. Dr. N.T. Jose, Coordinator Entry into Service.
3. Prof. Sumpam Tangjang, DSW, Dept. of Botany (Member)
4. Prof. Jumyir Basar, President, RGUTA, AITS (Member)
5. Prof. Kiran Kumari, Dept. of Geography (Member)
6. Mr. Solung Sonam, President, RGUEA (Member)

Discussion was made on the following agenda:

- Position & status of coaching facility at present.
- Methods of examining the performance of candidates.
- Examining the data of the students attending coaching classes.
- If any suggestions by the members.

The members present in the meeting discussed various issues relating to the coaching programmes and participation of students. Prof. Oken Lego, the Co-ordinator of NET and Remedial Committee expressed his concern how he is not satisfied to give justice to the students while co-ordinating the two programmes under his supervision. His request to the Advisory Committee to convey his concern to the authority for appointing another coordinator stating the fact that both the programmes are independent and need separate coordinators, staff and office too to share at least half of his responsibility. The members understood the problems of conducting two coaching programme by one co-ordinator and to request the authority for suggested appointing another co-ordinator with a view to change the co-ordinators with the over of their tenures. Prof. Oken Lego explained that the methods of examining and performance of candidates are being done paperwise by the resource persons.

With regard to the programmes the members came to know that the Remedial classes are being conducted before the semester examinations and NET and Entry level into service are being conducted after the semester examinations. Realising taking this as the probable cause of the students for not expressing enough desire to attend the coaching classes the members unanimously suggested to adopt the following measures.

- (i) The NET and Remedial classes shall be conducted in online / blended mode during pandemic situation.



- (ii) All Department heads shall be requested to assist for the conducting the coaching classes on Saturdays.
- (iii) In spite of the provision to invite the resource persons from outside the campus, the faculty members of individual departments shall be the first priority to take the classes.
- (iv) Concerned HoDs shall be requested to propose the names of the teachers who will be resourceful for the coaching programmes separately.
- (v) The programme co-ordinator shall provide programme details to the Departments much in advance before the beginning of the programmes.
- (vi) Office tenure of the coordinator be defined.

In the matter of coaching for entry into service much could not be discussed due to some official engagement of Dr. N.T. Jose, the Coordinator of the programme. However, it was decided that he would be intimated to take necessary steps to conduct the classes in online mode during the pandemic situation.

The meeting was over with a vote of thanks to the chair.


