The meeting was convened to assess the conduct of awareness meeting and take note if any such incident has been reported or observed in the Halls of residence, departments or within university premises.


Since most of the faculties were busy in ongoing examination process being conducted in the departments none of the members were able to attend physically.

At the very outset, the Chairperson welcomed all the members and apprised them of the purpose of the committee being constituted and the broad guidelines/frame work of the committee for smooth and effective functioning.

In this context, the chairman along with the convener shared about the online meeting with Hon'ble Vice chancellor and the directives received from him for taking measures by the committee members, in case of any untoward happenings among the student fraternity in the Halls of Residences or in the departments.

After getting apprised, the members attended the meeting and had a formal discussion on various measures that should be adopted for ragging-free environment in the University

1. The members strongly felt that the following steps needed to be taken in all the halls of residence, for making students aware of Ragging, particularly the incidences that needs to be understood and delimited as falling under ragging activity.

Identifying types of ragging-

- a) Physical violence/hurting, punching, etc.
- b) Mental – bad words/calling names/slangs, any other way of hurting sentiments.

2. For this, the members agreed for the following

- a) Posters and drawings can be put up in the hostels, Students' Activity Centre for creating awareness about what is considered as Ragging, (Members felt that Fine Arts department can help in creating these posters and write-ups)
- b) Putting up boards explaining the process of punishment/consequences if anybody is found guilty of ragging.


- c) There should be issuing of circular periodically from the administration side to HoDs/Directors/Deans of faculties and Wardens of the respective Halls of Residences for creating and assessing the situation in context.
- d) A complain book should be kept in the department and P.A should periodically check it and give update to the committee.
- e) Matters/Materials related to Anti-ragging activities should be distributed in each Halls of residence and should be available to access for each boarder.

It was agreed that the committee members by turn and making small teams of two members would visit the Halls of Residence and would organise an awareness meeting along with the warden to apprise the students about the committee and its functioning. Further, it was decided that the First meeting will be in the month of April in the Women's and Men's Halls of Residences, Subansiri, Kameng, Pare, Yomogo and Dibang, Siang (women) Lohit, Tirap, Panyor, Tawangchu, Tissa, and Bichom (male)

It was agreed that the details of the awareness interactions would be assessed and discussed in the next formal meeting.

Further, members agreed to the suggestion of the Chairman and Convener that there would be review meeting on a monthly basis.

After interaction, the members felt that the following measures were needed for effective measures of the awareness about the Anti-ragging activities.


- a) Departmental counselling should be compulsorily organised at the beginning of every session (particularly new semester). This can be jointly done by the anti-ragging team members and department faculties.
- b) This would facilitate joint meetings of both boarders of Women's and Men's Halls of Residence.
- c) Drop box may be placed in each department as well as in the halls of residence for facilitating reporting any form of harassment faced by the students.
- d) Any complaint received should be brought to the notice of the committee and the members would examine the nature and gravity of the action.
- e) Suitable and appropriate action then would be suggested to the Complaint Authority for the implementation of the action as deemed fit.
- f) Suggestions were also sought for framing the form of complaint and implementing it.

(However, the matter was postponed for detailed deliberation as it was informed that this was already in practice in the form of declaration that every student has to give an undertaking of being complaisant to anti-ragging activities at the time of admission and is

also informed about being liable to punishments as per UGC norm in case of violation of the same.).

It was unanimously decided that a review meeting would be held in month of May



2. Sensitisation programme regarding anti-ragging will be done during the Orientation Programme in the new semester by the members of the Anti-Ragging Cell.
3. Anti-Ragging workshops, poster competitions, etc. may also be organised from time to time, especially when new admissions begin.


