The members noted the reports of the Deans' Committee and approved it with the following additions in terms and conditions a. RGUSU must refund the entire advance amounting to Rs. 5.71 lakh released in favour of RGUSU towards the conduct of the Football Tournament within 3 days from the date of issue of Notification. b. RGUSU must deposit Rs. 6.72 lakh to the Revenue Account of RGU within 7 days from the date of issue of notification as the recovery of losses incurred towards ICT equipment, furniture, decorative and expenses on medicine/treatment in respect of PSO who sustained the injury during vandalism (herein responsibilities lies on President and the General Secretary to identify and realize the amount from each member of RGUSU who were involved in vandalism). The entire amount must be refunded within 7 days from the date of issue of Notification by the Students' Union (herein responsibilities lie on the President and the General Secretary to identify and realize the amount from each member of RGUSU who was involved in vandalism). c. All the students who were involved in vandalism and presently staying in various Halls of residence must vacate their seat/hostel within one week time from the date of issue of Notification. d. Those students / executive members of RGUSU who were involved in vandalism shall not be allowed to get admission in any PG/UG/Diploma Courses in Rajiv Gandhi University in the future. However, they may be allowed to pursue Ph.D. Program fulfilling laid down criteria in the Ph.D program. e. The students involved in the vandalism will not be allowed to write/sit in the term-end terminal examinations without adherence to the above terms and conditions. It is submitted that the Statute 2(4) of the Statutes of the Rajiv Gandhi University Act, 2006 (No. 8 of 2007) reads that the Vice Chancellor shall hold office for a term of five years from the date on which he enters upon his office, or until he attains the age of sixty five years, whichever is earlier, and he shall not be eligible for reappointment.

The Executive Council may kindly consider amendment to the Statute 2(4) of the Statutes of the Rajiv Gandhi University Act, 2006 (No. 8 of 2007) for reappointment of the Vice Chancellor for another term of five years.

The members after threadbare discussion with relevant documents, letters, etc., and also keeping in view the provision available in other Central Universities unanimously resolved to approve the proposal for amendment on Statute 2(4) that the Vice Chancellor shall hold office for a term of five years from the date on which he enters upon his office, or until he attains the age of seventy years, whichever is earlier, and he shall be eligible for re-appointment. The Council further resolved to submit the proposed Amendments to the Ministry of Education for the assent of the Hon'ble Visitor in terms of Section 30(3) of the Rajiv Gandhi University Act, 2006.

which the organizations/associations have expressed their concerns on the resolutions adopted in the 50th meeting of the EC held on 10th April, 2023 viz. EC:50:03 and EC:50:12 and appealed for reviewing and reconsideration of the two resolutions.

After a brief discussion on the resolution no. EC:50:03, the council noted that, as mentioned in the provision of para 2 of the Schedule of the RGU Act 2006, the Vice-Chancellor shall be appointed by the Visitor of the University from a panel of not less than three persons who shall be recommended by a committee, of which two of them shall be nominated by EC as Members and one by the Visitor and the nominee of the Visitor shall be the Convenor of the Committee; provided that none of the members of the Committee shall be an employee of the University or a member of any authority of the University. The Council noted the letter, the then MHRD (now MoE) vide letter F. No. 19-12/2015-Desk (U) dated 12th March, 2015 that, in order to avoid this conflict of interest, it has been decided that the Vice Chancellor who is aspirant to be the Vice Chancellor, as may be the case, will recuse themselves and will not participate in the meeting of EC during the discussion of the agenda item wherein the nominees of Executive Council are to be selected for the Search Committee for appointment of Vice Chancellor.

Based on the above provision and in pursuance to a letter from Ministry of Education (vide letter F. No. 35-3/2023-Cl-I, dated 28.03.2023), the Council recommended the two outstanding persons as nominees of the EC in the Search Committee for appointment of new Vice Chancellor of Rajiv Gandhi University. Thus, it has been done within the purview of the Rajiv Gandhi University Act, 2006 (No. 8 of 2007). The nominees of the EC is being conveyed by the university to the MoE and UGC vide letter F. No. RGU/REG-105/MoE/21 dated 21st April, 2023. The Council noted the minutes of the 18th EC vide item no. EC 18: 30 where the same processes was adopted while nominating two persons of the Search Committee for the appointment of the new Vice Chancellor of this university.

Regarding EC:50:12, the EC after threadbare discussion noted that the partial amendment / modification of the Statute 2(4) of Rajiv Gandhi University Act, 2006 (No. 8 of 2007) regarding the enhancement of age of superannuation of teachers from 62 years to 65 years and Vice Chancellor from 65 years to 70 years has already been resolved and approved in the 20th meeting of the EC vide item No. EC 20:13 held on 25th April, 2018. The minutes of the 20th EC and the ATR were confirmed in the 21st Meeting of the EC vide item No. EC 21:01 and EC 21:02. However, the process of amendment to the Statute could not be completed as it requires assent of the Visitor, the President of the India and through publication of the Notification in the Gazette of India.

The same matter pertaining to Vice Chancellor was brought before the 50th EC under agenda item No. EC 50:12 held on 10th April, 2023. The EC deliberated on the proposal and resolved as follows;

"The members after threadbare discussion with relevant document, letters, etc., and also keeping in view the provision available in other Central Universities unanimously resolved to approve the proposal for amendment on Statute 2(4) that the Vice Chancellor shall hold office for a term of five years from the date on which he enters upon his office, or until he attains the age of seventy years, whichever is earlier, and he shall be eligible for re-appointment. The Council further resolved to submit the proposed Amendments to the Ministry of Education for the assent of the Hon'ble Visitor in terms of Section 30(3) of the Rajiv Gandhi University Act, 2006".
