

MEMORANDUM OF UNDERSTANDING

The **Adroit Digisoft Solutions Pvt. Ltd., House No. 110, Kharghuli Main Road, Guwahati - 781004, Assam** and **Rajiv Gandhi University (RGU), Rono Hills, Doimukh – 791112, Arunachal Pradesh** agree to work together on the effective cooperation and participation in the field of academics, training and research, and placement of students, with respect to the various programmes under regular and vocational studies. The two parties are interesting in working together for the following objectives and purpose:

1. Objectives

- a. To establish the basis for a cooperative institutional relationship to encourage and promote bilateral cooperation on academics and research in various regular and vocational fields on the basis of mutual benefit, equality, and reciprocity; and
- b. To provide directly or in collaboration for regular and vocational education including general, vocational, technological and professional academia and research; to participate in the discovery and transmission of knowledge, for development of academic infrastructure/ placement, for stimulation of intellectual and cultural life, and for development and diversification of livelihood.

2. Cooperation in the field of Vocational Studies and Research

- a. Within such fields as are mutually acceptable for the parties, the following forms of co-operation, amongst others, may be pursued hereunder:
 - i. Recognition of the regular and vocational degrees (Certificate, Diploma, Advanced Diploma, Post-Graduation Diploma, Bachelor's Degree, Post-Graduation etc.) of this university as an equivalent or as a special or desired qualification for general as well as specialised jobs.
 - ii. Partnership to develop curriculum for regular and vocational studies, academic infrastructure, joint teaching / training / internship activities and research projects on regular / vocational subjects of mutual interest through visits by and exchange of scholars, teachers and other staff / trainers / professionals for sharing of experiences and knowledge on agreed fields;
 - iii. Implementation of regular / vocational education and training programs or schemes in this university and provisions of training and placement of apprentices / interns of various regular / vocational studies related to fields of mutual interest;
 - iv. Organization of workshops, seminars, and working groups;
 - v. Exchange of academic materials, reports and publications;

- vi. Participate in career fairs, on-campus career orientations, and diversity outreach efforts, as appropriate, to support the aims of this mutually agreed purpose of the exchange; and
- vii. Other modalities as may be agreed upon by the Parties.


3. Terms of Agreement

- a. This Memorandum of Understanding will commence on the date of its signing by both Parties, and shall remain in force for an initial period of three years. Any amendment of and/or modification to the MoU will require the written approval from both Parties. The MoU shall renew itself automatically for successive periods of three years unless either of the Parties notifies the other party in writing of its desire to terminate it upon six months' notice to the other party. The termination of this MoU shall not affect the implementation of the projects or programmes established under it prior to such termination.
- b. This MoU does not constitute a legal or contractual obligation on the part of either party. It reflects an arrangement that is currently satisfactory to the parties involved. The parties agree to negotiate amendments to this memorandum as needed to meet the evolving requirements.




