This Memorandum of understanding (MoU) is drawn on the thirteenth day of August, 2019, among:

**the North Eastern Regional Institute of Science and Technology, Nirjuli**, (hereinafter referred to as **NERIST**), the First Party, represented by the Registrar, NERIST;

**AND**

**the National Institute of Technology, Arunachal Pradesh, Yupia**, (hereinafter referred to as **NIT-AP**), the Second Party, represented by the Registrar, NIT-AP;

**AND**

**the Rajiv Gandhi University, Doimukh**, (hereinafter referred to as **RGU**), the Third Party, represented by the Registrar, RGU.

NERIST, NIT-AP, and RGU are individually referred to as 'Party' and collectively as 'Parties.'

**WHEREAS:**

A. this MoU is the outcome of the report submitted by the Placement Review Committee 2019 formed by the Governor of Arunachal Pradesh involving the representatives of all the parties and the Government of Arunachal Pradesh.

**PART - I: VISION, MISSION AND OBJECTIVES**

**1.1 Vision**

To develop the institution (s) as a source of employable students with enlightened citizenship of a knowledge society through promotion of training, motivation suitable for placement in different sectors in India and abroad.

**1.2 Mission**

To serve as a beacon of change, through multi-disciplinary learning, for creation of knowledge students, by building a strong character and nurturing a value-based work ethics, promoting creative and critical thinking for holistic development and self-

sustenance for employability. The institution (s) seeks to achieve this objective by cultivating an environment of excellence in teaching, research and innovation in pure and applied areas of learning.

### 1.3 Objectives

The institution (s) shall endeavour through education, research, training and extension in promoting the students for recruitment and placement in different parts of the country and abroad and to promote and advance the people of the state of Arunachal Pradesh as hub of knowledge and human resources. Towards this end, it shall endeavor:

- 1.3.1 To make infrastructural provisions to conduct pool recruitment drives in the campus of each institution, as and when required;
- 1.3.2 To share the database of the students as and when asked for by the recruiters for joint on and off-campus recruitment drives;
- 1.3.3 To provide help and support among the three signatories, whenever required, to promote, educate and train manpower and skill development for the employability of students in India and abroad;

### PART 2: DEFINITIONS

The terms that are used in this MoU shall mean the following:

2.1 '**Parties**' means the institutes which have entered into an agreement of the provisions of this MoU.

2.2 '**Host institution**' means the institution that host the campus placement activities in its campus or in other places as it deemed fit.

2.3 '**Three Institutions**' means the institutions namely-Rajiv Gandhi University (RGU), Doimukh, North Eastern Regional Institute of Science and Technology (NERIST), Nirjuli, and National Institute of Technology (NIT) Arunachal Pradesh, Yupia.

2.4 '**Students**' mean the students from three institutions-RGU, Doimukh, NERIST, Nirjuli and NIT, Yupia, who have registered to avail the placement services in their respective institutions.

### 3. NOW THEREFORE THE PARTIES HERETO AGREE AS UNDER:

3.1. Each party will individually and uniformly re-nomenclate the existing 'Training and Placement Cell' as 'Placement Cell.'

3.2. Each party will appoint a Professor from its available pool to head the Placement Cells and s/he will be designated as In-charge, Placement Cell.

3.3. Each party will make budgetary provisions as required by the Placement Cells to conduct training and facilitate placement related activities.

3.4. For conducting pool recruitment drives, the host institute will share the database of eligible students who have opted for placement services among the three partner institutes with the visiting companies, depending on the latter's requirement.





3.5. A Placement Co-ordination Committee (PCC) involving the parties will be formed with a Point of Contact (PoC) to be nominated from each party to liaise with each other.

3.6. Whenever joint recruitment drives are conducted, each party will share the feedback received from the recruiters and devise individual or joint mechanisms such as training, workshops, finishing schools, etc. for the students to improve their employability.

3.7. In case of joint recruitment drives, the expenses pertaining to travel and logistics of the visiting recruiters will be shared suitably among all the parties.

3.8. Each party will conduct periodic training programmes on soft skills, personality development, mock interviews, mock online tests, and other activities for improving the employability skills of the students. Such information may be circulated among the three parties to maximize participation by the students.

3.9. Each party will share their available infrastructural, human, and learning resources from time to time for the overall benefit of the students.

3.10. The Professor in-charges of the Placement Cells of all three institutions will meet every month to discuss the activities of the Placement Cells of each institution and propose innovative measures to boost the placement index and institutional ranking prospects.

3.11. In case, any legal or public dispute arises during joint recruitment drives with regard to students, the same will be addressed by the respective party to which the student belongs.

3.12. The provisions of this MoU will not replace the existing placement rules followed currently by each institution depending on their unique requirements.

The Parties hereto have carefully gone through the contents of this Memorandum of Understanding (MoU) and have signed and put their seals on the aforesaid MoU and agreed to abide by the terms and conditions as laid down therein in totality as of the day and year written above.
