CONSULTING AGREEMENT

This CONSULTING AGREEMENT (the "Agreement") is made this 23rd day of June, 2022 (the "Effective Date"), by and between:

(1) Arunachal Olympic Association (in short AOA) the Sport apex body of the state with a vision to regulate for overall development of sports thereby to produce national & international standard of athletes, registered under societies registration Act 1860 ([As modified by the Societies Registration (Extension to Arunachal Pradesh) Act, 1978]) being registration No. SR/ITA/116 dated 9th January, 1978 having its principal place of office at Itanagar, PO/PS Itanagar-791111, Arunachal Pradesh hereinafter referred as the First party;

AND

(2) Rajiv Gandhi University, Rono Hills, Doimukh, PO/PS
Doimukh, District Papum Pare-791112, Arunachal Pradesh
(India) represented by Registrar, under the nodal
faculty of Physical Education & Sports Science, RGU,
having Specialised/Technical know-how for promotion

and development of sports (To be known as "Consultant") hereinafter referred as the 2nd party; and collectively, as applicable, as the "Parties."

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties hereto hereby agree as follows:

- (I) Nature of Relationship: Consultant shall represent or appoint representative of AOA and shall have the following duties and responsibilities:
 - a. To prepare a three years road map "Target on Podium" (TOP) at Olympic 2028 and beyond.
 - b. To collaborate in Internship of Sports Science students and Ph.D. scholars for training, exchange and attachment programmes for sports sciences personnel with the affiliated body of Arunachal Olympic Association.
 - c. To develop and promote the Olympic movement and amateur sports.
 - d. To promote and encourage the physical, moral, sports and cultural Education of the youth of the state for the development of character building, healthy and good citizenship.
 - e. To educate the public of the State as to the value of sport and it's important.
 - f. To act as the channel of communication between State Sports Associations and the Government of Arunachal for financial or other assistance to the Associations.
 - g. To promote and control directly or in co-operation with all the State Sports Associations, the Amateur Games and Sports under Olympic Programs in the state in accordance with the rules of the IOA, IOC, and concerned National Federations.

- h. To collaborate and help State Sports Association, District Olympic Associations and other Sports bodies in the training of the sports administrators for the effective dissemination of sports information in Arunachal.
- i. To lay down guidelines to enforce the Guidelines of World Anti-Doping Agency (WADA), National Anti Doping Agency (NADA) and to fight against the use of substance and procedures prohibited by the Olympic Committee or International International/ National Federations and thereby ensuring that the AOA's Anti-Doping policies and rules, membership and/or funding requirements and results, management procedures conform with the World Anti-Doping Code and respect all the rules responsibilities for the State Olympic Committee including conduct seminars of importance of Sports in overall development of individual/state etc, awareness program among the coaches, instructors and athletes. administrators on the topic of sports science, Sports nutrition, refresher course for coaches, physical education teachers, harmful effects of doping in time to time throughout the state in consultation with the AOA and NADA as may required.
- j. To carry out all other thing that may be necessary or expedient to promote the development of Amateur Sports and Games in the state and for the conduct of its business.
- k. To channelise for establish of Sports infrastructures and also to obtain lease from the State/Centre Govt/ PSU/ Sport Control Board/ private parties and run academy/academies aiming to produce excellent sports personalities as well as to liaise for raising funds from the legitimate resources or financial institution and to apply those funds for all round development of sports including acquisition, leasing, out sourcing or

construction of assets and to dispose of any such moveable or immovable properties in the best interest of the State sports development programs as the case may be.

- 1. Keeping in mind that Arunachal Pradesh being blessed with the high-altitude environment above from the sea level which can be the India's best high-altitude Centre that other Sports person form different part of India to come and train to build their sports performance and sports capacities as well as to attract the tourism potentialities. Hence, to explore such High-altitude centre thereto.
- m. To promote and market Olympic Games across the Arunachal Pradesh in particular and beyond.
- In consideration (II) Remuneration and Expenses: duties the above carrying out consultant responsibilities to the best of its abilities, the parties shall mutually discuss and agrees budget afterfree, prior and informed consent of the parties incase-to-case basis.
- (III) Term. This Agreement may be discontinued by either party upon one month's notice in writing.
- (IV) This Agreement shall be construed and interpreted according to the laws of the country and all disputes, controversies, or claims arising between parties under this Agreement shall be settled as per arbitration Act of 1940.
