## BOM: 42:03 Compliance of the directives shared with Open and Distance Learning (ODL) Institute of India by Distance Education Bureau, UGC through virtual Awareness Programme for smooth implementation of UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020.

Ms. Moyir Riba placed the presentation of UGC directives of the virtual Awareness Programme conducted on 01/09/2021. The board deliberated on the matter in depth and resolved as follows;

- Renaming of the Institute from Institute of Distance Education to "Centre for Distance and Online Education (CDOE)"
- The degree certificate will contain the photo of the candidate, Aadhar No., Father's Name and Date of Birth as per directives.
- On the backside of each of the degrees/certificates and mark sheets (for each semester certificate and at the end of the Programme): Mode of delivery, Date of admission, Date of Completion, Name and address of all LSCs (Only for ODL) and Name and address of all Examination centres will be displayed.
- Third Party Audit to be conducted by the firm already engaged for Rajiv Gandhi University. Further, the matter to be discussed with CEMCA for possibilities.
- Reorganization of CIQA as per norms.
- PPR of all courses to be revised immediately.
- Development of online complaint handline mechanism through the parties engaged in the Online Admission/Online Examination.
- Mandatory Disclosure certificate to be issued at the earliest.
