AC:18:01 To confirm the minutes of the 17th meeting of Academic Council held on 14th October, 2016.
The Minutes of the 17th AC were circulated amongst the members and the AC noted that no comments have been received.
The AC confirmed the minutes of the 17th AC meeting held on 14th October 2017.

AC:18:02 To confirm the Action Taken Report (ATR) on the decision of the 17th meeting of Academic Council held on 14th October, 2016.
The AC accepted the Action Taken Report on the decisions of the 17th AC meeting held on 14.10.2017.

AC:18:03 To approve the Academic Calendar of the University for the Session 2017-18.
The AC noted that a five member committee under the chairmanship of Prof. Tasi Kaye, DSW and HoD Department of Commerce was constituted for preparation of the Academic calendar for the session 2017-18. The Academic Calendar prepared by the Committee was placed to the AC.

The AC perused and approved the same.

AC:18:04A To consider revised fee structure for various courses of Rajiv Gandhi University.
The AC noted that a three-member Fee Revision Committee was constituted under the Chairmanship of Prof. Otem Padang for the revision of various fee structures that are to be introduced from the Academic Session 2017-18. The revised fee structure for various courses prepared by the Committee was placed to AC for deliberation.

The AC perused and approved the revised syllabi prepared by various BUGS and BPGS.

AC:18:13 Conversion of APGDDM regular programme to a Minor Research Cell/Centre for MPhil leading to PhD along annual training programme.

The AC noted that a representation with comments from faculty members of the Department of Geography has been received from Prof. N. Kar, Coordinator, APGDDM (Advanced post graduate diploma in disaster management) with the proposal to discontinue the existing APGDDM regular programme and convert it to a minor research cell/centre with intake of 2 PhD and 5 MPhil students to cover the area of Disaster management. The reason so specified for such a conversion is on the consideration that average drop out of nearly 40% in the previous batches because of various reasons.

The AC discussed the matter and endorsed that the Centre shall be known as 'Centre for Disaster Management'. It was further decided that a 5-Member committee shall be constituted to work out its Plan perspective and submit the report within a period of two months.

AC:18:14 To consider the implementation of the scheme for HAG Scale among existing Professors in RGU.

The AC noted that as per letter received from UGC, New Delhi vide No.F. No.16-50/2016 (CU), dated 9th September, 2016, mentioning that as per clause 6.4.10 of the UGC regulation 2010, 10% of the positions of the Professors in a University with a minimum of 10 years of teaching and research experience as Professor may be eligible for promotion in the higher grade. In this letter it is also mentioned that some conditions are to be fulfilled by the Professors for such promotion. Accordingly one committee was constituted by the University authority to prepare a guideline for implementation the scheme for HAG scale among existing Professors.

The Committee has prepared the guideline for promotion of University Professors (from stage-5 to stage-6) under career Advancement Scheme (CAS) in RGU (based on UGC regulation 2010), which was placed to the AC.

The AC perused the report of the committee and approved the proposal in principle.



AC:18:15 To consider the Common Admission Test (RGUCET-2017) for various courses in RGU

The AC noted that a three-member committee under the Chairmanship of Prof. Tomo Riba submitted the modalities for conducting of a common entrance test for all the PG courses, Interdisciplinary & professional courses, M.Phil and Ph.D courses, which was placed to the AC.

The AC discussed the matter threadbare and approved the proposal in principle. The Council decided that all the respective departments/institutes of the University shall work out mechanisms basing on the broad guidelines prepared by the committee and introduce the Test from the next academic session 2017-18. However, PhD and M.Phil programmes shall not come under the purview of RGUCET.

AC:18:16 To consider for approval of Academic Calendar for the year 2017-18 of B.Sc Nursing Course duly prepared and submitted by Principal, North East Nursing College of Health Science, Itanagar.

The AC noted that academic calendar for the year 2017-18 of B.Sc Nursing Course prepared and submitted by Principal, North East Nursing College of Health Science, Itanagar was placed to the AC.

The AC perused and approved the Academic Calendar for the year 2017-18 of B.Sc Nursing Course of North East Nursing College of Health Science, Itanagar.

The AC noted that an inspection committee was formed under the chairmanship of Prof. H.K. Sharma Dean, Faculty of Languages to conduct physical verification covering all requirements as per UGC (affiliation of College's by University) Regulation in connection with introduction of BA (conventional) course from the session 2017-18 at MTM (Mudo Tamo memorial) College, Ziro, Arunachal Pradesh. The AC noted that an inspection committee was formed under the chairmanship of Prof. J. Sahoo, Dean, Faculty of Education to conduct physical verification covering all requirements as per UGC (affiliation of College's by University) Regulation in connection with introduction of BA (conventional) course from the session 2017-18 at Denning College of Teacher Education, Tezu, Arunachal Pradesh. The report of the inspection committee was placed to the AC.

Sahoo, Dean, Faculty of Education to conduct physical verification covering all requirements as per UGC (affiliation of College's by University) Regulation in connection with introduction of B.A (conventional) course from the session 2017-18 at Donyi Polo B.Ed College, Itanagar, Arunachal Pradesh. The report of the inspection committee was placed to the AC.

The AC perused and approved the introduction of B.A. (Conventional) Course at Donyi Polo B.Ed College, Itanagar from the academic session 2017-18 subject to fulfilment of observations of the inspection committee before starting B.A programme, failing which the permission shall be withdrawn.

The AC noted that an inspection committee was formed under the chairmanship of Prof. S.K. Singh Dean, Faculty of Social Sciences to conduct physical verification covering all requirements as per UGC (affiliation of College's by University) Regulation in connection with introduction of BA (conventional) course from the session 2017-18 at Kasturba Gandhi Institute of Higher Education (B.Ed) college, Roing, Arunachal Pradesh. The report of the inspection committee was placed to the AC.

The AC perused and approved the introduction of B.A. (Conventional) Course at Kasturba Gandhi Institute of Higher Education (B.Ed) college, Roing from the academic session 2017-18 subject to fulfilment of observations of the inspection committee like procurement of Books, faculty appointment, etc. before starting the B.A programme, failing which the permission shall be withdrawn.

AC:18:26 Permission to introduce B.A in Sociology subject from the session 2017-18, at Mahabodhi Lord Buddha College, Namsai

The AC noted that a screening committee was formed under the chairmanship of Prof. S.K. Singh to scrutinize the application along with relevant documents submitted by the principal of Mahabodhi Lord Buddha College, for introducing BA in Sociology subject in the said college from academic session 2017-18. Subsequently an inspection committee under the Chairmanship Prof. J. Sahoo inspected the college. The reports of the screening and inspection committee were placed to the AC.

The AC perused and approved the introduction B.A in Sociology *subject* at Mahabodhi Lord Buddha College, Namsai from the academic session 2017-18 subject to fulfilment of all requirements as observed by the inspection committee.

AC:18:27 Permission to introduce B.Ed course from the current session 2017-18, at Mahabodhi Lord Buddha College, Namsai

The AC noted that a screening committee was formed under the chairmanship of Prof. J. Sahoo, Dean Faculty of Education to scrutinize the relevant documents in connection with introduction of B.Ed course from the current session 2017-18 at Mahabodhi Lord Buddha College, Namsai, Arunachal Pradesh. Subsequently an inspection committee under the Chairmanship Prof. J. Sahoo inspected the college and submitted the report. The reports of the screening and inspection committee were placed to the AC.

The AC perused and approved the introduction of B.Ed. course at Mahabodhi Lord Buddha College, Namsai from the academic session 2017-18 as per the recognition granted by the NCTE, Bhubhaneshwar, subject to fulfilment of all other requirements as observed by the inspection committee.

AC:18:28 Permission to start a new science College in the name and style of Galaxy Science College, Nirjuli, Arunachal Pradesh from the session 2017-18.

The AC noted that a three-member screening committee under the Chairpersonship of Prof. J. Chakraborty, Dean, Faculty of Life Sciences was constituted to scrutinize the application along with relevant documents which was submitted by the Director, New Galaxy Science College, Nirjuli.

The screening committee accordingly verified the application on 31st March 2017 and submitted the report and the same screening committee was entrusted for physical verification of the college. The physical verification committee visited the college on 18th April 2017 and submitted the report. The reports of the screening and inspection committee were placed to the AC.

The AC after a threadbare discussion decided not to grant affiliation and communicate to the Director of New Galaxy Science College, Nirjuli that they have not fulfilled the basic requirements as observed by the inspection committee pertaining to possession of requisite area of land prescribed by UGC.

AC:18:29 To consider the affiliation of Tomo Riba Institute of Health & Medical Sciences, Naharlagun.

The AC noted that an inspection committee was constituted under the Chairmanship of Prof. Utpal Bhattacharjee, Dean, Faculty of Basic Science & Information Technology and five other members to inspect/conduct physical verification covering all requirements as per UGC (affiliation of College's by University) Regulation in connection with grant of Temporary affiliation to a new Government Medical College, namely, Tomo Riba Institute of Health & Medical Sciences (TRIHMS), Naharlagun. The inspection report was placed to the AC.

The AC approved the issuance of Consent Letter in line of the requirement of the Medical Council of India for subsequent grant of Temporary Affiliation, however with the condition that the Institute authority obtain recognition of the Medical Council of India (MCI) first. A letter of consent shall be issued with a remark to the Institute Authority to expedite obtaining the recognition of MCI, New Delhi.



AC:18:30 To ratify the action taken by the University authority to approve the academic calendar for the year 2016-17 session for North East Homoeopathic Medical College, Itanagar.

The AC noted that the Principal of the North East Homoeopathic Medical College, Itanagar submitted the academic calendar for the year 2016-17 which was administratively approved.

The AC ratified the action taken by the University authority.

AC:18:31 To ratify the MoUs signed with various Institutes:

- 1) MoU signed between Department of Management with Indian Institute of Entrepreneurship (IEE), Guwahati on the 27th of February, 2017.
- 2) MoU signed between NSS Unit RGU with National Council for Rural Institutes (NCRI), Hyderabad on the 3rd of February, 2017.
- 3) MoU signed between Department of Commerce with Institute of Company Secretaries of India (ICSI), Guwahati on the 15th of December, 2016.

The AC ratified the action taken by the University authority.

AC:18:32 Agenda items from Examination Branch:

A Discontinuation of special and supplementary examination at both UG and PG level

The AC noted that the conduct of special and supplementary examination within a period of one month from the date of declaration of examination result (May and December) at both UG and PG level is difficult to be managed by the examination branch. Within a period of one month there is a need to appoint paper setters for setting up of the question papers of PG and UG, collect the question papers, moderate the question papers, send them to the press for printing, conduct the examinations, evaluate the answer scripts and then declare the results. Practically, it is very much difficult to complete the whole process within the short period of time. Special and supplementary examinations have also affected the conduct of regular semester examination held during the month of May and December including the examination of Distance Education and Law Course. Further, there is no such provision of special and supplementary Exam in the neighbouring university especially at UG level.

Therefore it was proposed to discontinue the special and supplementary Examination. The exam of "No More chance" for which there is need to conduct special exam, shall be conducted with regular examination in the month of May and December.

The AC decided that a 3-Member committee shall be constituted to examine the problem and the committee shall submit its report within a month.

B Soft copy of the Ph.D Thesis and Report

The AC noted that as per examination ordinance, the exam branch is required to send the hard copy of the thesis for evaluation. This is not so convenient in case of examiner who is from the foreign countries. The process of sending of thesis by post and collect the report by post is time consuming in nature. Some time such examiner is refuse to accept hard copy of Ph.D. thesis. Therefore it is proposed that in case of engagement of examiner from foreign countries, the examination branch may be allowed to send the soft copy of the thesis and also to accept the soft copy of the report.

The AC approved the same only for foreign or overseas examiners.

C Declaration of UG result on time

The AC noted that for smooth functioning of Examination Branch and declaration of results in time, there is a proposal that number of central evaluation centre (UG) may be increased. Presently, there is four number of evaluation centres. It was also proposed that college should directly submit the answer script to the respective evaluation centre instead of sending the same directly to the university. The record of such answer script should also be sent to the examination branch by the college. The central evaluation centre shall do the needful to evaluate the answer scripts and send the mark to the examination branch for preparation of results.

The AC approved the proposal to increase the number of Evaluation Centres and decided to continue with the existing system.

D Abolition of three chances to clear the back paper

The AC noted that as per present system, three chances are given to the students to clear their back paper(s). If he or she cannot clear the back paper(s) by availing three chances then he/she is out of the system. Therefore it was proposed that without considering three chances to clear the back paper(s), students may be promoted continuously to the higher semesters. However, he/she has to complete the degree/qualify in all papers of the course within the tenure as prescribed in the Examination ordinance of the university.

The AC deliberated on it and decided to constitute a three Member committee to examine the matter. The Committee shall submit its report within a period of 3 months.

E Enhancement of Remuneration

The AC noted that the existing rate of remuneration for the examination work has been fixed in the year 2008. Therefore, there is a need to enhance the rate of remuneration for the examination works and accordingly it was proposed as under:

Paper setting:

Existing rate	Proposed rate
PG Rs. 350/-	Rs. 500/-
UG Rs. 300/-	Rs. 400/-

Paper evaluation:

PG	Rs. 15/-	Rs. 20/-
UG	Rs. 12/-	Rs. 15/-

The AC approved the proposed hike in remuneration for the Examination related work as shown above. However, the said hike shall be effective from the Academic session 2017-18 after being routed through the Finance Committee in its next meeting.

F Conducting Supplementary Examination for BSc Programme

The AC noted that the students of B.Sc VI semester have requested the Authority to conduct the Supplementary/Special examinations for those students who have back paper in III and V semesters. Those who have back paper cannot clear their examinations after passing VI semester.

The members deliberated on it and did not approve the proposal.



G. Disposal of used Answer Scripts

The AC noted that presently the used/old answer scripts are disposed off after every two (2) academic years following all codal formalities. It is found in many Universities that such scripts are disposed after alternate semester examinations i.e. after 6 (six) months to 1 (one) year period. Moreover, as there is considerable constraint of space, non-disclosure of answer scripts to RTI applicant(s), discontinuation of re-evaluation system under semester mode further justifies the disposal of used answer scripts within six months.

The AC decided to continue with the existing system.

AC:18:33 Any other item:

A Provision for Inter-Disciplinary Research

The AC noted that a representation has been received from Prof. Jayadev Sahoo, Dean, Faculty of Education wherein he has proposed for introducing inter-disciplinary research at PhD programme. He has put an argument that many genuine professionals with expertise are deprived of availing research opportunities in our University. He also argued that this lead to deprivation of induced knowledge creation. Therefore, he has personally suggested for creation of scope for allowing genuine professionals for admission into likely faculty for pursuing PhD under interested supervisors. He has suggested for considering 5(five) member board to be set up for considering the proposals. This according to him would safe guard the mandate of UGC.

The AC deliberated on the matter and did not approve the proposal.

B To approve the Renewal of Temporary Affiliation to Mahabodhi Lord Buddha College, Namsai.

The AC noted that an inspection committee was constituted under the Chairmanship of Prof. A.K. Das, Director, CDC to conduct physical verification of Mahabodhi Lord Buddha College, Namsai for granting renewal of Temporary Affiliation. The report of the committee was placed to the AC.

The AC approved the renewal of Temporary Affiliation to Mahabodhi Lord Buddha College, Namsai effectively for a period of one year.

C To approve the Renewal of Temporary affiliation to Denning College of Teacher Education, Tezu, Arunachal Pradesh.

The AC noted that an inspection committee was formed under the chairmanship of Prof. J. Sahoo, Dean, Faculty of Education to conduct physical verification for granting renewal of temporary affiliation to Denning College of Teacher Education Tezu, Arunachal Pradesh. The report of the committee was placed to the AC.

The AC approved the renewal of Temporary Affiliation to Denning College of Teacher Education, Tezu effectively for a period of one year.

D To approve the renewal of Temporary Affiliation to Siang Royal Academy, Pasighat, Arunachal Pradesh.

The AC noted that an inspection committee was formed under the chairmanship of Prof. J. Sahoo, Dean, Faculty of Education to conduct physical verification for granting renewal of Temporary Affiliation to Siang Royal Academy, Pasighat, Arunachal Pradesh. The report of the committee was placed to the AC.

The AC approved the renewal of Temporary Affiliation to Siang Royal Academy, Pasighat effectively for a period of one year.

E On the School Internship Programme for 2 year B.Ed. Course

The AC noted that as a special case, the B.Ed Internship programme for the 4th Semester trainees in the current academic session 2016-17 has been reduced to 2 months. It was decided that affiliated B.Ed colleges(s) should complete the internship programme on or before July 31, 2017.

F To discuss on the issuance of Govt. of India Gazette notification regarding 5% bench mark for disabilities in admission to Higher Educational Institutions.

The AC perused and approved the adoption of the Govt. of India Gazette notification related to 5% bench mark for disabilities in admission to Higher Educational Institutions. It also felt that it should be reflected in the University Prospectus.

G On furnishing of Annual Reports and AQARs by the various Departments of RGU.

The Chairman of the Academic Council and Vice-Chancellor of the University requested all the Heads and Directors to expedite submitting the filled-in AQARs to the Directorate of IQAC to facilitate compilation and completion of the Annual Reports of the University.

As there was no other item for discussion, the AC meeting came to an end with Vote of Thanks from the Registrar, the Ex-Officio-Secretary of the Academic Council.

The said committee under the chairmanship of Prof. Nishamani Kar, Dept. of Geography had visited the College on 10th June, 2019 and found that the college fulfills all the basic criteria. The committee has recommended the grant of Permanent Affiliation to the College by RGU from the coming academic session (2020-21). The report of the committee was placed for perusal by the AC.

It offers BA course in the subjects like English, History, Hindi, Political Science, Economics & Education. The total enrolment of the college in the current academic session is 197 students, with a in-charge Principal and 13 faculty members besides 4 administrative staff including a Librarian.

As per norms, the RGU authority had constituted a Screening Committee and subsequently on recommendation of the Screening Committee an Inspection Committee for physical verification was formed. The said committee under the chairmanship of Prof. Oken Logo, Head, Dept. of Hindi had visited the College on 2nd May, 2019 and found that the college fulfils all the basic criteria to run classes. The committee has furnished some observations and areas of attentions and further remarked that the infrastructure available in the college is not upto the mark. The report of the committee was placed for perusal by the AC.

The Council perused and did not approve the proposal for Permanent Affiliation and instead approved for the grant of renewal of Temporary Affiliation for the session 2019-20.

To grant Permission to start MA/MSc. in Geography and MA in Political Science Programme at St. Claret College, Ziro, Lower Subansiri district, Arunachal Pradesh from the coming academic session 2019-20.

The AC noted that the proposal submitted by the Principal of St. Claret College, Ziro, Lower Subansiri district for the introduction of PG courses in their college from the academic session 2019-20 was screened by a Screening committee under the chairmanship of Prof. Nabam Nakha Hina and then was physically inspected by a three member Inspection committee under the Chairmanship of Prof. Nani Bath, Dept. of Pol. The college presently has 4 qualified teachers in Geography and 3 in Political Science having requisite qualification to teach undergraduate and postgraduate students. The college was asked to recruit more faculties for the said PG courses at the earliest. At least 2 in Geography and 3 more for Political Science Department. The college was also advised to procure more books exclusively for PG programmes at the earliest. The college so far has 443 and 541 books exclusively for Pol. Sc.

& Geography subjects respectively. The college has adequate laboratory facility for Geography.

RGU has so far allowed PG courses to be run in JNC, Pasighat, HCTE, Naharlagun and at ALA, Naharlagun. JNC is offering MA in History, Hindi and MA/MSc. in Geography, while HCTE and ALA are offering M.Ed. and LLM programmes respectively.

The committee has recommended for the introduction of MA/MSc. in Geography and MA in Political Science programmes from the session 2019-20.

The report of the inspection committee which was submitted on 15th June, 2019 was placed for perusal by AC.

The AC perused and deferred the item. The Council further resolved to constitute a committee to look into such matters.

The AC noted that, the matter was discussed in the 23rd meeting of the AC held on 14th March, 2019, vide item No. AC:23:25 under "Any other item" section at Sl. No. (iv), wherein the AC felt

that it should come to Academic Council through the BOS, Sociology.

The Board of Study (BOS) in Sociology had after going through the merit and also highlighting the ground realities had suggested exclusion of MA Sociology programme from the list of interdisciplinary subjects for admission purpose.

The BOS also suggested that, BA Sociology with 45% marks in Honours/Major or 50% marks in Pass Course in the concerned subject should be kept as the eligibility criterion for admissions to MA Sociology in RGU. The minutes of the BoS and its recommendations was placed for perusal by AC.

The Academic Council perused and approved the proposal and it shall be implemented from the next Academic Session 2020-21.

Reporting Items:

(i) Implementation of 6 month Core Module Syllabus for Environmental Studies for Under Graduate course prescribed by UGC.

The AC noted that, RGU has implemented this module after getting it approved in the Academic Council's 14th meeting held on 27 April, 2015 vide item No. AC: 14:09, following a positive report by a five member committee under the chairmanship of Prof. Tomo Riba, the then Dean, Faculty of Environmental Science which was formed to study the module prescribed by UGC on environmental studies (EVS) for undergraduate and also to explore the possibility to introduce the same in RGU. The same is offered as a mandatory paper in all the UG programmes being run in RGU such as BUA, BSc (Geology), BFA & BMUS. The UGC endorsed Syllabus was placed for perusal by the AC.

The AC perused and noted the same.

AGENDA ITEMS FROM EXAMINATION BRANCH

1. Discontinuation of supplementary examination for UG and PG.

The AC noted that Supplementary Examination was introduced in the year 2015-16 academic session after a special request by the students and to enable end semester students (i.e. 5th Semester for UG and 3rd Semester for PG) to clear their backlogs before the end semester i.e. 6th and 4th of UG and PG respectively. Further, the AC noted that this was introduced with the view that if a student fails the paper in 3rd semester of PG and 5th Semester of UG the same student has to wait for almost a year to clear the back paper in the respective semester examination even he or she has passed the 6th Semester.

Now, this supplementary system is hampering the smooth conduct of examination especially arrangement of Question Papers, moderation and evaluation as it is done in the middle of the academic session. It disturbs the routine academic classes of the college as many reports have come from the colleges regarding the inconvenience caused by the supplementary examinations.

The University Ordinance provides a provision for the students to clear the backlog papers through re-check and appearing back paper examination in the respective semester. In many universities the supplementary system of examination is no longer practised except for few professional courses like Homeopathic as per its own national council.

Therefore, it is proposed to discontinue the supplementary examinations to avoid duplicities and inconvenience caused by it.

The AC discussed the matter and decided to follow rules and regulations envisaged in the RGU Examination Ordinance and NCTE, AICTE, BCI, MCI, HCI & INC, as the case may be.

2. Double course/degree in one academic session.

The AC noted that many students who have back papers in the final semesters of a PG course apply for admission in B.Ed. which is against the university rules as no candidate can pursue two degrees at a same time in an academic year. While preparing the date sheet many students approach the Office of CoE informing that the dates of two examinations (back paper of PG and B.Ed. is colliding). As per rule a student with back paper is still considered as incomplete and hence technically he or she cannot take admission in B.Ed without passing out of PG courses in back papers. Therefore, such students should not be allowed to take admission without completing the back papers.

The AC perused and approved the proposal. The Council also felt pursuing two degrees in an academic year is illegal and hence it was decided that students should not be allowed to take admission without completing back paper(s).

3. RGUMPET – Paper-I

The AC noted that RGUMPET is basically a research oriented test to determine the students' knowledge of the subject and research aptitude. Therefore, this entrance test mainly focuses on research aptitude and subject concern. The Paper-I which is objective type in nature has less significance that may not completely judge the ability of students for research as there are many questions of general knowledge nature which has no relevance for research work.

As per 2016 M.Phil. and Ph.D. regulation, entrance test is qualifying in nature and more weightage is given to personal interview/interaction.

Therefore, it is proposed that Paper-I of RGUMPET may be discontinued. In place of this a descriptive type question with a section wherein a candidate may write an essay on concern area consisting of 25 marks and interview may be conducted for all those who qualify.

The AC perused and resolved to constitute a committee to look into the matter threadbare.

4. Teacher's Seat and M.Phil. exemption for Ph.D.

The AC noted that at present RGUMPET there is no seat allocation or option to select Teachers through open/quota mode is mentioned. Those eligible faculties should have a seat allocation in respective department.

Further, for getting an exemption from Entrance test M.Phil. Scholars should have passed and possess M.Phil. Marksheet/certificate or their final result declared before applying for RGUMPET.

Those scholars whose results are awaited and not declared before last date of submission of application for RGUMPET shall not be eligible for exemption. Such scholar has to compete through open category.

The AC perused and deferred the proposal for seat allocation to teachers in Ph.D.

Further, it was resolved that:

- a) M.Phil scholar whose results are being awaited shall be allowed for this year only for admission to Ph.D. as per the provisions and prevalent practices. From next year 31st of March will be fixed as the last date of submission of M.Phil dissertation. This may be circulated to all the Departments, and
- b) A committee will be constituted to look into the matter in detail.



5. Retention of Practical fee by Colleges:

The AC noted that as per normal practice all colleges submit the exam fee alongwith Practical fee. All colleges have requested to allow the college to retain all Practical fee as practical exam/test is conducted in college and finds difficulties to meet up the expenditure related to practical exam. i.e. TA/DA, remuneration and other related issues.

The AC perused and resolved to continue the existing practice for now.

6. Issue of Degree Certificate in Colleges.

The AC noted that the University issues degree certificate to all candidates who have qualified the exam and admitted/conferred during convocation. Many students come from distant places to collect the certificate after convocation from RGU office

Therefore, to minimise the trouble faced by students while coming from far distance to collect certificate, it is proposed to issue certificates to student in their respective colleges. Any fee, if not paid, can be remitted in University Account through RTGS. A copy of which may be retained in colleges and could be submitted to RGU with all detail in a consolidated manner.

The AC perused and did not approve the proposal.

Any other item, with the permission of the Chair.

1. Agenda items proposed by Dean, Faculty of Social Science:

(i) Proposal to Downsize the existing posts of Dean:

The AC noted that, Prof. Tana Showren, Dean, Faculty of Social Science, is of the opinion that there may be downsizing of the existing 7 posts of Dean to actual proportion, i.e. 3 posts.

The AC discussed the matter and did not approve the proposal.

(ii) To maintain the establishment of chronological order in listing the name of the Departments in all official correspondences:

The AC noted that there is a suggestion for maintaining chronological order in listing the name of the Departments in all official correspondences as per the date of establishment of Departments.

The AC discussed the matter and approved the proposal to be introduced from the session 2019-20 only for convocation purpose.

2. Agenda Items proposed from the Department of Sociology:

(i) Proposal for Smart Class: The department has endorsed the use of ICTs in higher education system on the line of UGC initiatives and suggested that setting up of Smart Classes be there in RGU's departments.

The AC perused and approved the setting up of multimedia system and screen/board in the Department as provided to other departments.



(ii) Eligibility for admission to Post Graduate Diploma in Environmental Sanitation (PGDES): The BPGS (Sociology) has proposed it to be "Graduate In Social Science subjects with 50% marks from a recognized University".

The AC perused and approved that the programme will be run in self-financing mode.

(iii) For additional Posts of Teachers for running Post Graduate Diploma in Environmental Sanitation (PGDES): The Dept. is of the opinion that there should be appointment of three more teachers (Assistant Professors) to smoothly run the said course.

The AC perused and approved the proposal.

3. To ratify the approval and issuance of new format for Annual Performance Appraisal Report (APAR):

The AC noted that recently the University authority has approved the UGC new format for Annual Performance Appraisal Report (APAR) prepared by the University IQAC, to be filled by the faculty members of the University. The same has been administratively issued and posted on University website also. The Notice and the copy of format issued in this regard were placed to AC for perusal.

The AC ratified the action taken by the University.

4. To discuss on the withdrawal of NCTE recognition to DECTE, Pasighat:

Rk
The AC noted that the Director, CDE-RGU has brought to the notice of the authority that, the NCTE has recently withdrawn the recognition granted to Daying Ering College of Teacher Education, Pasighat w.e.f. the academic session 2019-20 vide its letter No. ER-271.1.23/(APE00564)/B.Ed/2019/60510 dated 21.5.2019 for not adhering to the observations and conditions of NCTE. The letter of NCTE addressed to the Registrar, RGU intimating the same was placed to AC.

The AC discussed the matter and resolved that RGU as an affiliating University will stand with the NCTE decision. The AC decided that affiliation granted to the college shall remain suspended till the matter is resolved. Necessary official proceedings shall be taken up with the College at the earliest in this regard.

5. Case of forgery of Chairman's signature in a Selection Board Meeting minutes:

Rk
The AC noted that the Director, CDC-RGU has brought to the notice of the university authority that, there has been a serious case of forgery of a University Teacher's signature on a Selection Board meeting minutes. This has been noticed during the screening of documents in file of Teachers Training College, also recently for their application for grant of Permanent Affiliation.

The committee in the report for the same has remarked that, "In the course of vetting the documents, in file, the committee found that there was a forgery of signature of the Chairman of the Selection Board in the meeting minutes. The meeting was held on 18th July 2012. This has been taken very seriously, and the committee suggested that an enquiry should be initiated administratively".

The report and letter from Director CDC was placed to AC.



The AC perused and decided, as under:

- (i) Administrative action should be taken in this matter, and
- (ii) A high level enquiry shall be initiated to fix the issue

6.

To peruse the minutes of the meeting of I-STEM Portal Committee:

The Chairman of the I-STEM Portal committee has submitted a meeting minutes recommending three proposals related to it, which was placed to the AC.

The AC discussed the item and explained about the purpose of the I-STEM scheme, i.e. optimal utilization of facilities. The AC felt that the researchers should make use of the Govt. funded equipments in their respective institutions for carrying out their research/hands on training. The AC endorsed the uploading of Scientific Research Equipments details in I-STEM portal and issue of formats to all the Science departments. The AC was informed that, prescribed format is available on the portal and concerned departments could be able to download it.

To consider granting permission to introduce BA-BEd. & BSc.-BEd. 4 years integrated courses from the session 2019-20 at (i) Donyi-Polo B.Ed College, Itanagar, (ii) Mudo Tamo Memorial B.Ed College, Ziro and (iii) Denning College of Teacher Education, Tezu, Lohit District, Arunachal Pradesh.

The Academic Council noted that earlier the request of Donyi-Polo B Ed College, Itanagar to offer BA-BEd. 4 years integrated course was approved by AC in its 19th meeting held on 12th Oct., 2017 vide resolution No. AC:19:22. Subsequently, a similar request from Mudo Tamo Memorial B.Ed College, Ziro, Arunachal Pradesh was placed during the 20th meeting of the AC held on 27th Feb., 2018 vide Item No. AC:20:14 in connection with granting of permission for introducing BA-BEd. & BSc.-BEd. 4 years integrated course after proper physical inspection by RGU's inspection team following approval from NCTE to the college to run the course. The AC however, after a threadbare discussion decided that the approval already given to Donyi-Polo B.Ed. College, Itanagar to start 4 years integrated BA-B.Ed course from the Academic Session 2018-19 shall be kept in abeyance till the modalities are worked out by the University. And it also decided that the proposal to introduce BA-B.Ed & B.Sc-BEd. 4 years integrated course from the session 2018-19 at Mudo Tamo Memorial B.Ed College, Ziro shall also be kept in abeyance and the same may be communicated to the Principals of the concerned colleges. The AC also advised that, a workshop should be held on 9th March, 2018 and the Principals of both the colleges should be invited to attend the workshop. The said workshop was successfully conducted by the Dept. of Education accordingly. Subsequently, in the same line, the request of Denning College of Teacher Education, Tezu, Lohit District, Arunachal Pradesh was placed during the 21st meeting of the Academic Council (Special) held on 13th June, 2018 vide item No. AC:21:26. The copies of the minutes of the 19th, 20th and 21st meetings of the AC held on 12th Oct., 2017, 27th Feb., 2018 & 13th June, 2018 respectively were placed to the AC for perusal.

Further, the AC noted that, basically, the permission to introduce BA-B.Ed and BSc.-B.Ed 4 year Integrated courses at these affiliated Teacher Education colleges were not granted by the Academic Council for the want of proper syllabuses, although they got the approval from the recognizing body i.e. NCTE to start the courses.

Mudra

The AC further noted that recently the Broad Based Syllabus Committee and Special BPGS constituted as per the directives of the Academic Council have conducted their meetings and the syllabuses were prepared. The syllabuses were tabled as an agenda item at AC:24:08 above. And, thus, it was proposed that the said colleges may be granted the permission to run the courses from the academic session 2019-20.

The AC perused the proposal for granting permission to introduce BA-BEd. & BSc.-BEd. 4 year integrated course from the session 2019-20 to the aforesaid, affiliated colleges, and resolved that;

- i) All the aforementioned colleges shall be granted permission to introduce BA-B.Ed. 4-year integrated course for one year only at the first instance.
- ii) University shall send Inspection Teams to these colleges at the earliest to take stock of the facilities and other requirements including the appointment of sufficient teachers and shall explore feasibility to introduce 4-year integrated BA-B.Ed. & BSc.-B.Ed. programme in the said colleges.
- iii) The Director, CDC was requested to submit request in writing regarding TA/DA issue and to suggest names for the committees to be constituted at the earliest.

8. Agenda item endorsed by the Department of Geography on PGDI Course:

The AC noted that this has the reference to AC directive on the proposal of increasing of seats and fee of PG Diploma in Geo Informatics Course in the 23rd meeting. Wherein, the AC deliberated on the matter and decided to refer the case back to the Department of Geography. Further, it was decided that IQAC Ordinance Committee will look into it and Coordinator shall be appointed on rotation basis from amongst the Senior Professors.

The HoD Geography has expressed the inability to conduct the said meeting for the want of official order. However the HoD has requested the Authority to place it in the AC meeting for discussion. The proposal and financial implication as furnished earlier is placed below for perusal;

The letter from HoD and proposal from the Course Coordinator was placed to AC for perusal. The AC perused and decided that the proposal should be kept in abeyance unless proper guidelines are made. It was also resolved that;

- i) The course will be brought under self-financing mode.
- ii) The Course will continue with 26 seats.
- iii) New course coordinator shall be appointed.

The AC further seriously observed that the proposal should have been routed through HoD and not directly to the Vice-Chancellor.

To peruse the minutes of the meeting of the Committee for "Earn While Learn" Scheme:

The AC noted that the Chairman of the Committee for "Earn While Learn" Scheme has submitted a meeting minute suggesting the modalities of the scheme. The HVC and Chairman (Ex-Officio) of the Academic Council has desired that the scheme is to be informed to the members of the Academic Council.

The minutes of the committee meeting held on 22nd May, 2019 was placed to AC.

The AC perused and resolved that the Director, CDC shall identify areas and explore the feasibility as to where the University could institute the scheme.

To discuss on the matter pertaining to grant of study leave to Teachers of RGU pursuing PhD in RGU.

As desired by the HVC, the two identical cases of faculty members were placed for perusal and decision by the Academic Council.

The AC discussed the matter and resolved to grant one year study leave for teachers, who are pursuing Ph.D in RGU and two years for those teachers who are pursuing Ph.D outside RGU.

It was also resolved that;

- i) The University shall introduce signing of Board for granting study leave. This shall be effective from July 2019 onwards, and
- ii) A committee shall be constituted to look into the matter.

11. Agenda items received from Prof. Ashan Fiddi, Director, IDE:

a) Establishment of Study Centre for Institute of Distance Education at Namdapha Degree College, Miao, Changlang.

The AC noted that the XXXII Board of Management meeting held on 10th June 2019 has decided that a Centre may be established at Namdapha Degree College, Miao, Changlang district after completing due formalities.

The AC perused and approved the proposal.

b) Approval of Revised syllabus under Institute of Distance Education, RGU

The AC noted that the XXXI Board of Management meeting held on 6th February 2019, has decided that Board of Studies for the entire subjects would be conducted and the syllabus will be revised for the courses. In the month of February/March 2019, eight (8) Board of Studies meetings were conducted where syllabuses were revised and approved. The revised syllabuses were placed in the XXXII BoM meeting held on 10th June 2019. The syllabuses were accepted by the Board and the same were placed in the Academic Council.

The AC perused and approved the proposal.

c) Introduction of various professional courses under Institute of Distance Education

The AC noted that the Board of Management in its XXXI and XXXII meetings has received proposals from various departments in regard to introduction of New Courses under IDE. The proposed course are;



- i) Diploma in Food Processing
- ii) PG Diploma in Mass Communication
- iii) Postgraduate Diploma in Agriculture Business
- iv) Bachelor of Tourism & Hospitality Management
- v) Diploma in Elementary Education
- vi) Diploma in Nutrition and Fitness Management

The Board of Management approved the introduction of the above courses subject to approval by the concerned accreditation agencies. The proposal was placed to the AC for perusal and decision. The AC perused and approved the proposal.

12. Progress on MOOC SWAYAM Courses

The Chairman enquired about the progress of activities related to MOOC SWAYAM courses from the Head of Departments and Directors.

The AC resolved that it should be placed through BPGS in the next meeting of the AC.

13. Proposals from HoD, History

The Head, Department of History proposed for strengthening M.Phil guidelines like registration of M.Phil scholars, notification and award of M.Phil degrees.

The Council resolved that the University is going to develop M.Phil guidelines. A committee will be constituted to formulate the guidelines.

14. On an issue pertaining to seat vacancy in Mass Communication for RGUMPET 2019

The AC deliberated on the matter at length and it was resolved to constitute a 3-Member Enquiry Committee. Thereafter the matter shall be administratively taken up.

15. On adoption of reservation policy in place for Economically Weaker Section (EWS) category for admissions to various courses and for appointment to teaching positions in Rajiv Gandhi University

Following the directives of the Govt. of India, RGU has adopted the reservation policy for Economically Weaker Section (EWS) category for admissions to various courses and for appointment to various teaching positions in RGU. In this regard, the university has also issued a circular vide File No. AC-1740/RGUCET/2017 on 6 June, 2019, directing candidates to submit the Income and Asset Certificate as prescribed by Govt. of India for admissions through RGUCET-2019.

The AC deliberated on the matter at length and it was resolved to constitute a 3-Member Enquiry Committee. Thereafter the matter shall be administratively taken up.

As there was no other item for discussion, the meeting ended with the proposal of vote of thanks by the Registrar i/c and Ex-Officio-Secretary of the Academic Council.

As per the latest NAAC regulations, the AQAR needs to be approved by the statutory bodies of the University (AC/EC).</p> <p>The Academic Council perused and approved the AQAR, 2018-19 and 2019-20.</p> <p>(ii) VISION-2032:</p> <p>The AC noted that the University has already prepared and printed the VISION-2032 documents in the year 2017 and it has already been approved by the then Vice-Chancellor. However, it has not been approved by the Statutory Bodies of the University.</p> <p>The Academic Council noted and accorded ex-post-facto approval with retrospective effect. However, a Committee may be constituted to look into the issue along with the other policy documents as placed in the 33rd AC.</p>
