Pursuant to a decision taken in the 43<sup>rd</sup> meeting of the Academic Council held on 12<sup>th</sup> June, 2023 under item No.AC:43:41, Permanent Affiliation of Teacher Training College (B.Ed), Aalo, District West Siang, Arunachal Pradesh in accorded in principle subject to fulfillment of following conditions:-

- 1. Structural adjustment of the building constructed to run B.Sc. programme with the inclusion of separate washrooms for men and women, and cubicles for teachers.
- 2. The faculty members and other staff are to be appointed before the start of the BA/B.Sc. programmes, as per the laid down rules.
- 3. Books/Journals need be procured for both the B.A. and B.Sc. programmes before the commencement of courses.
- 4. Laboratories are to be maintained with adequate instruments and chemicals.
- 5. The college shall be required to procure adequate books all these three (3) programmes.
- 6. The College needs to have proper Leave Rules for both teaching and non-teaching staff.
- 7. The online/electronic transfer of the staff salaries is to be ensured.
- 8. The vacation period is to be counted 'on duty' and as such, the staffs are to be paid full salaries during vacation also.

On submission of the compliance reports on the eight (8) points mentioned above, an inspection committee from RGU shall be deputed to ascertain the same. The non-fulfillment of mentioned conditions herein lead to the forfeiture of the approval granted with conditions.
