1. Background

International Youth Day focuses on the difficulties that some young people are experiencing throughout the world. Half the children between the age of six and 13 lack basic reading and math skills and childhood poverty is still a prevalent problem globally. International Youth Day was created by the UN to help draw awareness to these issues as we strive to find solutions. It's a day for reflection but also a day for taking action so get involved. There'll be many concerts, workshops and cultural events taking place so have a look at what is happening in your local area.

International Youth Day began in 2000 and was organized by the UN to recognize the input that young people make in education, community development, environmental groups, volunteering for different social projects. Accordingly **Centre for Youth Development and Leadership Studies (CYDLS)**, Department of Social Work, Rajiv Gandhi University, organized a national webinar to commemorate International Youth Day with theme as 'Youth as Harbingers of Peace and Social Transformation.' The Programme encourages youth around the world to organize activities to raise awareness about the situation of youth in their country.

2. About the Organizing Institution

2.1. Rajiv Gandhi University

Rajiv Gandhi University (formerly Arunachal University) is the premier institution for higher education in the state of Arunachal Pradesh. Late Smt. Indira Gandhi, the then Prime Minister of India, laid the foundation stone of the University on 4th February 1984 at Rono Hills. Subsequently, the postgraduate teaching programme was introduced in the University, starting from the academic session of 1988-89. The University was converted into a Central University by an Act of the Parliament of India which came into force on 9 April 2007, as per the notification of the Ministry of Human Resource Development (MHRD), Government of India. Ever since its inception, the university has been trying to achieve academic excellence in the fulfilment of the objectives envisaged in the University Act. In this endeavour, the University has successfully elevated itself in the higher rung of the Indian University system.

The campus at Rono Hills is located on a picturesque tableland in the outskirts of Itanagar, the capital city of Arunachal Pradesh. The University offers post-graduate /graduate / PG Diploma / Certificate and research programmes. At present, there are more than Thirty (30) Departments and Two (02) Institutes functioning under Nine (09) Academic Faculties. The affiliating jurisdiction of the University encompasses all the existing colleges in the state.

The university has expanded vertically and horizontally by creating and augmenting departments and facilities to cater to the demands of the native communities of the state, the marginalized and the disempowered, while serving the needs of the nation. The students of the University have found placements in State and Central Government Services and in various institutions, industries and organizations across the country. Maintaining its academic excellence ever since inception and years of concerted efforts has resulted in qualitative as well as quantitative progress in the overall standards of teaching and research in the University. The students from the University are contributing at significant positions not only in State and Central Government Services but also in various Institutions, Industries and Organizations. The University has been Ranked Second Best among all the Central Universities in the country during 2020 by the Ministry of Education, Government of India. University has also been awarded with the title of Best Central University of the Year 2020 during the 3rd Himalayan Educators Summit-2020 & 3rd DivyaHimgiri Himalayan State Education Excellence Award-2020 to recognize the efforts of leading educational institutes of the Himalayan States that are substantially contributing to the Education sector. The University has been recognized as a Centre with Potential for Excellence in biodiversity by the University Grants Commission (UGC).

2.2. Department of Social Work

The Department of Social Work (DSW) at Rajiv Gandhi University (RGU) was established in 2015 with the vision of providing quality Social Work Education. The Department started with offering face-to-face Master of Arts in Social Work (MASW) Program during the academic session 2015-16. The MASW students/trainees are exposed to carefully crafted skill building and personality development programs and are provided with opportunities to participate in workshops, seminars and lectures from external experts on regular basis. The Doctoral Program in Social Work (PhDSW) was introduced in June 2018 to focus on strengthening the research component with an emphasis on 'evidence-based practice and

practice-based evidence'. In our pursuit to extend our horizons in serving diverse categories of student community the Certificate Program in Environmental Sanitation (CPES) was conceptualized and introduced with the academic session 2019-20 for an integrated understanding to the learners about the issues involved in Health, Hygiene and Sustainable Development.

The mandates of the social work course curriculum also include students led initiatives in the department and the community with varied clientele groups. The department has strived and established a strong foothold in the field of social work education by means of continuous engagement in both academic and outreach activities. In a relatively short span of time, the Department has established meaningful and sustainable engagement with more than fifty field work partner agencies located across the country.

The department is thereby committed in enabling and equipping the students to realize their full potential and acquire the knowledge, skills, values and techniques essential for a professional social worker leading to personal and professional development and country at large. Currently the Department offers three regular academic programs as below:

- a. Doctor of Philosophy in Social Work (PhDSW)
- b. Master of Arts in Social Work (MASW)
- c. Certification Program in Environmental Sanitation (CPES)

3. Beneficiaries

The intended target audience were the youth groups from across the country who were concerned or interested in working on the various challenges faced by youth groups and the constructive role this group can play in building India. The online national level webinar aims to directly benefit students, research scholars, academicians, social scientists, social workers, government and non-government functionaries.

There was no registration fee for the participants. Live web sessions were conducted through Google Meet Platform. **In total 150 participants attended the webinar.**

4. Program Date

The programme was organised on 12th August, 2021.

5. Total Budget

The total budget incurred for organizing of the programme was Rs. 2,000/- which includes honorarium to the Resource Person.

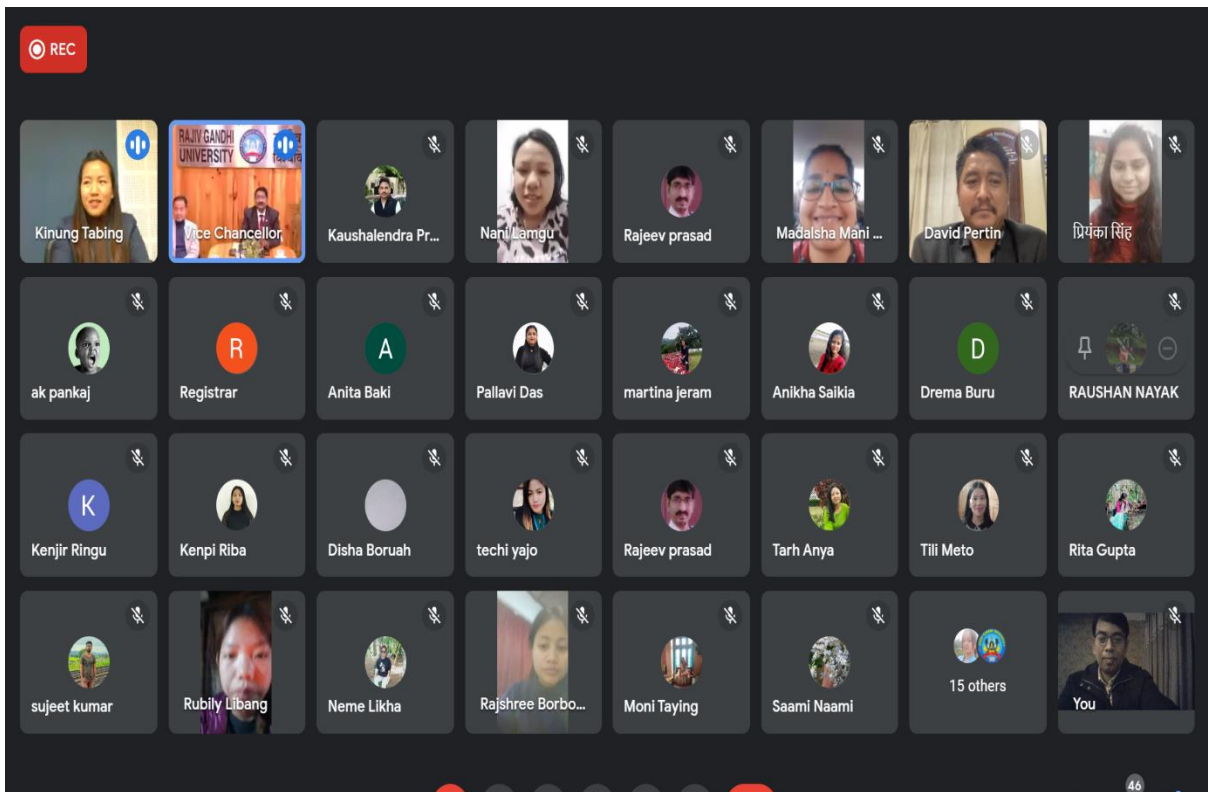
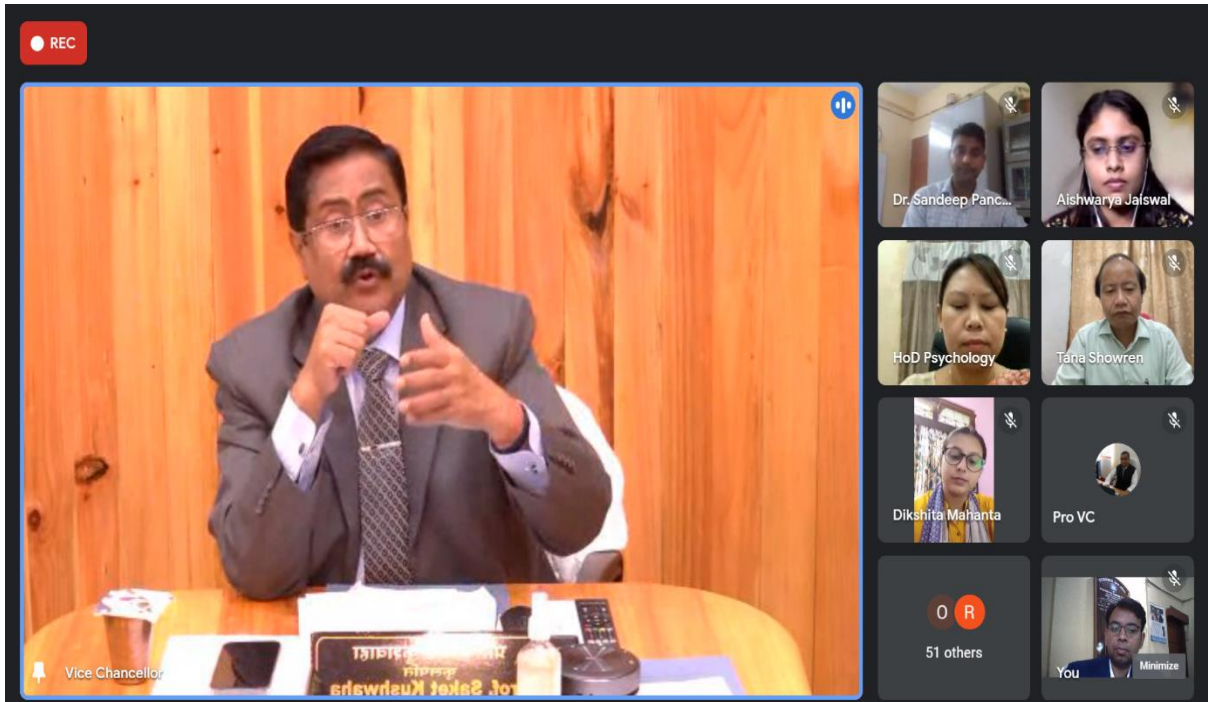
Mizoram University vice-chancellor Prof K R S Sambasiva Rao shared his vision for youth development and stressed upon their instrumental roles for nation building.

The department with a commitment towards 'evidence based practice and practice based evidence' is dedicated in grooming and equipping students to reach their full potential and acquire the knowledge, skills, values and techniques essential to become professional social workers who not only acquire personal and professional competency and growth, but also contribute to the betterment of the society and country at large.

3. About the Centre for Youth Development and Leadership Studies

Centre for Youth Development and Leadership Studies (CYDLS) has been established through the vide notification no. AC-108/2007(Vol-II)/397 dated 11 July, 2017 at the Rajiv Gandhi University (A Central University), Rono Hills, Doimukh, Arunachal Pradesh. It aims to address the issues and challenges, building capacities with a special emphasis on utilizing the energy of youth in the North East Region of India especially in the state of Arunachal Pradesh. Since its inception CYDLS is continuously working towards the betterment of youth through a host of extension activities, skill and capacity development programs, trainings, workshops, seminars, conferences, and instituting awards and scholarships to motivate the youth. The vision of the CYDLS is to groom youth as potential leaders and contribute to sustainable development. The centre's mission is to create a platform for progressive engagement and empowerment of youth through professional training and guidance. Also, for nourishing leadership traits among youth through innovation, research, and skills development, the CYDLS has set following specific objectives as well:

- To promote psycho-social well-being of youth;
- To develop leadership qualities among the youth and orient them towards community building;
- To involve youth in community development by way of aligning them with developmental programmes; and
- To embark on training and research on youth development and leadership.

In order to operationalize the vision and mission of CYDLS, three specific Cells namely Counselling Resource Cell (CRC), Youth and Community Engagement Cell (YCEC), and Training and Leadership Research Cell (TLRC) are working to achieve the objectives of centre.

4. Background of the Programme

A grateful Nation remembers with love and pride to great son of *Ma Bharati* – *Swami Vivekananda* for his historic speech in the Parliament of the World's Religions in Chicago On 11th September 1893. On 11th September 1893 Swami Vivekananda, the greatest youth icon ever known to India delivered his historic speech in the Parliament of the World's Religions in Chicago. The electrifying address held the august audience spell bound for the entire brief while for which he spoke. The spirit of India and the kernel of Indian Philosophical thought came beautifully alive in the words of the venerated monk. Addressing the gathering as “Sisters and Brothers of America”, The Great Swamiji gave a valuable insight on National Youth. The Message was loud and clear that the whole of humanity belongs to just one great global family. The rich message ringing from the noble lips of the great son of India was to flood the world with the milk of love. He reiterated the *Sanatan Mantra* “*Vasudhaiv Kutumbakam*”. The dream emanating from the holy soil of India was to keep the whole world audience mesmerized. The spiritual thought was so emotionally soaked in genuineness that the world audience came instantly to be confirmed that action appropriate to the tenor and dignity of the occasion was going to be the only saving grace. The humanity was required only to get ready to translate the dream into reality. In this regard, the birth day of Swamiji 12 January is observed each year as “**National Youth Day**” is being organized by the Department of Social Work and Centre for Youth Development and Leadership Studies in Collaboration with Department of Functional Hindi, RGU to Commemorate Swami Vivekananda’s life, vision and message to the youth for a world based on tolerance and universal acceptance.

5. Objectives

The precise objectives of special lecture commemorating National Youth Day 2022 are specified as below:

- To build capacity of youth with specialized knowledge and skills for a value based social fabric;

- To provide a platform for the youth to understand brotherhood, unity and integrity of the nation;
- To impart knowledge about universal values of brotherhood, empathy and youth empowerment;
- To sensitize youth about symbiotic engagement with different stakeholders for enhanced social and spiritual well-being; and
- To educate youth about leadership as well as self-reliance aptitude.

6. Programme Outcomes

The expected programme outcomes of the special lecture commemorating National Youth Day -2022 are specified below:

- Improvement of social cohesion values among youth;
- Enhancement of aptitude for a socially productive and spiritually healthy youth; and
- Sensitization of youth about symbiotic engagement with different stakeholders.

7. Resource Persons

Smt Vandana Tete, Social Worker and Activist together with Dr. W.G Prasanna Kumar, Chairperson, Mahatma Gandhi National Council of Rural Education (MGNCRE), Hyderabad were the resource persons of the day.

8. Programme Beneficiaries

The target audience included the postgraduate students, research scholars, and faculty members. Nearly 155 (One Hundred Fifty Five) participants attended the programme.

9. Modus Operandi

Live web sessions were conducted through Google Meet Platform.

10. Session Deliberation

National Youth Day is observed on **12 January each year**. It marks the commemoration of Swami Vivekananda's birth anniversary. His immortalized speech is popularly remembered for its opening words – 'Sisters and brothers of America.'

The programme was organised by Department of Social Work and Centre for Youth Development and Leadership Studies in active collaboration with Department of Functional Hindi, RGU. Prof. Saket Kushwaha, Vice Chancellor, RGU delivered the Presidential Remarks. He reminisced his childhood and shared some memories with the students. The key message of accepting the other person in totality and making peace with all; this being the ideal commemoration of National Youth Day' and the motto being, to make this country and the world at large a better place to live in. He concluded mentioning Josephine Baker's lines, "Surely the day will come when color means nothing more than the skin tone, when religion is seen uniquely as a way to speak one's soul, when birth places have the weight of a throw of the dice and all men are born free, when understanding breeds love and brotherhood". Prof. Amitava Mitra, the Pro-Vice Chancellor called upon the teachers to inspire and awaken the youth as rich demographic dividend of the nation.

Smt Vandana Tete, Social Worker and Activist together with Dr. W.G Prasanna Kumar, Chairperson, Mahatma Gandhi National Council of Rural Education (MGNCRE), Hyderabad the resource persons of the event emphasized on how the youth is the power of the nation, have the potential energy and the power to bring change in the society. He talked on the relevance of being Present Across the Nation (PAN) today via the aid of digital presence and internet connect and therefore, utilizing the same as a boon and consciously exert its positive emphasis on to the children and the youth. He threw light on being responsible citizens of the country and imbibe the true feeling of nationalism moving away

from holding on to just one identity of our own tribe but rather expand one's horizon and spread the concept of love, peace and National Youth.

Essentially, Swamiji advocated the right to follow one's unique nature and disapproved imposing changes on anyone. This he applied from macrocosm to microcosm, which is from nations to individuals. His idea of toleration is the solution to the discords between nations, religions and cultures on one hand, and discord in families and smaller groups on the other. The way forward to diplomatic and domestic peace is then to follow Swami Vivekananda's idea of toleration -accept the other person in totality and make peace with all. This would be the ideal commemoration of National Youth Day.

Nearly 155 participants attended the programme through google meet platform on a virtual mode which included PG students as well as PhD Research Scholars in addition to faculty members, statutory officers, Heads of various Departments, Dean of Students Welfare and those of other faculties of the university. The participants ranged from pan India representing Kerala, Chhattisgarh, Gujarat, Delhi, Uttar Pradesh, Tamil Nadu etc.



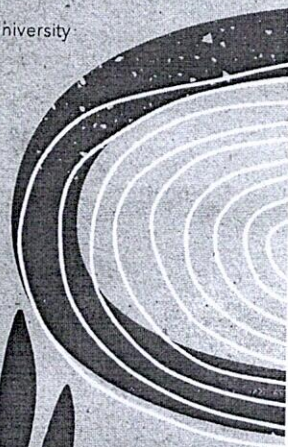
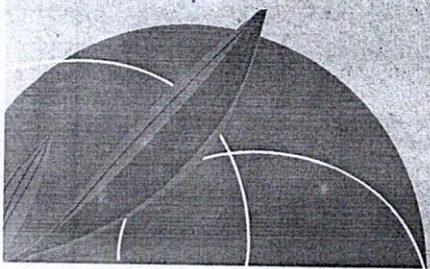

1.1: About the University:

Rajiv Gandhi University (formerly Arunachal University) is the premier institution for higher education in the state of Arunachal Pradesh and has completed twenty-five years of its existence. Late Smt. Indira Gandhi, the then Prime Minister of India, laid the foundation stone of the university on 4th February 1984 at Rono Hills, where the present campus is located. PART 2: SESSION WISE DETAILS

2.1 E-INAUGURAL CEREMONY DAY-1 11/10/2021

Hon’ble VC, RGU, Prof. Saket Kushwahagraced the occasion as the Chief Guest and presided over the e-ceremony. The program was attended by 138 participants both from different parts of India and abroad.

Dr. P Narayan Piraji, Master of the Ceremony, welcomed all. “In the time when the world is facing the pandemic, every program is an opportunity in disguise”, he said emphasizing the importance of e-learning. He introduced the Chief Guest and President of the program and wished all the participants to have a fruitful experience over the next 2 days.

Prof. Bhagabat Nayak, HoD, Dept of English. welcomed the Chief Guest, Prof. Sanjai Bhatt, Delhi School of Social Work, University of Delhi, Hon’ble VC, RGU, Prof. Saket Kushwaha, Registrar, Dr. N T Rikamand gave heartfelt thanks for their constant support and guidance towards the program. He invited and welcomed eminent Resource Persons from all over the globe. He welcomed all the participants and assured that the Annual International Conference would be very fruitful by having discussions on Gandhi and his ideals in different paradigms.

Registrar (Aca. & Conf.), Dr. David Pertin, Prof. Gollanapalli Prasad, Chief Trustee, Gandhi-King Foundation, Hyderabad and a host of other eminent personalities were present during the Inaugural Session.

Prof. Saket Kushwaha during his presidential remarks to the inaugural session called upon the participants to realize the true meaning of honesty in personal and professional lives. He focused that Gandhiji always suggested being non-hypocritical and if we can realize that in our lives most of our issues will be taken care. Keynote Speaker and Veteran Social Worker Prof. Bhatt asked for the audience to realize the importance of social capital and family which is getting neglected in our blind rush to material pursuits which the Bapu always warned as a source of all evils. Registrar, Dr. N.T. Rikam highlighted the significance of recalling the life and lessons as critical to building value system for younger generations, which Joint Registrar (academic & conference), Dr. David Pertin emphasized on core principles of Gandhian philosophy as being Holistic, Inclusive and Empathetic.

2.2. TECHNICAL SESSION DAY-1 11/10/2021

2.2.1 TECHNICAL SESSION- I: 10.00 am to 12.00 pm

Session Details:

A Total of nine paper presentations were scheduled for the session. Seven of the total presenters presented their papers. Research papers ranged from various disciplines including English, Social Work, Education, Youth Development. Both theory and practice perspectives emerged.

There was lively participation from other participants in terms of queries, clarifications and doubt clearance which was adequately addressed by the paper presenters and duly facilitated by the moderator.

2.2.2 TECHNICAL SESSION- II: 2.30pm to 3.30pm

Chairperson: Prof. Prasanta Kumar Ghosh, Professor & Former Head,
Department of Social Work, Visva Bharati, Sriniketan.

1st Presentation

Chaphiak Lowang, Assistant Professor, Dept. of Social Work, Rajiv Gandhi University.

Topic: Substance Use and Dependence among Youth in Arunachal Pradesh.

She began her paper by mentioning the alarming increase of the number of people who intake harmful substances in the state of Arunachal Pradesh. She provides data that confirms that Arunachal Pradesh is the third state with high use of Alcohol. Her study was done on the people of 15-35 age group in the state of Arunachal Pradesh. During her study she finds out that Tobacco, Alcohol and Cannabis are the mostly used harmful substances. While some small portion of the study group also use Opioids, Inhalants, Cocaine, Amphetamines, Sedatives and Hallucinogens. Her study uncovers that not all of these substance users need intensive medical intervention. Some of the substance user only need proper awareness and psychiatric consultations. She also highlighted the lack of mental health infrastructure in Arunachal Pradesh.

2nd Presentation

Bharati Biswas Student, Dept. of Social Work, Rajiv Gandhi University

Topic: Contrasting Emphases of Private and Government Hospitals – Services and Infrastructure: A Social Work Interventional Study in Sonitpur District of Assam.

Bharati Biswas started her presentation by highlighting the poorer healthcare services in government hospitals than the private hospital. In her paper, she based her studies on empirical observation and case studies, Bharati insisted on the lack of proportionate medical infrastructure is one of the major reasons for the unsatisfactory experience of the patients in government hospitals. Along with this, she pointed out the unethical practices on the part of medical workers in government hospitals. By unethical practices, she talked about the unprofessional behavior of the health care providers such as negligence in performing their duties, irresponsible behavior etc. Her findings inform that because of such practices a large number of patients are victimized every day specially from the economically weaker section. This topic is definitely an important area for further research.

3rd Presentation

Mousumi Kalita, Student, Dept. of Social Work, Rajiv Gandhi University

Topic: Plight of Women under COVID Pandemonium: A Gandhian Perspective on Women in India.

The final presenter of the 2nd Technical Session MousumiKalita mainly focused her study on how women are affected more than their male counterparts in the current Covid 19 Pandemic. She reiterates that even in 21st-century women lag in many aspects of their social life than men. Most important tools of women empowerment like education and economic independence are yet to be reached by the major percentage of the women in her study area i.e., Udalguri district of Assam, India. As a result, women in her study area are seen as the worst sufferer during the Covid 19 situation both in the domestic and public sphere. She also discusses on the relevance and importance of the practices of Gandhian principles on women empowerment in the current time.

At the end of the session, the chairperson, Prof. Prasanta Kumar Ghosh shared his critical observations on the three papers presented. He appreciated the paper presenters for selecting very relevant issues for discussion and pointed out that all three papers can be contextualized in the paradigm of Gandhian studies. He also pointed out the commonalities and differences of opinion regarding education policies by two towering figures of twentieth-century India-i.e. Mahatma Gandhi and Rabindranath Tagore. Prof. Ghosh further mentioned that both Gandhi and Tagore stressed holistic education especially on the character building of a child. Lastly, he pointed out that Gandhi's emphasis on moral and ethical education is the need of the present time and our education system should make provision for such education.

2.2.3 TECHNICAL SESSION- III: 3.30 Pm to 4.30 pm

Chairperson: Prof. K.C. Mishra, Professor,
Department of English, Rajiv Gandhi University

Moderator: Dr. Parachand Narayan Piraji, Convenor, AIC-2021
Department of English, Rajiv Gandhi University

This session was chaired and facilitated by Prof. K.C. Mishra, Professor, Department of English, Rajiv Gandhi University. The moderator of the session was Dr. Prachand Narayan Piraji, Assistant professor, Department of English, Rajiv Gandhi University. The chair was formally introduced by the moderator.

During this session, there were only 2 contributions from the floor due to certain technical glitches. One was by Dr. Ram Tiwari and his paper titled “*Gandhiji ke Bicharonki Surakshatmak Pariveshmein Bhumika*” followed by Dikshita Mahanta’s “*Re-Imagining Medical Social Worker as Patient Rights Enforcement Officer: A Gandhian Perspective from North-East India*”.

In his presentation, Dr. Tiwari highlighted the importance of Gandhi’s emphasis on education without exploitation. He further stressed on 3H’s education i.e., Head, Hand and Heart and talked on Gandhi’s ideals on *Swaraj* for all the people without discrimination. Gandhi’s initiative for the Dalits i.e., his 6 days fasting for the same and his *Satyagraha* were further explained. Inspiration from Gandhi in today’s social spectrum was mainly emphasized at the end of the presentation.

Dikshita Mahanta related her study with Gandhiji’s perspective and tried to put forth the various real cases of mistreatments and negligence towards patients by health administrators and medical practitioners. She however put forth evidence-based recommendations for policymakers and practitioners with regard to healthcare administration in North-East India. The emphasis was given on the dignity of patients being humans that could be paid better attention not to be violated.

The chair then presented his critical comments and views on both the contributors. An enlightened and aware society was emphasized, and he said, “We should think in terms of Gandhi.” The chair then thanked all the presenters, participants, and organizers.

In conclusion, Dr. Ravi Ranjan Kumar, Head i/c, Department of Social Work, Rajiv Gandhi University offered his regards and thanks. He briefed and informed about the next-day sessions and other activities and competitions to be organized in relation to the event.

The session was chaired and facilitated by Dr. Manish Sharma, Chairperson, Department of Gandhian and Peace Studies, Panjab University, Chandigarh. The moderator of the session was Dr. Ravi Ranjan Kumar, Convenor, AIC-2021 Head, Department of Social Work, Rajiv Gandhi University. The chair was formally introduced by the moderator.

The first presenter of the third technical session, Dr. DoyirEteTaipodia, Assistant Professor, Department of English, Rajiv Gandhi University, presented her paper titled “Symbolism of Gandhi in Indian Jewish Literary Imagination” focusing on three books by the Jewish writer Esther David, namely *Book of Esther*, *By the Sabarmati* and *The Man with Enormous Wings*. She talked about Gandhi's views and Gandhian literature. In the three books Esther David uses Gandhi's views on the untouchables and compares it with the Jews and reflects why Gandhi is important to the minority communities of India. The message of Gandhi is to coexist in harmony, VasudhaivaKutumbakam, and this is shown and conveyed in the stories woven in the books which reflected the Godha violence and other injustices faced by her community. Gandhiji dreamt of a utopian society that was holistic, inclusive and interconnected. It is important not just to coexist but also to be deeply connected. It is such a society which has the potential to prevent and stop communal violence. “My life is my message” this was said Gandhi when asked what message he wants to convey about his life shortly before his death, and this has beautifully been captured in the works of David.

The next paper was presented jointly by Dr. KasimangMayong, Assistant Professor, Department of Sociology, Rajiv Gandhi University and Dr. Nisanth P.M., Assistant Professor, Department of Education, Rajiv Gandhi University titled “Scope of Gandhian Education in the 21st Century.” In this paper they focused on Gandhian political thought, Gandhian concept of society, Gandhian concept of economy, Gandhian concept of secularism, Gandhism in education, technology and relevance of Gandhism in the 21st century. Gandhi regarded education as a tool, light of life and the very source of realisation of oneness, he believed education led to universalisation and national integration. Based on Gandhiji’s idea of Satyam meaning Truth the contemporary society brought this idea and formed the Right to Information Act (RTI Act) which empower the citizens by bringing out the truth. Adopting Gandhian philosophy of building the bridge between the rural and urban, technology the conceived the idea of E-Pathsala.

TenzingWangmu, Assistant Professor from the Department of Sociology, Mahabodhi Lord Buddha College, Namsai, Arunachal Pradesh was the third presenter, and the title of her paper was “Relevance of Gandhian Ideas: A Gandhian Approach of Understanding Dam Construction and Environmental Justice in Tawang District of Arunachal Pradesh.” She talked about the effect of dams in Tawang and highlighted with the Uttarakhand flood example how a dam can be a nightmare for both people and nature. As per the National Hydro Power Policy of India thirteen hydropower projects are to be constructed on two rivers, Tawang Chu and Nyanjang Chu which made the local people, ecologists and Buddhist monks worry about the environment. Mahatma Gandhi was considered as the worlds early environmentalist in both his vision and practice and his idea of Sawodaya meaning the welfare of all, must be kept in mind before implementing any such developmental policy. She collected data from three villages Brokenthang, Gorsam and Khebleteng which are located nearby the project site and get directly affected by the dam construction. She concluded by saying the realisation of environmental justice helps to transform development policy having inspired from Gandhian idea of non-violence and decentralisation of power.

The fourth presenter of the day was Tapi Chama, Practitioner, Social Work and MSW Alumni, Department of Social Work, Rajiv Gandhi University, and the title of his paper were “Re-Defining Development from Gandhian Perspective: A Social Work Study in Hydro Power Projects in Arunachal Pradesh.” He talked about the impact of the dam in the surrounding area of its construction like loss of downstream aquifers, flooded habitats, riverbank erosion, loss of livelihood of fishermen and how the ideas of Mahatma Gandhi come into the fold. Quoting Gandhiji’s famous line “Earth provides enough to satisfy every man’s need, not every man’s greed” he talks about sustainable development, non-violence towards nature and diversity, Gandhi’s principle of Trusteeship and Antyodaya.

KenjirRingu, Research Scholar (PhD), Department of Education, Rajiv Gandhi University and Menuka Kadu, Research Scholar (PhD), Department of Social Work, Rajiv Gandhi University were the fifth presenters, their paper titled “Social Justice through Inclusive and Equitable Education: The Case of Children with Special Needs in Arunachal Pradesh”.

Next Dr. Kirti Arya, Medical Social Service Officer (MSSO), All India Institute of Medical Sciences (AIIMS), New Delhi presented her paper on “Mental Health Consequences of Drug Dependency: A Gandhian Analogy of Health and Well-Being.” She highlighted the various reasons why people are attracted to drugs.

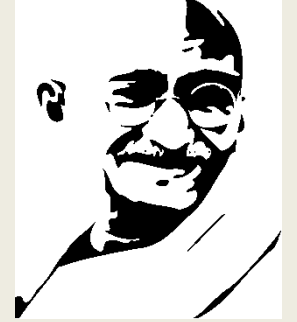

Lectured extensively on Gandhian Philosophy in many Telangana schools and colleges. The Department of English, Rajiv Gandhi University has organized a lecture series on the 152nd Birth Anniversary of Mahatma Gandhi. On the second day of the lecture series, the English Department invited the noted Speaker Dr. Avadhanam Raghukumar to deliver a lecture on the topic “Gandhi’s Truth: Theory and Practice.” The coordinator of the program, Dr. Chandan Panda addressed the audience and also welcomed the guest speaker on behalf of the university. He gave brief information about the guest. The program began at 3.00 pm and it was conducted through online mode. Many Scholars, Academicians, Educationists, students were invited to grace the Occasion. Dr. Raghukumar spoke at length counting the relevance of Gandhi’s philosophy in the 21st century. He began his lecture by discussing Anthony J. Parel’s contribution towards understanding Mahatma Gandhi. In this modern world, Gandhian ideas of Satyagraha and dialogic method are the only way out, said Dr. Raghukumar in his speech. This was followed by an interactive session where students asked questions related to Gandhi.

The questions that were asked by the students were:

- Gandhi changed the notion of God is Truth to Truth is God. So then can lie also be God?
- How do Gandhian ideas influence women?
- Would you please throw light on the relevance of Gandhiji's philosophy in the 21st century?
- Is Gandhian Hinduism the same as the Hinduism being preached and practiced in the current scenario?
- Could you please, shed light on Puna Act?
- What is your view on Nathuram Godse's disagreement with Gandhiji's conviction?
- Could you please highlight how Gandhiji's ideology influenced the subaltern for whom Gandhi was just another elite?
- Sir, you stated that for Gandhi truth did not mean only empirical evidence but that one's inner voice had to take the higher role.
- My question is, wouldn't such an interpretation of truth lay too much emphasis on subjectivity and leave us grappling for truths
- in absence of consensus?
- Could you please tell us about Gandhi's feature and scope of Indian Nationalism?
- How do you look at the modern politicians' use of Gandhi in their narrow perspectives?
- How do you see Gandhi either as a socialist or Nationalist in his overall approach and vision?

Dr. Raghukumar expressed his opinions and stressed the need for responsive beings. He also acknowledged the meritorious service rendered by the university. It was one of the most educative lecture sessions we all had seen in recent times. The students were encouraged by the informative lecture provided by Dr. Raghukumar.

The last session of the program ended with a Vote of Thanks delivered by K.C Mishra sir. He extended his hearty vote of thanks to the speaker, who spared time from his busiest schedule to grace the program and to the listeners present online.

The third day of the Five Davy Online Lecture Series organized by the Department of English to commemorate the 152nd birth anniversary of Mahatma Gandhi was divided into two technical sessions. The first technical session began with the welcome speech by the Convener of the Program Dr. K.C Mishra, followed by Gandhi Bhajan by the students of the Department of Music, Rajiv Gandhi University. The session was chaired by the Honorable Vice-Chancellor, Prof. Saket Kushwaha. The special guest of the session was Shri. Tushar Gandhi, renowned journalist, author, and great-grandson of Mahatma Gandhi. Honourable Vice-Chancellor warmly welcomed the speakers of both the sessions and he encouraged the participants to take an active part in the programme. Dr Doyir Ete, the coordinator of the programme briefly stated the objectives of the programme.

Prof. Prasad Gollanapalli, Gandhian Scholar from the Gandhi- King Foundation, Hyderabad introduced Shri Tushar Gandhi to the participants. Prof. Prasad highlighted the shared lineage of the special guest with Mahatma Gandhi and appreciated Mr Gandhi as a courageous thinker and an activist. Speaking on the legacy of Gandhi, Prof. Gollanapalli laid emphasis on the Gandhian principles of truth and non-violence as the core foundation to rebuild modern society today. He stated, “Unless we bring the Gandhian thought to the young generation the society will not be peaceful.” He welcomed the special guest and congratulated the participants for the opportunity to interact with Shri Tushar Gandhi.

The special guest of the session, Shri Tushar Gandhi spoke on the topic ‘Relevance of Gandhian Philosophy in School Education. He highlighted the fundamentals of Gandhian philosophy in education and its implementation in the Indian school system. In his lecture Mr Gandhi called for a regional and culturally specific education system. He talked about how today’s education is mainly rote learning, focused on passing exams and not knowledge based. A change must be brought into the education system of the country. It can only be done by understanding the philosophy of Gandhi and implementing it. He also focused on the Gandhi’s idea of Skill-based, vocational, and holistic education. He pointed out that the purpose of an education system should be to empower a person and to provide a quality life much greater than they could have without education. Talking about the ideal education system he advocated Mahatma Gandhi’s view of 3’Hs’ of education, that education should enlighten the head, appeal to the heart and empower the hand. He said that in a diverse country like India where enormous diversity and disparity are found in every corner the education system must be made independent and decentralized to reduce this disparity as well as to balance the diversities.

The second technical session of the day had Dr. Prasad Mandi from NITEL, Mumbai as the key speaker. He spoke on the Gandhian concept of education. Dr. Prasad shared a YouTube video of his lecture on Gandhian Education titled *Nai Talim*. In the visual, he explained how the Gandhian education system can be embedded as a part of regular education system. He highlighted the importance of converting study into work particularly for graduate students. He also shed light on the three things that Gandhi incorporated in his idea of Education: manual labour, holistic education, and the positives of education. He pointed out the weakness of the education system today stating, “In education, work is missing”. The present education system should be able to bring work in education and to convert the study into work. Referring to Gandhi’s idea 3Hs of education he said that it must be incorporated in the present education system to make a person economically and morally self-reliant. He said that education is also a way of gaining financial benefit through education, he quoted Mahatma Gandhi, “convert your studies into work, convert your work into value and use your work experience for developing your three important aspects head, heart and hand”. He cited the examples of various start-up companies by his students as examples of successful translation of Gandhi’s message which is ‘manual labor is a must in transforming education into practice.’ The lectures were engaging and enlightening. The lecture series ended with an interactive question and answer session between the speakers and the students. The session came to an end with the vote of thanks by Dr. Chandan Kumar Panda, Asst. Prof.

The meeting started with a welcome address by Dr. Chandan Kumar Panda. He read out the bio-note of speaker Prof. Raj Kumar where his works and prestigious publications were highlighted. Dr. Panda announced the topic for the day's lecture- "Gandhi-Ambedkar Debate" and passed the baton to the esteemed speaker.

Prof. Raj Kumar, at the outset, thanked the HOD and all faculty members of the Department of English for inviting him to the online lecture series. He started his lecture by quoting authors who documented B. R. Ambedkar's reaction to Gandhi's death. He presented the impressions of Bhikhu Parekh on the relationship between Gandhi and Ambedkar. He pointed out the bitterness that existed between Gandhi and Ambedkar. Ambedkar did not issue a public statement on the assassination of Gandhi. Ambedkar felt that Gandhi did not contribute to the spiritual, moral and social make-up. Prof Kumar quoted: "I owe nothing to Gandhi and he has contributed nothing to my spiritual, moral and social make-up"- Ambedkar. He cited Gopal Krishna Gandhi's imagination on how Dalit activists would think about the conflict between Gandhi and Ambedkar. Prof. Kumar in his lecture arrived at a consensus that the

relationship between the two men of historical importance was an uneasy and tense one. He informed the audience that Gandhi and Ambedkar had differences of opinions on myriad issues. However, in the lecture, he was going to discuss the aspect of caste in detail. Prof. Kumar highlighted the ways in which Gandhi and Ambedkar led their life. Gandhi's idea of passive resistance and non-violence started to emerge when he was in South Africa. He returned to India in 1914, shared his clothes with the poor to become a naked fakir. He was the leader behind the Non-cooperation movement, Salt Satyagraha and Quit India Movement. He belonged to an affluent family, unlike Ambedkar who was economically weak and faced adversities in every facet of life. Ambedkar was not allowed to sit with upper-caste boys in school. He was not allowed to take Sanskrit for being an 'untouchable'. He fought and thought for the Dalits and eventually converted to Buddhism. Prof. Kumar acknowledged that Gandhi had an affinity with Ambedkar so far as building a society of justice and peace is concerned.

In so far as the debate between Gandhi-Ambedkar is concerned, there are supporting and opposing camps. The either line of thought endorses one and throws unfair criticism to the other. In this regard, Prof. Kumar illuminated on Arundhati Roy's Introduction to *Annihilation of Caste* by Ambedkar. The two figures seemed to be inextricably linked. However, Gandhi and Ambedkar had diametrically opposite views on caste. For Gandhi, untouchability had nothing to do with the caste system but a division of labour. *Varna* implied duties which are necessary to live. Progenies ought to follow their ancestral works or traditions. This aspect of Gandhi makes him orthodox. Prof. Kumar opined that Ambedkar felt the need of a separate electoral system for Dalits to get justice. In this respect, the Poona Pact garners tremendous significance. Ambedkar on *Annihilation of Caste* states that it's a pity for caste to be defended. Caste is not a division of labour but labourers. It is what divides people into different categories. An outcast shall remain one till there is caste. Gandhi in 1921 endorsed caste. According to him, it was another name for control. For Ambedkar, virtue became caste ridden. Caste system made it unfair to the meritorious and needy. The remedy for caste is inter-marriage. Nothing else will serve as a solvent of caste.

In the concluding remarks, Prof. Kumar pointed out certain ideas associated with Gandhism. Gandhi was a propagator of tradition and an upper caste Hindu spokesperson. He quoted scholar Nagraj to suggest that Indian society would have gained if there

was a big conflict between Gandhi and Ambedkar. After all, Ambedkar attacked the caste system and hoped to purge caste-infected Hindu. He was a realist and not a sceptic.

At the end of the lecture, Dr. Chandan Kumar Panda (Coordinator) thanked Prof. Raj Kumar for his lecture highlighting the ontology and historicity of caste. He also hoped that certain other pertinent aspects such as ideas on petition and colonization may be touched upon while addressing the questions from the audience.

The following questions were asked by the audience during the Q&A session:

1. If New Education that Gandhi initiated in any way accentuates or annihilate casteism. (Mandi Sikayi)
2. How does caste system operate in 21st century urban setting in India? (DevidPayeng)
3. How Gandhi made Ambedkar a villain in his fight to be the real representative of Dalits or realist? (Litum Bole)
4. The National Education Policy, 2020 (Draft) claims to rest on the bedrock of Gandhi's idea of basic education. How you see the future of India's education in the light of the progressive vision of Dr. B.R. Ambedkar for Independent India? (Sumin Prakash)
5. Could you throw light on the impact of the Poona Pact on the prevailing caste system and the status of vulnerable and downtrodden sections of the society in India?

After the Q & A session, Prof. Prasad, a leading Gandhi practitioner, joined the programme. He said that Gandhi believed in the integration of society and worked for the removal of untouchability. It was in fact Gandhi who made Ambedkar a law minister. He said that one should be generous to offer Gandhi his due credits. It was Gandhi who declared himself a Harijan.

The lecture series ended with Dr. Doyir Ete delivering her vote of thanks. She thanked the speaker for the day, Vice-Chancellor, Pro-Vice-Chancellor, Registrar, officials, dignitaries, previous speakers, faculty members, research scholars and students.

The coordinator concluded the session by thanking everyone

The keynote for the fifth day of the Five Days Online Lecture Series organized by the Department of English was delivered by Prof. V. Balamohandas, Former Vice-Chancellor, Acharya Nagarjuna University, Hyderabad, on the topic “Gandhian Principles of Management”.

The program began with a welcome address by Prof. Bhagabat Nayak, HOD, Department of English, RGU. It was followed with a brief outline of the objectives of the programme by the coordinator Dr Doyir Ete. Prof. Balamohandas expressed his pleasure in being a part of the lecture series and congratulated the Honorable Vice-Chancellor, Prof Saket Kushwaha, the Department of English and Rajiv Gandhi University for the initiative. He began his talk with an anecdote relating to Arun Gandhi, the Mahatma's grandson which was narrated by Arun Gandhi himself at the University of Puerto Rico, USA. The moral of the story was that there is great power in truth

and non-violence. He then spoke about the concept of Management, and how Gandhian principles can be implemented in it. He highlighted the great leadership skills of Mahatma Gandhi and how he had all the qualities of a great leader with knowledge and experience in almost all the spheres of life. This made him a man of all disciplines. He was a multifaceted man with the spirit of innovation and creativity who introduced non-violence in freedom struggle focusing on peace and liberation without bloodshed. Professor V. Balamohandas emphasized the Gandhian ways of life such as self-discipline, equality, self-reliance, mutual respect, appreciation of individual abilities and teamwork. Decentralizing of authority, commitment and punctuality, emotional intelligence that spoke for patience and perseverance, brand building, self-confidence, and awareness of one's strength and most importantly to be the trustee of wealth and not the owner of it.

With all his devotion to Gandhian ways of life, he appealed to the Honorable Vice-Chancellor to introduce a Diploma Course on Gandhian Studies at Rajiv Gandhi University which was echoed by Prof. Prashad Gollanapalli, a Gandhian Scholar of Gandhi -King Foundation, Hyderabad. He expressed concern over the prevalent loss of Gandhian values and hoped that the introduction of such courses may contribute to its return. Prof. Balamohandas also interacted with the participants and answered their queries.

The programme ended on a high note with the vote of thanks proposed by Dr Miazi Hazam, Associate Professor, Department of English.

PART 6: MAJOR TAKEAWAYS

6.1 ACADEMIC CONTEXT

A week-long commemoration of Mahatma Gandhi's 152nd birth anniversary saw a considerable reflection on many areas of study on Gandhi and his principles working both in critical discourse and in daily usage. The importance of studying Gandhi has also been established through numerous frameworks and paths. It was also observed that, in addition to the problems of comprehending Gandhi on indigenous culture, language, and digital humanities, questions have been made regarding fields such as study in performing arts, paintings, and translations, and so on. Prominent scholars from prestigious universities offered lectures, attempting to convey an understanding of what Gandhian philosophy is and how it should be applied in the everyday life of the ordinary man through diverse trajectories of practices, literary ideas, and texts. Ethics was also identified as a critical topic to be addressed throughout these celebrations.

6.2 POLICY IMPLICATIONS

6.2.1 Gandhian values, ideas and ideals should be ingrained in course curricula at all levels of formal education.

6.2.2 As a champion of Social Justice and Equity, a comparative discourse on Gandhian Ideology with that of Dr. Ambedkar's views for a holistic understanding and pragmatic implications.


6.2.3 Gandhian economic principles should be re-visited in contemporary context of COVID-19 for sustainability and sarvodaya.

6.2.4 The younger generations must be taught with the Gandhian philosophy of 'Last in the ladder' for an empathetic social order.


6.2.5 The development practitioners should be encouraged to work through Gandhian practice models for a compassionate, empathetic and sustainable world order.

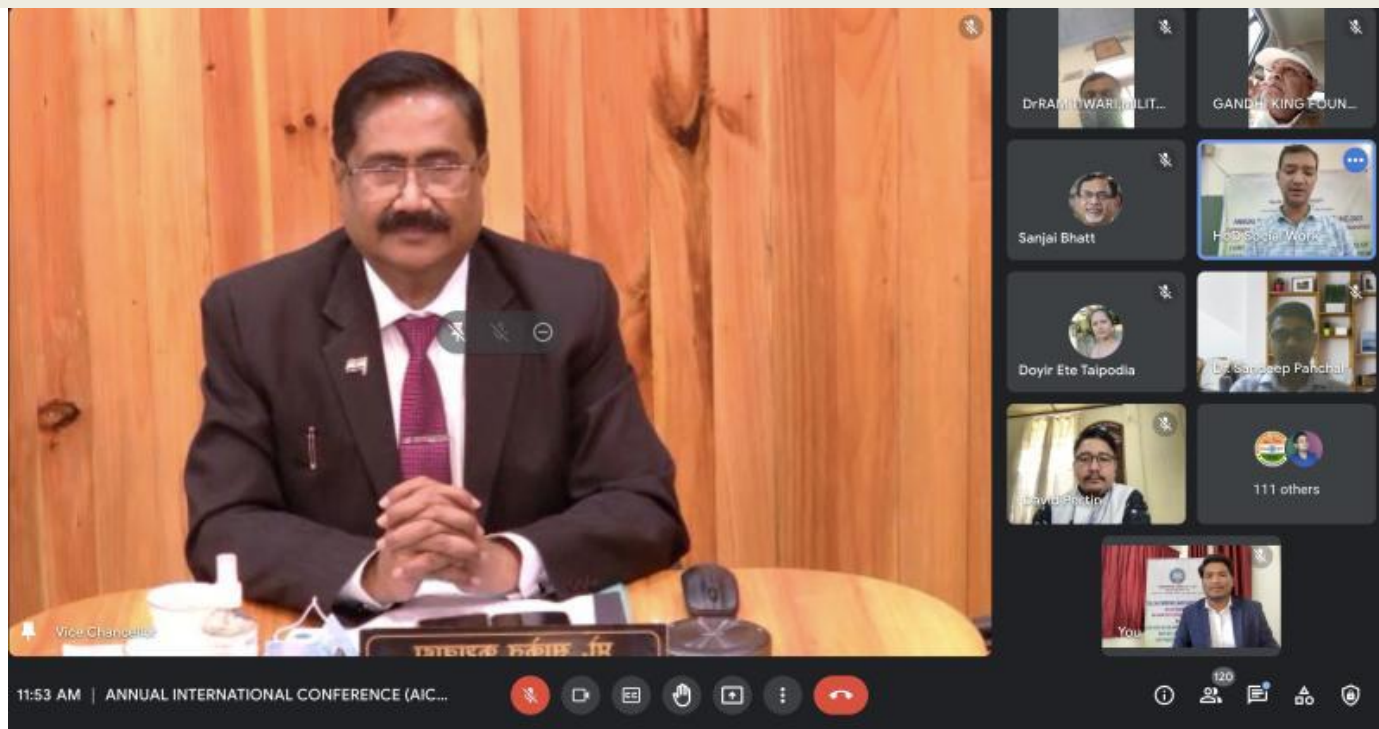
Ms. Dikshita Mahanta and Mr. Tapi Chama.
