Sub: Deduction of Income Tax at source u/s 192 of the IT Act 1961 during financial year 2023-24, Assessment Year 2024-25

To facilitate the Finance branch for accurate assessment of income and tax and deduction thereon at source under section 192 of Income Tax Act – 1961, all teaching and administrative staff members whose income exceeds Rs. 2, 50, 000/- p.a. for both male and female employees during the year 2022-23 are required to submit a statement showing details of their income and amount claimed for exemption/rebate in tax along with photocopies of supporting documents (in duplicate)

The income tax assesses are requested to download the assessment form attached herewith and submit to the undersigned along with photo copies of PAN Card, insurance premium paid and other investments admissible for exemption of income tax on or before 15th December 2023 after duly furnishing all information.

Further all concerned employees are requested to mention their PAN number on the Assessment Form which has been made mandatory by the Income Tax Department for proper credit of tax to the Central Govt. account. The Income Tax Department will not accept the Assessment Form/Return without PAN number.

This OM does not apply to those who are exempted from paying income tax under relevant provisions of the Income Tax Act.
