Since the earnest money is part of performance guarantee and Security deposit. It shall be released after the completion of observation/maintenance period.
- 6. The observation or maintenance period shall be of one year from the date of actual completion of works.

- 7. Bids under two separate PARTS super scribed as 'PART-I TECHNICAL BID' and 'PART-II FINANCIAL BID' must be submitted on or before 1300 Hrs on 20,12,2023. The bids will be opened as according to date and time give in table above in the office chamber of Registrar in presence of intending Tenderer and shall be evaluated by screening committee whose decision shall be final. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
- 8. A pre-bid meeting will be held on 18.12.2023 at 1130 Hrs at the officeChamber of Registrar, Rajiv Gandhi University, Rono Hills, Doimukh to clarify the issues and to answer questions on any matter that may be raised at that stage.
- 9. Contractors who fulfil the following initial requirements shall only be eligible to apply.
 - a) Should have completed three similar (building) works each of value 40% of Tendered Value or Two similar works each of Value 60% of Tendered Value or one similar work of value 80% of Tendered Value during last five years.
 - NB: The Documents should be authenticated by completion Certificate and Performance Certificate
 - b) Should have an average annual financial turnover of 50% of Tendered Value in construction works during last five years up to 2022-23.
 - c) The bidders shall produce Solvency & Bank Certificate from recognize bank, Experience Certificate, Details of T & P with authentication, PAN Card, & details of Technical Manpower. The Bidders should produce income tax exemption certificate if any. The intending contractor/Firms must have the GST registration certificates and its clearance certificate upto the previous month of GST deposit period.
 - d) The Machineries/T&P on leased, Hired will not be considered for qualification. The Details without ownership certificate shall be rejected.
 - e) The materials as specified in the annexure-III may/may not be provided from the employer end.
- 10. The competent authority on behalf of President of India reserves the right to accept or reject, any Bid, and to cancel the Bidding process and reject all bids, at time prior to the award of contract, thereby without incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds.
