

अधिसूचना NOTIFICATION

As mandated by the UGC and Ministry of Education, Govt. of India and Public Notice issued by National Testing Agency (NTA) Dated 26.12.2023, an administrative approval is hereby accorded to participate Common University Entrance Test (CUET) for both UG and PG programmes of the University and its affiliated Colleges to consider eligibility for admission to various courses from the Academic Session, 2024-25. However, admission through CUET shall not exceed more than 20% of total seat in each department/course. University will conduct RGUCET for both UG & PG programmes for 80% of total seat for Department/Course. Student may opt either CUET or RGUCET or both. Rationalization of scores in CUET and RGUCET shall be done to prepare a merit list for admission in different courses by the Department/College concern. University will also conduct RGUPET for all doctoral programmes offered by the departments.

As you know, the Common University Entrance Test (CUET) provides a common platform and equal opportunities to candidates across the Country for admission into UG/PG programmes of Central and participating universities. The National Testing Agency (NTA) has been mandated by the Ministry of Education and UGC to conduct CUET – UG/PG.

I would like to draw your attention to the Public Notice dated 27th February 2024 issued by NTA regarding timelines for the conduct of CUET (UG) -2024, along with other relevant details. For the academic session 2024-25, CUET (UG) 2024 will be conducted in the Hybrid mode between 15th May and 31st May, 2024 in 13 languages, with the result declaration date as 30th June, 2024; the date(s) may vary depending on the National Election Schedule. The public notice may be accessed at www.nta.ac.in and <https://exams.nta.ac.in/CUET-UG/>

The list of participating universities is displayed on NTA's website. NTA has already written to the universities that participated in last year's CUET (UG) to enable their participation in this year's CUET. ***If you still need to register with NTA to enable admissions to UG programmes in your university, in the year 2024, you may do so now. The list of participating universities, as displayed on NTA's website, is dynamic and will be updated to include your university name after you register with NTA. For registration, universities are required to send programme details with eligibility to cuetu@nta.ac.in.***
