C I R C U L A R

Consequent upon the resolutions adopted in the meeting of the NEP-2020 Task Force held on 12.03.2024, all the Deans of various faculties, Heads/Directors of the Department/Institutes and NEP-2020 Coordinators of the Rajiv Gandhi University shall initiate for timely compliance and adherence of the following tasks:


1. Submission of updated Draft Syllabi (both UG and PG as per NEP-2020) to NEP Task Force by respective Deans of Faculties : **15th April, 2024**
2. Scrutiny of Course Structure and Mapping as per POs and COs followed by communication to NEP Coordinators of the Department concerned for desired corrections : **16th to 25th April, 2024**
3. BoS meetings of all the Departments to finalize their respective Syllabi of UG and PG programmes under NEP-2020: **26th April, 2024 to 2nd May, 2024**
4. BoS should prepare the syllabi of respective courses/programmes at par with national level, drawing analogy from NEP-2020 and other reputed Universities/Institutions. Respective Deans of Faculties will be responsible for certifying the parity of every syllabi under their faculty essentially including contents (Context specific) which are cardinal to the courses/programmes of respective standards (UG or PG).
5. As per UGC public notice, F.No. 60-1(QIP/Misc.)/2024, dated 1 March, 2024, all the students who have already enrolled and pursuing UG programmes as per the Choice Based Credit System (CBCS) are eligible to pursue 4-year undergraduate programme. All the Board of Studies are required to develop Bridge courses (including online/MOOC courses) to enable those students for transition to the 4-year program. Respective Deans of Faculties to submit the Draft Syllabi to NEP task force by **15th April, 2024**.
6. In accordance with UGC directives, all Boards of Studies are required to identify and incorporate few topics related to the Viksit Bharat theme to increase student engagement in the campaign.
