FC: 25:03: To approve the Revised Annual Accounts for the Financial Year 2021-2022.

> The FC noted that the Annual Accounts of the Rajiv Gandhi University for the financial year 2021-2022 were audited by an audit team from the office of PAG Itanagar from 22nd November, 2022 to 30th November, 2022. The audit team has pointed out some errors in the accounts. Accordingly, the University has furnished the comments on the Draft SAR along with revised annual accounts 2021-2022 to the PAG Itanagar 26th December, 2022 with the approval of the competent authority of the University. However, the PAG has suggested to place the revised annual accounts for the year 2021-2022 to the statutory bodies of the University for issuing of the final SAR.

The revised Annual Accounts was placed to the FC for perusal and consideration.

The FO informed the members that the audit team from PAG, Itanagar has located some errors in the Annual Accounts during their auditing period (22-11-22 to 30-11-22) and raised observations, and suggested to furnish revised Annual Accounts. Accordingly, the revised annual accounts was submitted to PAG, Itanagar on 26.12.2022 along with comments on draft SAR 2021-22 duly approved by Competent Authority. However, before obtaining final SAR, PAG suggested to get the revised annual accounts approved in Statutory Body.

The FC perused the Revised Annual Accounts of RGU for the financial year 2021-22 and approved the same.

The FC noted that the Government of Arunachal Pradesh vide its Gazette Notification No. 14, Vol. XXXII dated 30th July, 2021 has accorded approval for ex-post-facto implementation of GPF-cum-Pension Gratuity (Pension) Scheme for the employees of Rajiv Gandhi University, (the then Arunachal University), Arunachal Pradesh from 23-02-

After receiving the ex-post-facto administrative approval and release of pension liabilities, the University has requested the UGC/MoE vide letter No Estt-177/PS/2000 (Vol-II) Dated 03/01/2022 to initiate the process to adopt the CCS (Pension) Rules, 1972 for the employees who were in service before conversion as a Central University and in whose case the pension liabilities were cleared by the State Government as per the provisions of Central University Act. The queries raised by MoE in this matter have also been addressed. However, the necessary approval from the MoE is still awaited and a few numbers of employees who retired from University service are waiting for their due pension.

Finance Committee may like peruse the matter and suggest for future course in this matter.

FC noted the same. The Director, MoE informed that the Ministry of Finance, Department of Expenditure have returned the file to MoE with some observations, and if needed, replies/comments may also be obtained from the University in this regard.
