At the outset, Prof. Saket Kushwaha, Vice Chancellor and the Chairman (Ex-Officio) of the Academic Council, greeted all the learned members of the Academic Council and also the Special Invitees and exhorted all to participate keenly in the deliberations. In his opening remark, the Registrar Dr. N.T. Rikam informed the house about the urgency of the matters that were being tabled in the meeting and on the necessity to call the meeting of the Academic Council of RGU to resolve some important pressing issues. Thereafter, the Chairman invited the Joint Registrar (Academic & Conference) Dr. David Pertin to initiate the proceedings of the meeting.

The following Agenda items were then placed before the Academic Council for perusal, discussion and decision/recommendation, thereon:

To discuss on the matter pertaining to Admissions to all the Ph.D. programmes in RGU.

The Academic Council of the University noted that, while taking cognizance of some technical issues the Competent Authority of the University had postponed the admission process of Ph.D. programmes to 23rd August, 2023 vide a notification bearing No.AC-56/OAS/2015 (Vol-I), Dated the 1st Aug., 2023, keeping 8-11 August, 2023 as the days for the notification of the list of shortlisted candidates through RGUPET-2023 for Viva-Voce.

The AC further noted that, a 12 member Central Admission committee under the chairmanship of Prof. T. Lhungdim, Dean, Faculty of Education, Physical Education & Sports Sciences, was formed vide notification no. AC-56/OAS-RGUCET/RGUPET/2022(Vol-III), dated 24th July, 2023 in connection with the preparation of guidelines/SOP for all aspects (including release/notification of name/registration number/category for RGUCET/RGUPET candidates) based on existing govt./UGC guide lines and norms/practices in the University, category wise seats in the Departments/Institutes for UG/PG/Ph.D. admission and to ensure smooth and fair admission process. The said committee has submitted its reports relating to admission of Ph.D. programme. The report of the committee was placed as **Annexure-1**.

Besides, the University administration had also written to all the central Universities in the North East and also JNU & University of Delhi to share their admission systems being practiced for admissions to Ph.D. vide letter no. RGU/REG-45/AC/21, dated 2nd Aug., 2023.

Accordingly, the analogies of Admission system from other central universities such as Manipur University, Imphal, Central Sanskrit University, New Delhi, HNB Garhwal University, etc. have been obtained and were placed as **Annexure-2**.

After a threadbare deliberation, the members felt that there should be uniform reservation system for admission to UG, PG and Ph.D. programmes of the University and recommended that, the existing reservation system for UG & PG admissions shall be implemented for admission to Ph.D. programme also i.e. 60% of seats of the Ph.D. Programme will be reserved for ST candidates, 9% for OBC (Non-creamy layer), 3% for SC, 3% for wards of Ex-Servicemen and 5% for differently-abled candidates. Rest 20% of the seats will be kept as Open seats. However, if there are no OBC, SC, wards of Ex-Servicemen and differently-abled applicants, etc. the seats will go to the ST category in the ensuing session. Likewise, if ST candidates are not available then seats will be treated as "Open". However, there will be no additional weightage over and above their percentage of marks shall not be given.

The AC approved the same for its implementation with immediate effect.

Further, the Academic Council also resolved to constitute a broad based committee to look into the reservation matter thoroughly for drawing a standard reservation system at RGU as per the Central Educational Institutions (Reservation in Admission) Amendment Act, 2012 and other relevant documents pertaining to it.

AC:44:02	To approve the implementation of moderated syllabi of Environmental Sciences (EVS). The University vide a notification bearing no. AC-2424/NCr.F/2023, dated 13 th July, 2023, had constituted a 5 member committee under the chairmanship of Prof. Hui Tag, Dept. of Botany to moderate the syllabi of Environmental Sciences (EVS) as endorsed by UGC to be implemented in RGU and its affiliated colleges, had furnished their reports and submitted the moderated syllabi. The AC accepted the proposal in principle. Only Paper-I will be notified for now.
AC:44:03	To approve the start of Bharatnatyam Course under Music programme. The AC noted that a proposal has been received from Head i/c, Dept. of Fine Arts & Music to start Bharatnatyam Course under Music programme from the session 2024-25 in either Certificate or Diploma or a full fledge UG programme. The AC approved the same to start the programme from the next academic session and suggested the HoD i/c to prepare the detailed syllabus through the BOS concerned.
AC:44:04	To approve the revised syllabi of BA Anthropology and One Year PG Diploma in Forensic Sciences. The following revised syllabuses which were drafted and framed by the Board of Studies (BOS) in Anthropology got tabled before the AC for its approval and consideration of implementations; (1) BA Anthropology 1 st and 2 nd Semester (2) One Year PG Diploma in Forensic Sciences As the modification/changes made were based on the suggestions of the External Experts of BOS and are within the prescribed limit, the AC approved the same.
AC:44:05	To approve the revised syllabi of Paper BEDSE-1051 under BEd. (Spl. Edu.) programme based on RCI guidelines. The following revised syllabus drafted and framed by the Board of Studies (BOS) in Education based on RCI guidelines and which got tabled before the AC for its approval and consideration of implementation; (1) Paper BEDSE-1051 under BEd. (Spl. Edu.) programme The AC approved the same for implementation. The AC further noted that any communication regarding academic matters from colleges must accompany Minute of the meeting(s) of the Academic Bodies of the colleges concerned and all such proposals and applications are required to be routed through the office of the Director CDC.

AC:44:06	To approve the revised syllabi of BA Mass Communication & Course Structure based on NEP-2020 guidelines. The following revised syllabus and course structure drafted and framed by the Board of Studies (BOS) in Mass Communication based on NEP-2020 guidelines which got tabled before the AC for its approval and consideration of implementation; (1) Syllabi & Course Structure of BA Mass Communication The AC noted that, nomenclature of few of the courses has been modified as per the suggestions of the BOS members and thus, the AC approved the same for implementation.
AC:44:07	To update on the undergraduate programmes under Institute of Undergraduate Studies (IUS), RGU. The AC noted that, the University under the Institute of Undergraduate Studies (IUS) has started offering 8 new programmes viz; 4YUP in Basic Sciences and Social Sciences from the current academic session. The admission processes are on full swing. A 5 member committee with Dr. Rajesh Chakrabarty as Director of IUP also has been constituted. The Director Dr. Rajesh Chakrabarty informed the house that RGU has started the Four Year Undergraduate Programme in Anthropology, Sociology, Psychology, Social Work, Chemistry, Physics, Mathematics and Statistics with intake capacity of 10 students each. The Academic Council noted the same and appreciated the move by the University in this direction.
AC:44:08	To update and ratify the action initiated to invite candidates to seek admissions to various post-graduate programmes through CUET-PG-2023 scores for some residual vacant seats. The AC noted that, the University Authority had notified the opening of CUET-PG registration portal for candidates seeking admissions against some residual vacant seats in various post-graduate programmes being offered by RGU during the ensuing Academic Session 2023-24, through scores obtained in NTA conducted CUET-PG-2023. The Joint Registrar (Academic & Conference) Dr. David Pertin informed the Council that there are 129 residual vacancies in 12 PG programmes. As such, the university had started inviting candidates for admission to these programmes through the CUET-PG scores. The Academic Council noted and ratified the same.

To conduct the RGUCET-2023 Phase-III for completing admissions to various residual seats in the ensuing session. The AC noted that, the University Authority has decided to conduct the RGUCET-2023 Phase-III for completing admissions to various residual seats in the ensuing session. The Coordinator of RGUCET-2023 Central Coordination Committee Prof. SK Patnaik informed the Council that the same is proposed to be conducted on 2nd September, 2023 AC:44:09 (Saturday) in three sessions at RGU campus centre only. The required notification could be done only after the completion of admission process of the RGUCET-2023 I & II phase on 14.8.2023. The Academic Council approved the same. Any other item(s) with the permission of the Chair. (1) The Academic Council perused and approved the revised syllabus of FYUP-B.Sc. (Geology), which was passed by the BOS (Geology) in a board meeting conducted on 07/08/2023. (2) The Principal, JNC, Pasighat Dr. Tasi Taloh presented before the council some pressing issues pertaining to the colleges covering (a) Clustering of examination zone matter, (b) On retaining of percentage of practical fee (c) on Evaluation of answer scripts and (d) on Remuneration of examination related works. AC:44:10 The Academic Council noted the same and suggested that, these matters may be brought up through proper channel. (3) The Registrar Dr. N.T. Rikam informed the Council about the maiden visit of the Honourable Governor of Arunachal Pradesh and Chief Rector of RGU Lt Gen Kaiwalya Trivikram Parnaik, PVSM, UYSM, YSM (Retd.) to RGU campus on 11th August, 2023 for an interaction programme with faculty members and officers. The Council noted the same.
