The Quotations will be opened on the same day after closing date of submission at 02.30 pm at the Chamber of the Chairman, Purchase Committee (General), Rajiv Gandhi University, Doimukh, Arunachal Pradesh. The tenders received after the scheduled date and time will be rejected out-rightly.

Terms and Conditions:

1.	The Rate Contracts concluded as a result of this Tender inquiry shall be governed by the 'Terms & Conditions' and other relevant instructions as contained in this Tender Document.
2.	Tenders received without Tender Fee, Bid Security (EMD) by way of Demand Draft or Pay Order/Banker's Cheque / FDR in the name of Registrar, Rajiv Gandhi University, Doimukh/ Itanagar will not be considered at all.
3.	Tenderers are requested to enclose a self attested copy of their valid GST Certificate, PAN Card, Valid Trading License etc.
4.	The competent authority reserves the right to accept or reject any or all tenders without assigning any reason.
5.	Tenderers may note that if the date of tender opening given in this Tender Document is declared to be a holiday, the tender shall be opened on the next working day at the same timing.
6.	Late/delayed tenders received due to any reason whatsoever will not be accepted under any circumstances.
7.	Acceptance of the rate will be communicated by Speed post /E-mail/University Website or any other form of communication.
8.	Each and every page of the tender documents must be signed by the bidder.
9.	The parties to the contract are the contractor (the tenderer to whom the work has been awarded) and the RGU, Arunachal Pradesh for and on behalf of the Registrar, RGU, Rono Hills, Doimukh.



10. The EMD, in case of successful bidders shall be retained as performance security and in case of unsuccessful Bidders the EMD shall be returned within 30 days from the date of opening of the bid or till the finalization of the tender, whichever is later. The EMD shall be refunded to the unsuccessful tenderers on written request. No interest will be payable by the Rajiv Gandhi University authorities on the EMD.




Dimension of University Mementoes
