**EC:58:03:**

The Executive Council extensively discussed the matter and accepted the report of the Inquiry Committee. Based on the report of the Inquiry Committee, the university will seek the legal opinion regarding the imposition of 'major penalties' as per relevant rules of CCS (CCA). Further, the EC extended the suspension order in respect of Dr. Philip Modi, Associate Professor, for three months from the date of the meeting of this 58<sup>th</sup> Executive Council (14.06.2024). An order will be issued accordingly.

This is issued with the approval of the Vice-Chancellor, being the Chairman (Ex-Officio) of the 58<sup>th</sup> EC.


