No candidates shall be allowed for consideration after 11 am. After verification of the documents, the two seats shall be given to the first two candidates from amongst the reporting candidates **AS PER MERIT LIST**.

The following are the documents required for verification and submission of photocopies (for the selected candidates):

1. Education Qualification: mark sheets and certificates of class X, XII and Graduation.
2. College Leaving Certificate.
3. ST Certificate
4. Co-curricular activities carrying weightage: NCC, NSS.
5. Three numbers of passport size photographs

Note:

1. Candidates not fulfilling the minimum eligibility criteria as specified in the RGU Admission Bulletin/ admission norms, that is, graduates under 10+2+3 pattern of education from Rajiv Gandhi University or any other UGC recognized University with 45% marks in History will **NOT** be given admission even if their names appear in the provisional merit list.
2. For sake of clarity and to avoid hardship, candidates who have **NOT** studied History as either a Major/Honours or Elective/Pass Subject in Graduation are advised **NOT** to come for verification of their documents.

3. Selected applicants are to pay the admission fee of Rs 7,150/ (Seven thousand one hundred fifty rupees) by signing in to the university admission portal by 31st August 2024. The payment receipt must be submitted to Department of History soon after the payment is made.
