ORDER

In pursuance to the UGC vide letter D.O. No. F. 1-13/2022 (CPP-II), dated 12th April 2023, and consequent upon the decision taken in the 51st meeting of the Executive Council held on 22.5.2023 vide resolution No. EC:51:07, Prof. K.S.R. Rao, former Vice Chancellor, Mizoram University, Alzwal is hereby appointed as the 'Ombudsman' of Rajiv Gandhi University, Doimukh, Arunachal Pradesh with immediate effect, till further order.

He shall be entitled TA/DA, etc. as per rules while attending the official meeting. The terms of references/functions/roles of the Ombudsman shall be as per the Gazette Notification No. 12, Part-III, Section 4, March 29, 2013 and No. 233, Part-III, Section 4, dated April 11, 2023.

As per the 51st EC resolution, if any aggrieved party (students) in such a situation that, they are not satisfied with the decisions of the various Students Grievance Committees constituted by the university vide Notifications of even number dated 18.5.2023, on certain matters or issues, could then appeal to the Ombudsman of the university.

This supersedes the earlier Order of even number dated 26th May, 2023. This is issued with the approval of the Vice Chancellor.
