**ORDER**

**Whereas**, a Show Cause notice vide order of even No. Dated 19<sup>th</sup> December, 2023, was served to Siang Royal Academy, Pasighat, East Siang District, Arunachal Pradesh for violating the University ordinance and the guidelines of NCTE/AICTE by misusing the college infrastructure for school class room.

**Whereas**, the Siang Royal Academy, Pasighat in its response to Show Cause notice vide letter No.SRA/PSG/B.Ed/B.A/Estt/23/837 Dated 6<sup>th</sup> January, 2024, accepted the violation of the guidelines and sought an apology.

**Whereas**, the matter was deliberated in the 49<sup>th</sup> Academic Council meeting held on 26<sup>th</sup> September, 2024 under item No. AC:49:04 for initiating disciplinary action against the said college for violating of AICTE/NCTE guideline and ordinance of University.

**Therefore**, the affiliation in respect of Siang Royal Academy is hereby suspended and a token of penalty Rs. 1.00 (Rupees One) is imposed on the college. The College shall not admit new students in the next academic session 2025-2026. The suspension may be reviewed on satisfactory report of an inspection committee.
